The following member of the public addressed the Committee:

Dan Marioko expressed concern with public safety related to fire hazards with a homeless person in a tent near Carolina

Discussion ensued between staff and Committee Members regarding staff awareness of the situation; the Fire Marshal; ensuring that the encampment does not infringe on the bike path and walkways; efforts to get the people in the area housed; and appreciation to the public for sharing concerns.

Item A-1

Update Regarding Discussion with Los Angeles Homeless Services Authority (LAHSA) for the Culver City 2022 Greater Los Angeles Homeless Count Data

Chair Daniel Behrendt provided background on the item;

discussed information reviewed at the last meeting; questions regarding consistency of the numbers; a phone call with LAHSA (Los Angeles Housing Services Authority); the science behind the numbers; support from USC (University of Southern California) in estimating the numbers; the difficulty in drawing conclusions; flawed collection procedures; and fluctuating methodologies used for calculation.

Tevis Barnes, Housing Programs Manager, discussed previous collaboration between Culver City and USC; clarification regarding maps used; LAHSA confusion with borders; statistical information regarding surrounding areas; raw data; adjustment factors; changing methodologies; and patterns.

Discussion ensued between staff and Committee Members regarding lack of clarity on issues raised; variations from SPA (Service Provider Area) to SPA and from year to year; benefits to having larger or smaller numbers; funding; performance; the traditional date and time for conducting the count; and the LASHA number vs. the number from Culver City Police and Fire.

Discussion ensued between staff and Committee Members regarding the number of absent Committee Members; relevance to the discussion; and agreement to discuss Item A-2 after Item A-3.

Item A-3

Quarterly Report from Culver City Fire Department and Police Department

Andrew Bellante, Culver City Police Lieutenant, provided a

presentation and introduced members of the MET Team; distributed handouts; discussed ongoing challenges; maximizing outreach capabilities; partnerships; refuse collection; distribution of supplies to the unhoused; (Americans with Disabilities remediation of ADA Act) violations; he provided information on specific cases and actions taken to assist various unhoused individuals in Culver City; discussed jurisdictional boundaries; areas with the highest call volume for unhoused individuals; types of calls; types of crime; the growing trend of encampment fires; violent crime involving unhoused individuals; property crime; assault; he summarized noteworthy crime reports; discussed high visibility patrols; outreach from the MET Team; identification of new unhoused individuals and development of rapport; the Partnerships in Policing Team; education on Police Department response and the law as it relates to the unhoused; collaboration with the Mobile Crisis Response Team; and continued work on Project Homekey.

Discussion ensued between staff and Committee Members regarding appreciation for the presentation; conviction rate for those arrested; percentage of assaults that are homeless against homeless; Culver City being viewed as a safe haven for homeless individuals; interaction between Officer James Thomas and homeless individuals; the responsibility to keep the unhoused population safe; holding people accountable for violent crime; issues at Overland and the Creek; frequent calls for service; overdose calls; Fentanyl usage; demographics; causes of fires; non-criminal calls for service; the time-consuming nature of mental health calls; crimes captured on video; predators; reporting procedures; the Regional Communications Center (RCC); 911 emergency calls; non-emergency calls; dispatch; public comment making reference to the Culver City Police Department (CCPD) not being able to take action; response time; investigation; the job of the Police to enforce the law; trespassing calls; petty theft; the Private Person's Arrest Process; willingness of victims to prosecute; changes to what is enforced; guaranteed CCPD response and assessment; what is considered a minor crime; notification of parents about crimes involving juveniles; percentage of the population that generates the calls; people that come in from the city of Los Angeles that generate calls; repeat offenders; other ways to make the job of CCPD easier; education; laws associated with homelessness; the prohibition on taking possessions and kicking people out; opening a direct line of communication with the public;

providing extra patrols for hot spots; tailoring response to individuals; increases to violent crime; and changes to reporting procedures.

Chair Daniel Behrendt invited public comment.

The following member of the public addressed the Committee:

Gary Silbiger discussed persecuted groups; people with issues; the importance of presuming someone innocent until proven guilty; people who are found eventually to be innocent; he quoted a song by Phil Ochs: "There But for Fortune Go You or I"; lack of support; the work of the Committee to assist people in recuperating from their problems; the origin of the Homelessness Committee; and the role of St. Josephs Center (SJC).

Discussion ensued between staff and Committee Members regarding the role of SJC to visit the camps and establish relationships; criminal activity handled by CCPD; and response teams for non-criminal activity.

Paul Vorhees, Fire Department Captain, Emergency Medical Services Coordinator, indicated that he was impressed by the presentation from CCPD; discussed the proactive response to the unhoused situation; the reactive role of the Culver City Fire Department (CCFD); mitigating hazards; helping people in need; use of the National Fire Incident Reporting System (NFIRS); statistics to date; total calls for service involving homeless individuals; EMS (Emergency Medical System) related calls; use of Narcan; alcohol related calls; miscellaneous calls; CCPD response; people sleeping on the sidewalk; water flow alarms; and hot spots.

Discussion ensued between staff and Committee Members regarding appreciation for the presentation and for the presence of Captain Voorhees at Committee meetings; CCFD team response; maintaining strict policy guidelines; and the effect of new bus lanes downtown on response time.

Tevis Barnes, Housing Programs Manager, indicated that SJC would be providing a presentation at the next meeting, and SJC representatives introduced themselves.

Discussion on ACOHH By-laws and Committee Member Meeting Attendance

Chair Daniel Behrendt discussed attendance issues; instances when there has been a lack of a quorum; concern with hampering the ability of the Committee to execute on their mission; taking a spot from someone who may want to participate; the section in the by-laws regarding absences; forfeiture of membership; and a Member who is no longer able to serve.

Tevis Barnes, Housing Programs Manager, provided historical context on the issue; noted that definitive language had been derived from Landlord Tenant Mediation Board by-laws; she discussed a Member with educational obligations; and excused absences vs. no shows.

Discussion ensued between staff and Committee Members regarding the importance of communication; staff communication with Committee Members regarding meeting dates; codification of meeting time in the by-laws; the regular schedule and meeting place to allow certainty for the public; providing early awareness of changes to meeting time and/or location; a recommendation that Committee Members who miss a meeting be responsible for finding out when the next meeting is; the importance of Committee Members making use of their City email; and a reminder that email is part of the public record.
