Commissioner Leonard discussed communication from community members and staff; creation of a survey distributed throughout the City and online; public outreach; signage; and next steps.

Vice Chair Zeidman thanked staff for their work and he was looking forward to receiving feedback from the community.

Chair Rickards invited public comment.

The following members of the public addressed the Committee:

John Coray asserted that parks make life better by being inclusive; indicated that he is part of the paddle tennis community; discussed accommodating both paddle tennis and pickleball and alterations to make the courts work for both sports; use of the courts on a first come, first served basis; he stated that if he wanted to make a reservation, he would join a club; and, responding to inquiry, he indicated that he had taken the survey.

Howie Jacobowitz indicated being a long-time paddle tennis player; advocated for the most efficient use of existing courts; discussed courts on the Middle School campus; purview of the Board of Education; signage; court sharing; the potential to serve more people by putting four pickleball courts on one tennis court; the upcoming election; and, responding to inquiry, he indicated that he had taken the survey.

Vice Chair Zeidman reported that neighboring cities were working with their school districts to make use of courts for pickleball.

Romy Hightower provided background on herself; indicated that she was an advocate for pickleball and paddle ball; she expressed support for making use of the tennis courts; she reported taking and sharing the survey; expressed appreciation for the actions of Manhattan Beach to open up the school courts for use to play pickleball; discussed the reservation system; antiquated signage that has caused issues; problems caused by misinformation; and she expressed appreciation to Commissioner Leonard for her support.

Discussion ensued between staff and Commissioners regarding efforts to include the tennis community and the surrounding neighborhoods in the conversation; ways for the community to access the survey; a planned community mailing; confusion caused by signage; a suggestion to block off the "paddle tennis only" portion of the signage; creating a transparent process; allowing for input; appreciation to the public for their comments; and ensuring that the community does not feel that staff is favoring one point of view over another.

Commissioner Mohammed reported that he had not heard anything from the City Attorney about the Parks and Facilities Sections of the Culver City Municipal Code Review Ad Hoc Subcommittee.

Discussion ensued between staff and Commissioners regarding the City Council request that the Commission consider forming a Community Gardens Subcommittee and a subcommittee to consider adding hours for dogs to be off leash in Culver City parks. Commissioner Leonard discussed attending monthly meetings of the Culver City Senior Center Board of Directors.

Responding to inquiry, Armando Abrego, Parks, Recreation and Community Services Director, indicated that he would send an email to the City Attorney's Office in an attempt to get information to report back to the Parks and Facilities Sections of the Culver City Municipal Code Review Ad Hoc Subcommittee.

Meg Sullivan expressed concern with the original site for the relocated garden; discussed loss of space for those who rely on Syd Kronenthal Park; she indicated having a community garden plot elsewhere; she was pleased that alternative sites would

be considered; she wondered how the subcommittee would work with the public; she felt that the list of sites should be provided to the public who should be allowed to make suggestions; noted that the City had created a problem by indicating that the sites would be within a City park; she suggested use of potential sites at West Los Angeles Community College; she offered to take anyone to the community garden that she volunteers in; and she thanked the City for their work.

Discussion ensued between staff and Commissioners regarding skepticism with the original offer by the Wende Museum; support for creation of a subcommittee; alternative locations; creative use of space for gardening; thinking outside of the parks; providing opportunities for community engagement; those willing to serve on the subcommittee; appreciation for the public comment; the opportunity to investigate different models of community gardens; exciting and opportunities for the City; people who want to grow their own vegetables but don't have their own space; engaging in an interactive process; getting out of the "mine" and "yours" model; looking at alternatives; availability to serve; different approaches to gardening in South Central Los Angeles; policies and concerns; security; consequences of assigning use factors; appreciation to the Commission for their work on the item; and opportunities for all community members to be engaged.

Discussion ensued between staff and Commissioners regarding City Council direction to investigate the matter; the existing Dog Park; ramifications of not choosing to form an ad hoc subcommittee to consider the matter; opportunities to clarify opinions on the matter; previous consideration of the matter; the inability of the Commission to make a recommendation against allowing dogs to be off-leash during the current meeting; clarification about not wanting to form an ad hoc subcommittee; Council direction given as a result of public comment; liability and safety; data; concern with shutting down residents who want to engage with local government; consideration of Section 9.10.55 in the Ad Hoc Subcommittee to Revise the Municipal Code; a suggestion to add the proposed item to the existing subcommittee; research needed before making a recommendation to change the Municipal Code; outreach; the prohibition of dogs in parks whether on or off leash; providing for a transparent process; sections that impact other departments; and a request for a meeting with the City Attorney to discuss code changes and liability.
