14	approve the settlement of claims against the City and litigation in the amount of
15	\$25,000, and
16	WHEREAS, in settlement negotiations, it is often important that parties be
17	able to reach settlements without delay, and
18	WHEREAS, in mandatory settlement conferences conducted by judges,
19	there is a need to provide greater latitude for settlement of litigation, and
20	WHEREAS the avoidance of litigation through negotiated settlements can
21	and does result in cost savings to the City in appropriate cases and
	WHEREAS, the City Council has determined that the settlement authority
22	for the City Attorney should be increased to \$10,000, in order to assist the expeditious
23	settlement of claims or litigation against the City
