CAC - 1) Update from Culver City Artist Laureate Alexey Steele on Projects and Activities for 2022; and, 2) Provide Comments as Appropriate

Chair Fleischer introduced the item.

Christine Byers, Cultural Affairs Manager, pointed out a clerical error on page 3 of the written report, noting that in number 17, the word "during" should instead read "in preparation for".

Alexey Steele provided a presentation on the final year of his tenure as Artist Laureate for Culver City; discussed previous perception of the program; defining and building the program; response to the pandemic; proving that art is an essential service; the war in Ukraine; inter-disciplinary collaborations; art in global crisis response; the importance of having an artist delivering their own art; being in the position to advocate for all arts; artist recognition at the Bowers Museum; the Arts for All Program; the Love My Neighbor series; Art Walk & Roll Festival; concern with the loss of art in the city due to gentrification; the role of the City in rectifying losses to the artistic side of the community; the connection between artistic visionaries and the Creative Economy; General Plan; the importance of the the ambassadorial function of the position; outreach; United Against Hate; the pop-up art installation at Village Well; collaboration with the Culver City Unified School District (CCUSD); the Culver Arts Spotlight Award; emergency work; advocacy; recommendations for the General Plan recognizing the need for a City gallery; important collaborations; key takeaways; the work of his father; hope for establishing positive relationships with other countries; the future; he presented a turtle gifted to him from the former Honorary Artist Laureate, Dr. Janet Hoult, to be passed along to future Artists Laureate; and he indicated willingness to support the new Artist Laureate and continue to work with the City.

Discussion ensued between staff and Commissioners regarding significance of the turtle as the mascot; appreciation to Mr. Steele for his creativity and enthusiasm; congratulations to the Artist Laureate Subcommittee on selecting an outstanding Artist Laureate; appreciation for the presentation; and the importance of the arts.

Additional discussion ensued between Alexey Steele, staff, and Commissioners regarding creating a municipal art gallery; collaboration with the Culver City Arts Foundation; providing a version of the presentation on the City website; location of the artwork created for the program; art at City Hall; and appreciation for the meaningful support from the City.

Christine Byers, Cultural Affairs Manager, introduced the item.

Discussion ensued between staff and Commissioners regarding adding the word "networking" before the word "events" under the bullet for the Creative Economy; adding the words "and retreat" at the end of the bullet for Culver City Arts Foundation; request from Council Member O'Brien regarding the creation of a mural for Project Homekey; the work plan; origin of the Artist Laureate position; the modest honorarium paid to the Artist Laureate; Commission purview; expanding the purpose of the Commission; media and film; changes to the municipal code in 2019 affecting the role of the Commission; language currently in the municipal code regarding powers and duties of the Commission; a request to add language to the biannual report to allow for unexpected or new opportunities generally to cultural issues; that relate providing flexibility in trying to match what the Commission does now and in the future; reviewing powers and duties in the work plan including being cultural ambassadors; agenda items for upcoming meetings; providing flexibility with wording; allowing the Commission to be responsive to new or ad hoc opportunities that arise in different areas relating to the purview of the body; benefits to itemizing and putting things in writing; appropriate support for neglected arenas; lack of cinemas in the city; incorporating film into other events; public art; the Artist Laureate Program; film festivals; providing cultural opportunities; brainstorming; cultural venues in the city; items currently being juggled by staff; history and context; providing time and space to consider items; the Economic Vitality Task Force; the Art in Empty Storefronts/Business Program; collaboration between Economic Development and Cultural Affairs; Performing Arts Grant Program grantee performances; ongoing need; the Public Art Subcommittee; ensuring a nimble process; the work plan schedule; budgeting for the creation of a new Community Cultural Plan; the adopted department work plans; the Historic Preservation Program update; using the General Plan
