**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
CULVER CITY, CALIFORNIA, AUTHORIZING THE FILING OF AN  
APPLICATION FOR THE FEDERAL ASSISTANCE COMMUNITY  
DEVELOPMENT BLOCK GRANT PROGRAM AS PART OF THE  
LOS ANGELES URBAN COUNTY – INCLUDING PROGRAM  
CERTIFICATIONS (2023-2024)**

WHEREAS, the City of Culver City, a municipal corporation within the State of California, operating under a Charter filed in the office of the Secretary of State on June 30, 2006, possesses legal authority to apply for Federal Assistance under the Community Development Block Grant Program; and

WHEREAS, the City has entered into a Cooperation Agreement with the County of Los Angeles to join the Urban County for the purposes of applying for Community Development Block Grant funds.

NOW THEREFORE, the City Council of the City of Culver City, California DOES HEREBY RESOLVE, as follows:

1. In compliance with State CEQA Guidelines, Section 15300, et seq., it is determined that the project activities for the 2023-2024 program year are categorically exempt activities.

2. The objectives for the conduct of the 2023-2024 Community Development Program are as follows:

a. To stabilize and preserve existing residential neighborhoods, prevent and eliminate blight by improving supporting public facilities and constructing streetscape improvements, and comply with the federal Americans with Disabilities Act (ADA).

1                   b.       To provide funding for projects serving the elderly and the  
2 disabled, which includes the City position of Disability Services Specialist or staff  
3 members performing such duties.

4                   3.       The projects and dollar amounts in order of priority for 2023-  
5 2024, attached hereto as Exhibit "A" and incorporated herein by reference, are  
6 hereby approved and adopted and shall serve as the basis for filing the application  
7 for Federal Assistance.

9                   4.       The filing of an application for Federal Assistance under the  
10 Community Development Block Grant program for 2023-2024 as part of the Los  
11 Angeles Urban County, including Program Certifications, is hereby authorized.

12                  5.       The City Manager of the City of Culver City or his/her designee  
13 is hereby designated and directed, as the authorized representative of the City of  
14 Culver City, to act in connection with the application, to execute documents relating  
15 to the application, and to provide such additional information as may be required.
