On February 16, 2023, the Bicycle & Pedestrian Advisory Committee (BPAC) approved the transmittal of the following information to the City Council:

### **July – December 2022 Accomplishments**

#### Communications to City Council

- Recommended that City Council recognize Art Nomura for Project Visibility, a grant funded project to provide free safety equipment to low-income residents and workers
- Requested that staff communicate BPAC's wish to host hybrid meetings

#### Review, Discussion & Advisory Feedback

- Received update and discussed status of Move Culver City Project, including mid-project key performance indicators, and alerted Transportation staff to issues
- Received update and discussed status of recent temporary closures of Ballona Creek Bike Path
- Received presentation from staff and discussed signalized and unsignalized intersection safety improvement projects
- Received presentation from staff regarding bicycle and pedestrian detection at traffic signals, discussed challenges and signal effectiveness
- Received update and discussed status of opening of Jackson Ave gate to Ballona Creek Bike Path; requested gate open before start of school year 2022-23

- Received update and discussed status of Fox Hills Neighborhood Traffic Management Plan, including takeaways from community meeting with residents
- Received presentation from Police Department regarding bike lane violation enforcement policy, Jackson Ave gate incidents, and Police Department's bike and pedestrian safety priorities; requested increased enforcement of vehicle violations in bicycle lanes
- Received updates from staff and discussed other active mobility projects being managed by Public Works Department, including Higuera Bridge Replacement Project and projects listed on City website ([Active Project List – Mobility & Traffic Engineering Division](#))
- Recommended prioritizing improvements to Jefferson Blvd bike lanes and reducing parking in response to closures of Ballona Creek Bike Path resulting from Higuera Bridge project and upcoming Bike Path improvements
- Requested reengagement of BPAC and Public Works staff with West LA College regarding shared mobility concerns and projects
- Requested new mobility improvements, including:
  - Elimination of one or more parking spaces near Duquesne Ave to improve bike visibility, as well as other safety measures for entrance/exit of Ballona Creek Bike Path at Duquesne Ave
  - Addition of bike parking downtown and in multiple locations across City
- Requested data be collected on use of Main St when closed and open
- Reported on and discussed pedestrian and bike safety issues throughout City, including pedestrian fatality in the Fox Hills area and safety issues along Ballona Creek Bike Path
- Requested report from Metro Bike Share regarding progress on implementation of bike share program under recent review
- Received community input through public comment on many non-agendized mobility related topics

#### Events & Activities

- Members attended City Council meetings and community meeting regarding Fox Hills Neighborhood Traffic Management
- Members attended receipt by Art Nomura on November 14, 2022 of commendation by City Council in recognition of his work on Project Visibility

#### Administration

- Produced biannual report to City Council covering period January – June 2022 and authorized transmittal to City Council
- Requested staff submit draft bylaws for discussion

- Make recommendations to City Council as appropriate on topics requested by City Council and on agenda items coming before City Council, including but not limited to Move Culver City Project, Main Street closure, and Melville Street closure

- Form ad-hoc subcommittees to engage and collaborate with West LA College and to investigate safety concerns and possible solutions to mobility challenges on Elenda Ave
