Garden Guidelines and Requirements

- ADA compliance.
- Easy access to free parking.
- Approximately 4,500 sq ft of space.
- Lanes wide enough for passing.
- Lanes for wheelchairs.
- 8-foot fence with locked entryways.
- Must be a Culver City resident that lives in an apartment or dwelling with no gardening space available to you.

Veterans Memorial Park


- Potential for 10+ raised bed plots.
- Easy access to free parking and walkways.
- Within close proximity of the previous garden.
- Tree removals are not needed.

Syd Kronenthal Park


- Easy access to free parking.
- Can accommodate about 10 plots.

- Area is located next to the outdoor basketball court.
- Area is located across from the baseball field.
- Behind the area is a bike path.
- Unhoused individuals.

- Potential for 10+ plots.
- Passive park.

Issues To Consider For Future Planning:

- No parking. Street only.
- Capital Improvement Project. Requires the approval of various departments.

Culver City Park	Easily accessible	Street & Small lot	Rose Garden	Highly permitted.
Blair Hills	Not easily accessible	Street	None	Park space is limited.
Blanco	Not easily accessible	Street	None	Located on school premises.
Culver-West	Easily accessible	Street & Small lot	Grass area adjacent to sidewalk.	Location identified will be too close to the public right of way.
El Marino	Easily accessible	Street	None	Park space is limited.
Lindberg	Easily accessible	Street & Small lot	None	
Carlson	Easily accessible	Street	None	Pocket park. Park space is limited.
Fox Hills	Not easily accessible	Street	Near walking path	Locations identified can be utilized. Limited plots. Not ADA compliant
