As requested, please let this letter serve as notice that the property owner of the above referenced location, as well as Pep Boys as tenant, does not wish to recreate the now inadvertently destroyed Artwork referenced above, but rather seeks to have said Artwork deaccessioned from the City's Art in Public Places Program ("APPP") collection. As a result of the Artwork being inadvertently destroyed, the Artwork cannot be appraised for its current market value per CCMC 15.06.150L and in an effort to settle this matter, Pep Boys is willing to pay to the City of Culver the amount of \$15,000.00 representing the original cost for commissioning the Artwork, as provided by Michelle Isenberg & Associates, Inc. Attached please find Pep Boys check payable to the City of Culver in the amount of \$15,000.00.

As a result of Pep Boys payment to the City of the original cost for commissioning the Artwork, we understand that the City has agreed to instruct Building Safety to lift the hold on and allow Advance Auto Parts, the subtenant of Pep Boys, to immediately close out their two pending permits (B21-0451 and B21-0656). We would appreciate some correspondence from you confirming the closure of those permits.

Pep Boys believe that this resolves this matter with the City, however, should you have any questions or require additional information, please contact me at your convenience.
