3 NOW, THEREFORE, the City Council of the City of Culver City, California, DOES  
4 HEREBY RESOLVE as follows:

5 1. The terms of Title 2 California Code of Regulations § 18730, and any  
6 amendments thereto, which have been duly adopted by the Fair Political Practices Commission  
7 (FPPC), are hereby incorporated by reference and, together with the attached Appendices A-  
8 C, which designates City officials and employees and establishes respective financial  
9 disclosure categories, shall constitute the City of Culver City Conflict of Interest Code.  
10

11 2. Future amendments to the terms of Title 2 California Code of Regulations  
12 § 18730, which are duly adopted by the FPPC, shall become part of the Culver City Conflict of  
13 Interest Code upon the expiration of forty-five (45) days after receipt by the City Council, unless  
14 the City Council, by Resolution, decides not to adopt such amendments in whole or in part.  
15 The City Council hereby reserves the right not to adopt any provisions not within the jurisdiction  
16 of the FPPC pursuant to Government Code § 81000, et seq.  
17

18 3. Designated employees and elected and appointed officials identified in  
19 Appendix "B" shall file Statements of Economic Interests (Form 700 Statements) with the City  
20 Clerk, to whom the City Council hereby delegates the authority to carry out the duties of filing  
21 officer. The Form 700 Statements of designated employees shall be retained as official records  
22 by the City Clerk and shall be made available for public inspection and reproduction, in  
23 accordance with Government Code § 81008.  
24

25 4. Pursuant to Government Code §§ 87200 et seq., upon receipt of Form 700  
26 Statements completed by City Council Members, Planning Commissioners, the City Manager,  
27

1 the City Attorney and the Chief Financial Officer/City Treasurer, the City Clerk shall make and  
2 retain a copy and forward the original of these Form 700 Statements to the FPPC.

3 5. Resolution No. 2021-R096 is hereby rescinded.

2 **APPENDIX "A"**

3 **GENERAL PROVISIONS**

4 When a designated employee is required to disclose investments and sources of  
5 income, he/she need only disclose investments in business entities and sources of  
6 income, which do business in the jurisdiction, plan to do business in the jurisdiction or  
7 have done business in the jurisdiction, within the past two (2) years. In addition to other  
8 activities, a business entity is doing business within the jurisdiction if it owns real property  
9 within the jurisdiction. When a designated employee is required to disclose interest in real  
10 property, he/she need only disclose real property, which is located in whole or in part  
11 within not more than two (2) miles outside the boundaries of the jurisdiction or within (2)  
12 miles of any land owned or used by the local government agency.

13 Designated employees shall disclose their financial interests pursuant to the  
14 appropriate disclosure category designated for each position.

15 **DISCLOSURE CATEGORIES**

- 16 Category 1: Persons in this category shall disclose all  
17 interests in real property.
- 18 Category 2: Persons in this category shall disclose all  
19 investments.
- 20 Category 3: Persons in this category shall disclose all  
21 sources of income.
- 22 Category 4: Persons in this category shall disclose all  
23 investments in business entities and sources  
24 of income of the type which, within the past two  
25 years, have contracted with the designated  
26 employee's department to provide services,  
27 supplies, materials, machinery or equipment.
- 28 Category 5: Persons in this category shall disclose any  
business entity in which the designated  
employee is a director, officer, partner, trustee,  
employee or holds any other position.
- Category 6: Persons in this category shall disclose all  
investments, interests in real property and  
sources of income subject to the regulatory,  
permit or licensing authority of the Board or  
Commission on which the member serves.

10 based upon that description, a statement of the extent of disclosure requirements. The  
11 City Manager’s determination is a public record and shall be retained for public inspection  
12 in the same manner and location as this Conflict of Interest Code.
