3 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
4 CULVER CITY AUTHORIZING THE FILING OF A CLAIM WITH  
5 THE LOS ANGELES COUNTY METROPOLITAN  
6 TRANSPORTATION AUTHORITY FOR TRANSPORTATION  
7 DEVELOPMENT ACT FUNDS FOR FISCAL YEAR 2023-24

8 WHEREAS, the State Transportation Development Act (TDA), as amended by  
9 the Mills-Alquist-Deddeh Act (Public Utilities Code Section 99200 et seq.) provides for the  
10 allocation of funds from two funding sources: the Local Transportation Fund (LTF), derived  
11 from a ¼ cent of the general sales tax collected statement; and State Transit Assistance funds  
12 (STA), derived from the statewide sales tax on diesel fuel; and

13 WHEREAS, these funds are available for use by eligible claimants for various  
14 transportation purposes; and

15 WHEREAS, pursuant to the provisions of the TDA, as amended, and pursuant  
16 to the applicable rules and regulations thereunder (Cal. Code of Regulations, Title 21,  
17 Sections 6600 et seq.), a prospective claimant wishing to receive an allocation from the LTF  
18 shall file its annual claim with its county transportation authority; and

19 WHEREAS, the City of Culver City is an eligible claimant and desires to file a  
20 claim for LTF with the Los Angeles County Metropolitan Transportation Authority (Metro);

21 NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CULVER CITY,  
22 CALIFORNIA DOES HEREBY RESOLVE AS FOLLOWS:

23 SECTION 1. The City Manager or their designee is hereby authorized to execute  
24 and file an appropriate claim with Metro pursuant to the terms of the TDA, as amended, and  
25 pursuant to the applicable rules and regulations promulgated thereunder, together with all  
26 necessary supporting documents, for an allocation of TDA funds in Fiscal Year 2023-24.

1 SECTION 2. The authorized claim includes \$856,352 for STA Article 6.5 funds  
2 for local transit purposes, including transit expenditures for services provided by Culver City  
3 Municipal Bus Lines (Culver CityBus).

4 SECTION 3. The authorized claim includes \$8,890,979 for TDA (LTF Article 4)  
5 funds for local transit purposes, including transit expenditures for services provided by Culver  
6 City Municipal Bus Lines (Culver CityBus).

7 SECTION 4. A copy of this Resolution shall be transmitted to Metro in  
8 conjunction with the filing of this claim.

9 SECTION 5. The City Clerk shall certify to the adoption of this resolution and  
10 shall cause a certified Resolution to be filed in the Office of the City Clerk.
