WHEREAS, the property identified as Los Angeles County Assessor Parcel Number 4312-014-052, City of Los Angeles, County of Los Angeles, California, and more particularly described on, and shown on the respective maps attached to, Exhibit "A" attached hereto and incorporated herein by this reference (Subject Property), has been acquired for a public use, namely, public parking and open space purposes and all purposes necessary and convenient thereto (Proposed Project); and:

WHEREAS, the City is authorized to acquire the lease-hold interest in the Subject Property by eminent domain pursuant to Article I, Section 19 of the California Constitution, Streets and Highways Code Sections 5100 et seq. and 10102, Code of Civil Procedure Sections 1230.010 et seq. (the California Eminent Domain Law), including but not limited to Sections 1240.010, 1240.020, 1240.030, 1240.110 and 1240.120, 1245.330 and other provisions of the law; and

WHEREAS, the City has made every reasonable effort to acquire the leasehold interest in the Subject Property;

WHEREAS, written notice was given to the affected tenant of the Subject Property in accordance with Code of Civil Procedure Section 1245.235 of the date, time and place where the matters addressed herein would be heard and considered by the City Council; and

1 WHEREAS, on June 13, 2016, the City Council held a duly noticed hearing 2 pursuant to the terms of Code of Civil Procedure Section 1245.235, and all interested parties 3 were given an opportunity to be heard. The hearing was concluded prior to the adoption of this Resolution; and 4

WHEREAS, the City has complied with all legal prerequisites and statutory 5 6 requirements to exercise the power of eminent domain to acquire the lease-hold interest in 7 the Subject Property prior to the adoption of this Resolution.

NOW, THEREFORE, the City Council of the City of Culver City DOES HEREBY RESOLVE, as follows:

SECTION 1. In all respects as set forth in the above recitals of this Resolution. 10 the City Council hereby declares its intention to acquire the lease-hold interest in the Subject Property in the name of the City of Culver City in accordance with the provisions of the laws 12 13 of the State of California governing condemnation procedures;

SECTION 2. That the lease-hold interest in the Subject Property, which is 14 15 required for the purposes referenced herein, is situated in the County of Los Angeles, State 16 of California, and are more specifically outlined in the legal descriptions and maps attached hereto as Exhibit "A" and incorporated herein by this reference; 17

SECTION 3. On the basis of the information contained in the Agenda Item 18 19 Report to the City Council dated June 23, 2016 which is incorporated herein by this reference, 20 and all other evidence and testimony presented to the City Council either prior to or on this date, the City Council of the City of Culver City declares by a vote of at least two-thirds of its 22 members that it has found and determined each of the following:

- The public interest and necessity require the Proposed Project; and the Α. Proposed Project is planned or located in the manner that will be most compatible with the greatest public good and the least private injury; and
- The Subject Property is necessary for the Proposed Project; and Β.

C. The just compensation offer required by Government Code Section 7267.2 has been made to the business owner of the lease-hold interest in the Subject Property; and

D. All the conditions and statutory requirements to exercise the power of eminent domain to acquire the lease-hold interest in the Subject Property have been complied with by the City of Culver City.

SECTION 4. As to any portion of the Subject Property that is currently appropriated to a use, the use for which the Subject Property is taken is a more necessary public use than the use to which the Subject Property is presently appropriated. The City of Culver City is empowered to acquire the lease-hold interest in the property for a more necessary public use pursuant to Code of Civil Procedure Section 1240.610.

11 **SECTION 5.** The City of Culver City hereby declares its intention to acquire 12 the lease-hold interest in the Subject Property by proceedings in eminent domain. The law 13 firm of Kane Ballmer & Berkman is hereby authorized to bring an action in the Superior Court 14 of the State of California for the County of Los Angeles, in the name of the City of Culver City 15 against all business owners and claimants of the lease-hold interest in the Subject Property 16 described herein to condemn the lease-hold interest to the Subject Property for public parking and open space purposes and all uses convenient and necessary thereto, and to do all things 17 18 necessary in its opinion to prosecute said action to its final determination in accordance with 19 the provisions of law applicable thereto. The aforesaid special eminent domain counsel is specifically authorized to take whatever steps and/or procedures are available to them under 20 21 the Eminent Domain Law of the State of California (Code of Civil Procedure, Title 7, Chapters 22 1-12, Sections 1230.010 - 1273.050).

SECTION 6. The City of Culver City hereby declares its intention to acquire
the lease-hold interest in the Subject Property, by Court proceedings and Motion for an Order
of Possession prior to Judgment.

SECTION 7. This Resolution shall take effect immediately upon its adoption.
