5.	Service Charge for Late Renewal	\$ 15.00
6.	Fee to Appeal Suspension or Revocation of Alarm Permit	\$150.00
7.	False Alarm Charge-Permit holders First chargeable response per permit yr. All other chargeable responses	\$120.00 \$235.00
8	False Alarm Charge for No Permit, Suspended or Revoked Permit	\$235.00
9.	Service Charge for Late Payment of False Alarm Charge	\$ 15.00
10.	Alarm User Failure to Respond to Scene Charge	\$ 15.00
