3 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
4 CULVER CITY, CALIFORNIA, APPROVING PROPOSED
5 CHANGES TO THE FORMAT AND PROCEDURES OF
6 THE CITY COUNCIL AGENDA AND RESCINDING
7 RESOLUTION NO 2011-R042.

8 WHEREAS, California Government Code 54950 et Seq. (The Ralph M.
9 Brown Act) requires that a legislative body, including the City Council, post an agenda prior
10 to a meeting held by that legislative body; and,

11 WHEREAS, The Ralph M. Brown Act also provides that a legislative body of a
12 local agency may adopt reasonable regulations, including, but not limited to, regulations
13 limiting the total amount of time allocated for public testimony on particular issues and for
14 each individual speaker; and,

15 WHEREAS, at a duly noticed public meeting held on August 22, 2016, after
16 hearing comments from the public, the City Council considered modifications to the format
17 of the agenda used by the City Council for its meetings; and,

18 WHEREAS, the City Council provided direction to the City Manager to update
19 the format of the City Council agenda consistent with the discussion and direction provided
20 at the August 22, 2016 City Council meeting.

21 NOW, THEREFORE, the City Council of the City of Culver City, DOES
22 HEREBY RESOLVE as follows:

24 1. The updated format for the City Council Agenda, attached hereto as
25 Exhibit A is hereby approved; and,

26 2. The City Manager is hereby directed and authorized to utilize the
27 updated agenda format for the meetings of the City Council and other legislative bodies

1 composed of the City Council Members, including, but not limited to, the Successor Agency
2 to the Culver City Redevelopment Agency; the Culver City Housing Authority and the
3 Culver City Parking Authority; and,

4 3. Use of the proposed and updated format for the agenda, as set forth in
5 Exhibit A, shall begin with the first meeting of the City Council that occurs on or after
6 September 1, 2016.

PUBLIC COMMENT:

At the times provided on the Agenda, the City Council will receive comments from the public on any item of interest to the public (not listed on the agenda) that is within the subject matter jurisdiction of the City Council. The City Council cannot legally take action on any item not appearing on the agenda. Such items may be referred for administrative action or scheduled on a future agenda. If you wish to address the City Council, the City Clerk requests you complete a Speaker's Card and present it to the City Clerk before the agenda item is called. You will be called to the podium when it is your turn to address the City Council. Providing your name and other information requested on the Speaker's Card is voluntary and is requested only to provide a reasonable means to notify persons when their opportunity to address the City Council has arrived. All persons may attend the meeting regardless of whether a person signs, registers, or completes a speaker's card. For specific items listed on the agenda, requests to address the City Council must be made prior to the calling for a vote on that particular item by the presiding officer. Each speaker may address the City Council for up to three minutes (up to four minutes if time is ceded). Persons who are present in the City Council Chambers may cede one minute of time to one other person who is present and wishes to address the City Council by presenting a Speaker's Card to the City Clerk. Public comments on items on the agenda are taken at the time that particular agenda item is considered by the City Council.

AUTHORITY OF PRESIDING OFFICER:

Section 611 of the City Charter provides that during any public meeting, all persons shall have the right to address the City Council, and any City commission, board or committee, subject to reasonable rules of decorum and time limits established by ordinance or the presiding officer. Therefore, the presiding officer may, from time to time, establish different time limits than those listed in this Agenda in order to effectively conduct City business. [The presiding officer may also, from time to time, re-order the items on the agenda in order to effectively conduct the City Council meeting.](#)

OF RESOURCES:**

Copies of the Agenda and a binder that includes a copy of all regular session staff reports and attachments are available on the table in the rear of the Council Chambers. During the meeting, please refrain from applause or other actions that may be disruptive to the speakers or the conduct of City business.
