## Presentation on the Ballona Creek Renaissance by BCR President Emeritus Jim Lamm

Jim Lamm, Ballona Creek Renaissance, discussed his tenure at BCR; provided a presentation on the organization including: a history of the Creek; watershed; runoff; mural backstories; cleanup and restoration efforts; greening and native plants; the bike path; education; park space; resident involvement; wildlife; urban flood protection; connecting the Creek and the community; and wetlands educational partnerships.

Discussion ensued between Mr. Lamm and Commissioners regarding the environmental impact of fireworks ignited in and around the Creek; the storm drain/catch basin's potential effect on the Creek; Culver City and Los Angeles' efforts with storm runoff; the positive effect of diversions; concern with the Creek running dry; trash and pollutants; dry weather water quality and diversions; the volunteer help from high school students; Creek boundaries; public cleanup activities; outreach; social media; public use vs. natural resources and ecological balance; security and the homeless population; bike path safety tips online; freeway underpasses; plans for improvements in the works; resistance to bike path entrances in residential cul de sacs; and thanks to Jim Lamm for his efforts over the years.
