Regina Birdsell and Leslie Robin from the Center for Nonprofit Management (CNM) conducted the Strategic Planning

Retreat. The goals of the retreat were for the City Council Members to engage in a dialogue to identify: (1) three to five City Priorities for 2016-2021 and (2) three to five topics to engage in Community discussion to further understand the issues. The City Council Members discussed the following goals: participating in the upcoming General Plan process to clarify vision for the future; increasing civic engagement; having the City become known as a City of Kindness and Compassion; creating a separate Cultural Affairs organization; addressing Ballona Creek; improving transportation and reducing congestion; addressing diversity and workforce development; and increasing revenue to support economic development.

The facilitators stated that they will provide a summary of the retreat discussion, and designated Council members will meet with staff to further define priorities and goals. Staff and the City Council will discuss updated priorities and tactics in early October for City Council to review. The document will be considered at the October 10, 2016 City Council meeting which will take place at 4:00 p.m.
