**RESOLUTION OF THE DISASTER COUNCIL OF THE
CITY OF CULVER CITY RECOMMENDING THAT THE
CITY COUNCIL ADOPT THE CITY OF CULVER CITY
EMERGENCY OPERATIONS PLAN.**

WHEREAS, the City of Culver City has long recognized its responsibility to mitigate the effects of natural, man-made or war-caused emergencies which result in conditions of disaster or extreme peril to life, property and the resources of the City, and generally to protect the health and safety and preserve the life and property of the people of the City;

WHEREAS, the California Emergency Services Act, Government Code Sections 8550 et seq., provides authority for local agencies to adopt plans pursuant to Section 8610 of the Government Code for meeting any condition constituting a Local Emergency, State of Emergency, or State of War Emergency, as those emergencies are defined under the California Emergency Services Act;

WHEREAS, Sections 3.09.015 and 3.09.035 of the Culver City Municipal Code provide that the City of Culver City Disaster Council is responsible for the development of emergency and mutual aid plans and agreements, which plans shall provide for the effective mobilization of all of the resources of the City, both public and private, to meet any condition constituting a Local Emergency, State of Emergency, or State of War Emergency and shall provide for the organization, powers and duties, services, and staff of the emergency organization;

WHEREAS, the proposed City of Culver City Emergency Operations Plan incorporates all of the provisions required by the Culver City Municipal Code, as well as

1 the Standardized Emergency Management System and the National Incident
2 Management System;

3 WHEREAS, the City of Culver City Emergency Operations plan takes effect
4 upon adoption by Resolution of the City Council; and,

5 WHEREAS, the City of Culver City Disaster Council has reviewed the City of
6 Culver City Emergency Operations Plan.

7
8 NOW, THEREFORE, the Disaster Council of the City of Culver City does
9 hereby resolve as follows:

10 1. The Disaster Council hereby recommends to the City Council the adoption
11 of the City of Culver City Emergency Operations Plan, with the effective date of October
12 24, 2016.

13
14 2. The Disaster Council hereby further recommends that the Director of
15 Emergency Services should be granted the authority to approve any revisions,
16 modifications or amendments to the City of Culver City Emergency Operations Plan.

17 3. Upon approval by Resolution of the City Council, the City Clerk is hereby
18 directed to forward two certified copies of the finalized City of Culver City Emergency
19 Operations Plan to the State of California Office of Emergency Services.
