WHEREAS, on October 24, 2016, at a duly noticed public meeting, the City Council considered establishment of various fees relating to massage establishment permit applications; and

WHEREAS, after giving the public an opportunity to be heard and considering all information before it, the City Council approved the adoption of said fees, attached hereto as Exhibit "A;" and

WHEREAS, the fees established herein are based upon the reasonable cost of providing the services and regulatory activity for administering the massage establishment permit system.

EXHIBIT "A"

The following fees are established for and applicable to Massage Establishment Permits, as described in Chapter 11.07 of the Culver City Municipal Code:

1.	Initial Massage Establishment Permit Application Fee	\$675.00
2.	Amended Application Fee for new/additional Managers	\$225.00
2.	Amended Application Fee For partnerships or corporations	\$225.00
3.	Reissuance of Permit Fee due to Name Change of Establishment	\$. 85.00
5.	Renewal Application Fee	\$195.00

OTHER FEES:

In addition to the fees set forth above:

- A business tax certificate application fee (one-time fee, which fee must be renewed annually), will be required as previously adopted by separate resolution. Massage technicians who provide services as independent contractors must obtain a business tax certificate as well.
- Business taxes are also applicable pursuant to Chapter 11.01. Massage technicians who provide services as independent contractors are also subject to business taxes in the amount of \$300.00 annually, pursuant to Section 11.01.250 of Chapter 11.01.
