Tevis Barnes, Housing Administrator, reported that staff would be drafting a memo to the City Council regarding the Community Conversation on Affordable Housing noting that the City Council had expressed interest in a joint meeting with the Landlord Tenant Mediation Board (LTMB), the Committee on Homelessness, and the City Council in Council Chambers; she discussed outreach; scheduling; topics to be considered; and additional community meetings.

Discussion and Recommendation of a Representative and an Alternate from the Landlord Tenant Mediation Board to Serve on the Short-Term Rentals Task Force Established by the City Council

Discussion ensued between staff and Board Members regarding resident concerns about Airbnbs in residential neighborhoods; termination of leases due to conversions to short-term rentals; clarification that short-term rentals are not illegal at this time; the lack of regulation regarding

converting existing long-term rental units into short-term rentals; resident requests for controls on the process; creation of a special task force to formulate policy recommendations for the City Council; establishing parameters; adding parking requirements; concern with short-term rentals being used as party houses; effects on the neighborhood; composition of the proposed task force; the time commitment involved; length of time the task force would be in existence; the need for a representative and an alternate; whether there is a deadline for establishing guidelines; and the complex nature of the issue.

Member Scott discussed her experiences allowing several of her tenants to rent-out their extra bedrooms for up to two weeks; various websites that cater to short-term rentals; a website that caters to short-term rentals in Culver City; examples of Culver City listings on different websites; procedures for short-term rentals; she indicated that she had rented out her spare room for short periods of time in the past; discussed actual numbers of short-term rentals in the City; determining how the critical the problem is; enforcement; actions of the City of Los Angeles; limitations on the number of nights allowable to rent; whether the owner lives in the unit being rented; and requirements in other cities that short-term rentals be registered.

Additional discussion ensued between staff and Board Members regarding different ways to measure the actual number of short-term rentals in Culver City, and volunteers to serve on the Task Force.

THE LANDLORD TENANT MEDIATION BOARD APPOINTED JUDY SCOTT TO SERVE AS LTMB REPRESENTATIVE ON THE SHORT-TERM RENTALS TASK FORCE.

Discussion ensued between staff and Board Members regarding individual research on the short-term rental issue; concern with those that use rental units for Airbnbs without permission from the landlord; use of facilities and amenities; holding the tenant responsible for the person subletting; whether subletting is a violation of a lease; subletting for filming; whether the City can allow tenants' rights that go beyond a lease; tenant screening; allowing random, unauthorized people into the unit; vetting through Airbnb; establishing the task force to create restrictions as there is currently nothing in place; hazards associated with posting properties for short-term rental online; the

prohibition of commercial activities in residential areas; enforcement; garage sales; permitting; citations; and Board Members interested in serving as alternate representative.

THE LANDLORD TENANT MEDIATION BOARD APPOINTED TARIA LEWIS TO SERVE AS ALTERNATE REPRESENTATIVE ON THE SHORT-TERM RENTALS TASK FORCE.

Discussion ensued between staff and Board Members regarding whether the task force meetings would be open to the public; looking at the actions of other cities; and the inclusion of Code Enforcement in the process.
