Dear Elaine,

We are pleased to submit this proposal to continue working with Culver City on the West Washington medians, Phase IV per the 2012 approved plans. The project construction will be divided into 2 sections. Phase IV-A includes islands 1 and 2 between Beethoven Street and Alla Road and will be bid and managed as a stand-alone construction project. Phase IV-B includes 5 islands, 3-7 between Alla Road and Glencoe Avenue on the south side of Washington Blvd. Construction will be bid and managed as part of an existing public works project. Fees shown are for the full project except where noted.

The approved February 10, 2012 'Construction Set' of plans will not be revised, but will need to be marked up and unnecessary details / pages crossed out. Addenda will be required for an additional water connection on Phase IV-A and use of reclaimed water equipment in Phase IV B.

Our scope is similar to our previous contract and includes: preparation of cost estimates, project bidding documents, and construction administration, management (Phase IV-A) and coordination. Fees are broken down by discipline.
