I live in Los Angeles just outside the boundaries of your project in Cameo Woods. There is a lot of new construction going on in that area, including a development on Lenawee (right behind Cameo Woods where I live) that includes assisted living housing. There is also a huge development going up on the corner of La Cienega and Jefferson, a couple of blocks away by the Metro Expo Line station. I do not think sufficient attention has been paid to impacts right outside Culver City, including also Kenneth Hahn Park across La Cienega. I climb the hill to the Baldwin Hills Scenic Overlook through the streets past Blair Hills Park in Culver City to exercise 3-4 days a week, and do not appreciate additional insults to air quality in the area. My wife was forced to leave the area because of incessant coughing while she was living here (she moved after retiring from Echo Horizon School nearby).

You definitely need to allow more time -- an additional 60 days -- as well as greater publicity about this project to Angelenos who have heard nothing about this. I only learned because I used to live in Culver City proper and was forwarded an announcement about your presentation at the Stoneview Nature Center. I get emails from the Baldwin Hills CSD and don't remember seeing anything about this. I intend to contact Herb Wesson, my LA City Council member and a family friend (his wife and mine used to work together at Echo Horizon) and urge him to get the City of LA to seek greater input on behalf of its residents.

Regarding the EIR, I think you need to include the greenhouse gas emissions that will result from burning the increased production, not just those from the construction and operation of the new wells. The best policy is to leave it in the ground. We have to move much more rapidly to non-carbon-based renewable energy resources, and every additional gallon pumped from the earth means more GHG in the atmosphere. Since it requires city approval to drill, the city should withhold its approval. The city should also prohibit all methods to stimulate increased production from existing wells.

I am a resident of Culver City.

Since 2012, I have been asking the Culver City Council for stronger anti-fracking related regulations, per the Inglewood Oil Fields.

I am writing once more to ask for a 60-day extension for public comment, so that more residents may have a chance to look over the Draft EIR. As well as to be able to submit comments on the draft, thereafter.

I personally feel we need a much stronger set back rule of not 400 feet, but 4000 feet at the minimum. Any allowance, to allow new drilling of 30 wells will directly compromise Culver City residents' health. As well as Baldwin Hills and Windsor Hills residents health too. Hello,

Thank you again for an informative presentation on the proposed Inglewood Specific Plan Project.

I am Beate Chelette, live on 4245 Irving Place in Culver City.

My first request is to please extend the review period by 60 days. It's just so much information to review and a language to learn and understand the full implementations. In addition there is not enough time to discuss with the Culver City neighbors what each of our concerns are.

Under section 5.0 Project Alternatives it states that potential significant effects of the alternatives are discussed in less detail than the significant effects of the Project as proposed.

After listening to the presentation there are two major concerns and objections I have:

5.4 Summary Of The Projects Significant and Unavoidable Impacts

Section 4.5

I object to the project because "the potential for well stimulation treatment to result in induced seismicity cannot definitively be reduced to a level less than significant.

Argument:

We cannot obtain reasonable earth quake insurance in California and it is a high risk for homeowners that we have to bear. The last thing we want to add is an even greater risk and exposure to the homes in Culver City that would cause a risk that can't even be evaluated and in case of increased seismic activities undue burden and expense. The city would also be exposed as there is a possibility of a class action lawsuit that to proof that any earthquake was caused by this project. What would make the operator assume responsibility and how would this affect the people of Culver City?

Section 5.6

Alternative 2 is a must. Deep wastewater disposal injection is known to cause seismic activity. This brings us back to point my above point. I believe seismic activity is the greatest threat to all homeowners in Culver City and the city itself.

Argument: Wastewater disposal is the primary cause of the recent increase in earthquakes in the central United States. <https://earthquake.usgs.gov/research/induced/myths.php>

Before 2008, Oklahoma experienced roughly one noticeable earthquake per year. By 2014, that number had soared to almost one a day, and the state is not alone. Scientists have documented an astronomical rise in seismic activity across the central and eastern United States, linking it to wastewater pumped into the ground from burgeoning oil and gas production. Now, new research suggests that high rates of fluid injection—rather than other factors such as volume or depth—may be the root of the problem. <http://www.sciencemag.org/news/2015/06/huge-study-links-wastewater-injection-wells-earthquakes>

The Sierra Club requests that the Culver City City Council grant a two-month extension of the comment period for the Inglewood Oil Field Specific Plan Project Draft Environmental Impact Report (DEIR) for the Inglewood Oil Field Specific Plan.

The reason for this request is that the DEIR is a voluminous document that covers highly technical issues of importance to the Culver City community that require additional time for review and preparation of comments.

Issues that require additional time for review include:

- Jurisdiction/Pre-Emption 250-1000ft depth
- Permanent and temporary/portable Surface Equipment
- Impervious/impermeable membrane or materials for containments and pads
- Shallow well design, casings, tubing, etc.
- Risks and threats requiring mitigation
- Mitigations including set back/enclosure
- Responsibilities/liabilities: Bonds for Owner/Leasee/Operator/Contractor
- Ownership/Leases-Surface/Subsurface

A two-month extension is required to give the public adequate time to provide meaningful comments.

Dear Mayor, Council members, City Attorney and City Manager,

Thank you for publishing the draft EIR and specific plan. I have been "plowing" through it to comprehend how the City intends to address areas of significance.

Although I am a researcher, I am not versed in the fields of geology, seismology, health risk exposures, water and air quality, etc, nor am I a statistician. Thus it is taking time to strive to adequately

- understand and evaluate impacts addressed,
- reflect on proposed mitigation outcomes,
- assess to what degree they will preserve our health, safety, and quality of life in light of the data presented, and
- note if any area of significance may have unintentionally been overlooked.

As I have gotten to know and respect each of you, having been a Culver City citizen for the past 40 years I sense that you too are committed to our health, safety, and well-being.

The unusual circumstance of having a very well educated population (per the City's recent MJHMP, 50% of our population is college educated, with over 27% holding advanced degrees) calls for respecting CEQA's intent and extend the Public Comment period. This will give us time to better understand impacts and proposed mitigations in order to make meaningful comments and suggestions, and so help assure that the work of our Staff and consultants indeed protects us. Is this not CEQA's intent?

Here in our beloved Culver City, let us not abrogate democratic process in favor of expediency or fear of being bullied by private interests! Let us set the bar for true democratic engagement! Yes?

May your decisions demonstrate that democracy that still exists at the local level.
And let us stay ever more strongly united in protecting the Greater Good!
