3 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
4 CULVER CITY, CALIFORNIA, SETTING PRIORITIES FOR  
5 FILING WRITTEN ARGUMENTS REGARDING A CITY  
6 MEASURE AND AUTHORIZING CERTAIN PERSONS TO  
7 SUBMIT ARGUMENTS REGARDING A CANNABIS  
8 BUSINESS EXCISE TAX MEASURE, WHICH WILL BE ON  
9 THE BALLOT FOR APRIL 10, 2018 GENERAL MUNICIPAL  
10 ELECTION.

11 WHEREAS, under the provisions of the Charter of the City of Culver City,  
12 California, a General Municipal Election shall be held in the City of Culver City,  
13 California on April 10, 2018, at which time there will be submitted to the voters the  
14 following measure:

16 To provide funding for fire/paramedic/police protection, road  
17 repairs, parks/recreation and other general municipal services shall  
18 Culver City tax commercial cannabis cultivation at \$12.00 per  
19 square foot and gross receipts of cannabis businesses not to  
20 exceed the following rates: 6% manufacturing/distribution; 8%  
21 medicinal I retail; 10% adult use retail; and 1.5% testing; raising  
22 approximately \$1,200,000 annually, until ended by voters,  
23 requiring annual audits and compliance with laws protecting public  
24 health, safety and community standards?

6 the date fixed by the City Clerk after which no arguments for or against the City  
7 measure may be submitted to the City Clerk:

14 printed name(s) and signature(s) of the author(s) submitting it, or if submitted on behalf  
15 of an organization, the name of the organization, and the printed name and signature of  
16 at least one of its principal officers who is the author of the argument. The arguments  
17 shall be accompanied by the Form of Statement To Be Filed By Author(s) of Argument.

18 SECTION 3. That the City Clerk shall certify to the passage and adoption of this  
19 resolution and enter it into the book of original resolutions.
