3 A RESOLUTION OF THE CITY COUNCIL OF THE CITY
4 OF CULVER CITY CALIFORNIA, AGREEING TO JOIN
5 REVITALIZE CALIFORNIA CITIES BY AND AMONG
6 MUNICIPALITIES AND AGENCIES WITHIN THE STATE
7 OF CALIFORNIA FOR THE PURPOSE OF ESTABLISHING
8 A UNIFIED MESSAGE TO ADVOCATE FOR THE RETURN
9 OF KEY COMMUNITY AND ECONOMIC DEVELOPMENT
10 TOOLS THAT WERE LOST WITH THE DISSOLUTION OF
11 REDEVELOPMENT

13 WHEREAS, municipalities and agencies within the State of California agree
14 that the February 2012 Sacramento decision to eliminate redevelopment has limited the
15 ability of local California cities to improve their communities; and,

16
17 WHEREAS, the elimination of redevelopment has had negative community
18 and economic development impacts that have affected the ability of cities to create jobs,
19 eliminate blight, rebuild infrastructure and build affordable housing; and,

21 WHEREAS, through a collaborative effort, Revitalize California Cities
22 ("Revitalize CA") seeks to advocate for common sense legislative solutions that will
23 enhance local governments' economic toolbox.

25 NOW, THEREFORE, the City Council of the City of Culver City, California,
26 DOES HEREBY RESOLVE:

28 1. Revitalize CA shall act as the lead organization with respect to the
development of strategy and policy, implementing said strategy and policy, and promoting
and administering the organization on behalf of municipalities and agencies within the
State of California who have joined Revitalize CA ("Members"); and,

2. In order to achieve the objectives of Revitalize CA, each Member agrees
to pay five thousand dollars (\$5,000.00) to Revitalize CA as a one-time membership fee.

1 3. Each Member shall designate one or more representatives to be an active
2 participant in Revitalize CA meetings, and facilitate the exchange and dissemination of
3 information to further the organization's objectives.

4 4. The City of Culver City does hereby join Revitalize California Cities as of
5 January 22, 2018, as authorized by the Mayor's signature below.

6 5. This Resolution shall take effect immediately upon its adoption.
