1. Topic: Sexual Harassment and Assault
 - a. Statement by Paula Amezola:

“To continue to strengthen our goal to creating a kinder Culver City, we propose the community topic “#MeToo - Changing the Culture Around Us”. This topic will include a discussion on respecting one another and the effects of gender, race and class on sexual harassment & assault. In the recent months we have seen how sexual assault is a national, state and local problem, that we need to address now. Let's use this moment in time as a catalyst to bring awareness of the prevalence of sexual assault and changing the culture to prevent anyone else from experiencing this. It's important to educate our youth about acceptable and unacceptable behavior in school, the workplace or in public spaces (such as parks). The focus will be on respecting one another especially those that are our subordinates. We hope to strike a balance between empowering girls to say “no” to unwanted behaviours and helping boys understand appropriate behaviour.
