Hi,

I've been a Culver City resident for almost 10 years and frequently walk from my house to the Nature Trail Boardwalk that's a part of the proposed designated dog path. I do not have a dog. I have 2 small human children who I've enjoyed taking on the nature path without having to worry about hitting peoples' dogs with my stroller.

In a city (LA as a whole) where the entitlement of dog owners seems ever on the rise, I frankly feel that the currently designated human nature boardwalk path should stay dog free. We have a dog park and a designated doggie path that goes right to it. You've done your share for the culver city pet. A connection to the Baldwin Hills gate seems pointless as dogs aren't allowed in that park at all, but if dog owner's are simply looking for exercise, can't they follow the access road? Put some money into a suitable sidewalk up the back side of the park along the access road and around the upper fields, but please keep the boardwalk dog free. Having a dog sometimes means you can't do everything you want to do. And as a former dog owner and current dog lover, that's a big reason why I've consciously chosen no to own a dog in LA.

I'm concerned that if you designate any more of my favorite Culver City park for dogs, the next issue you're going to have is the nearly impossible task of enforcing leash laws in those new areas and around the upper fields. While some dogs are fabulously trained by competent owners and could earn off-leash status around my children, some owners have a very poor understanding of their dogs obedience abilities and make bad choices that put others at risk. Just this week at Rancho Park/Cheviot Hills an off leash dog jumped in my car while I was loading my children into it. The owner of the dog seemed annoyed when I recommended a leash and presented the incredibly confusing attitude that his dog's quality of life and freedom to roam was equally as important as the safety of my children. Thankfully in a court of law, it's not. I've really enjoyed the boardwalk as a safe place to enjoy time with my young family without having to discern the good dog owner from the bad dog owner. Up 'til now, I haven't had to deal with significant dog owner entitlement in Culver City park and I'm really not interested in starting now.

Please don't call anything a "designated dog path". It feeds that entitlement. Sure you can put paw prints on the sidewalk to help people find the Bone Yard, but in considering new improvements with our tax dollars, make a new path for the people of this town and let them assume their dogs are welcome unless otherwise stated. Make a path or don't, but please retain the Nature Trail Boardwalk's designation for humans only.

I love dogs, but I don't see how a trail could realistically be designated both ADA accessible trail and allow dogs, because so many dog owners won't pick up after their pets or keep them on a leash. People with disabilities should be able to use an ADA trail in peace, without getting their equipment smeared with dog poop or having off-leash dogs jump or bark at them. I also walk on the dirt path around West L.A. College, less than a mile away from the proposed new paths. Some of the dog owners, the few who actually use poop bags, throw them in the bushes or in the sound barriers where they can't be seen, less than 25 yards away from the people who live adjacent to the path. These dog owners live within walking distance and could easily dispose of the bags properly. I'm OK with dogs jumping on me but I hate constantly dodging dog poop and poop bags that are drug out of their hiding places.
