# TIMELINE OF THE DOMESTIC FERRET LEGALIZATION EFFORT



1930's

All ferrets are banned under a broad statute prohibiting non-native species.

1990s

Four state bills fail. Twice the Fish & Game Commission rejects regulation changes.



2004

The Legalize Ferret Bill, SB89, passes the state legislature, only to have Governor Schwarzenegger veto.

2017

With no legislative representation for 13 years, attempts to permit domestic ferrets through the Fish & Game Commission fail.



## **FUTURE**

Currently requesting local city councils to become ferret friendly cities and working to secure support in the legislature.



# **DOMESTIC** FERRETS DON'T **THREATEN** WILDLIFE

**QUICK FACTS** 



Number of birds killed by domestic house cats per year. However no state reports any significant impact of domestic ferrets on local ecosystems or agriculture.

Ferrets were domesticated from European Polecats 2,000 years ago.

A rabies vaccine specificly for domestic ferrets has been administered since 1988.

You are 200 times less likely to be bitten by a ferret than a dog.

(And more likely to be bitten by a human, too!)

#### **Domestic Ferret Facts Supporting the Legalization of Ferrets in California**

#### Ferrets are domestic animals, not wildlife.

- The CDC1, Humane Society 2, and USDA3 all classify ferrets as domestic animals, not wildlife.
- Ferrets were domesticated from European polecats over 2000 years ago.<sup>4,5,6</sup>
- There are several studies linking domestic behaviors of animals, such as ferrets, to genetics rather than experience or training from interacting with humans.<sup>7</sup>
- Domestic ferrets, by definition, are an animal, that has been tamed and kept by humans as a work animal, food source, or pet, through selective breeding, and became notably different from their wild ancestors.8
- Domestic ferrets are the only domestic animal in the scientific family Mustelidae. They are not rodents and are cousin to the otter & black footed ferret of the central United States.

#### There are no feral ferrets and ferrets do not spread rabies.

- In 2009, all 50 states were surveyed by California Sate University Sacramento and none reported having a feral ferret population.<sup>9</sup>
- The domesticated ferret only exists in people's homes.<sup>10</sup> If the domestic ferret escapes to the outdoors it will not survive for more than a few days.<sup>11</sup>
- To avoid pet overpopulation and prevent health problems, every Marshall Ferret is neutered (spayed/castrated) and de-scented before being sent to authorized pet dealers. Marshall ferret is the largest breeder in the United States.
- A Rabies vaccination specific to domestic ferrets has been available since 1988.<sup>12</sup>Less than one ferret per year test positive for rabies. This is in contrast to the more than 200 cats and 140 dogs that are found carrying the virus every year.<sup>13</sup> Domestic ferrets have never transmitted rabies to a human or another animal.<sup>14</sup>
- In the 1880s the New Zealand government imported, released and bred domestic ferrets with polecats in the thousands to assist with pest control. This lead to a feral hybrid population that did cause harm to native wildlife but it is not a feral domestic ferret issue.<sup>15</sup>

#### Ferrets do not have an impact on agriculture or wildlife populations.

- Because there are no feral domestic ferrets, they do not inhabit natural ecosystems and have no roles.
- No state reported any major impact on agri-business, or any major opposition to ferrets. 12 Unlike cats, who are responsible for the deaths of 1.4 to 3.7 billion birds and 6.9 to 20.7 billion mammals every year. 17

#### Ferrets make great pets.

- Domestic ferrets are more 'dog-like' than 'wild ferret-like' due to genetic breeding.<sup>15</sup>
- They share many qualities with dogs & cats. They are affectionate, playful, intelligent, quiet, and small.
  Domestic ferrets adjust easily to humans schedules and are not nocturnal. They recognize their name, respond to verbal and visual commands, can learn to do tricks <sup>11</sup>, and be trained to use a litter box. <sup>16</sup>
- Domestic ferrets can be used as service animals detecting seizures or providing emotional support.<sup>18, 19</sup>
- Ferrets can coexist peacefully and amicably with cats and dogs.<sup>20</sup>

#### Ferrets are not 'vicious, blood thirty animals" and are safer than dogs.

- Like all pets, ferrets need to be taught what acceptable behavior is. 11 Dogs are at least 200 times more likely to bite than are ferrets. 21 In fact, based off of statistics, you are more likely to be bitten by a cat, rabbit, snake, or even a human being than a domestic ferret. 22
- The CDC indicate that a ferret bite is far less severe than what can be inflicted by a cat, dog, or even another human child.<sup>10</sup>
- The media have sensationalized a few cases indicating that a ferret viciously attacked a baby or child. In all reported cases, the ferrets had suffered from extreme animal abuse (and in many cases, the child had also suffered from neglect.)<sup>10</sup>
- The ASPCA and the HSUS warn "that No pet should be left unsupervised with a child.<sup>22</sup> When ferrets are around small children the interaction should be monitored as closely as you would with a dog.

#### Why Culver City should be Ferret Friendly:

- Over 600 signatures collected in less than a week for a Ferret Friendly Culver City.
- 3 Veterinarian offices in Culver City treat ferrets, Access, Culver Palms & CenterSinai.
- 6 pet stores sell products to ferret owners. (food, toys, bedding, litter) Petco & PetsMart have dedicated ferret sections. 28% of the country's ferret supplies are sold in California.
- La Mesa City Council just voted to support ferrets, 5-0
- The State's claims to keep ferrets illegal are unfounded. Ferrets are not wild but domestic house pets according to the CDC, Humane Society & USDA. No state has ever reported having a feral ferret problem. The species of ferrets that are kept as pets do not live any where in the wild. They are breed to be with humans.

#### What would Ferret Friendly mean for Culver City?

A Ferret Friendly Culver City would mean that the city acknowledges there are ferret owners living here who should not be living illegally, and possibly convicted of a misdemeanor, for owning a house pet that is legal in 48 states. Though the city cannot supersede state law, they can stand with their local business, ferret owners and enthusiast by publicly supporting legalizing domestic pet ferret ownership in California.
