### Review of Carnival 2017

John Adams, Disability Services Specialist, asked for feedback on how to improve the Disability Carnival for 2018.

Discussion ensued between staff and Committee Members regarding incorporating activities for older adults; broadening the scope of the event; engaging different vendors; renaming the event to reflect the broader reach; adults currently served by the Carnival; making the Carnival more inclusive; suggestions for different names; emphasizing resources available by calling it a Resource Fair; choosing a positive name; encouraging more people to come; eliminating confusion; behavior issues; ensuring that volunteers and participants feel supported; adding a friendly reminder on expectations and standards for the event; staff intervention; wristbands; seniors who thought the event was for them; the open nature of the event; requiring registration in the future; photo waivers; the Senior Center Newsletter; ensuring that the focus on children is not lost; outreach to schools; inclusion of special education classes from the Los Angeles Unified School District; clarification that the focus on children would not be reduced but that changes were sought to provide additional opportunities; nonprofits that provide direct services; expanding the scope of the Carnival; a suggestion that Committee Members submit email suggestions to rename the Carnival for consideration at the special meeting in March; clarification that thank you letters were sent out to donors; evaluation and updating of games; budget suggestions and clarification that there is no direct funding for the event beyond staffing and the

facility; continuing to have therapy dogs at the event; the art show from LA Goal as a the tie in between the kids and older adults; and the wish of some of the Girl Scouts to develop some new games.
