1 2. The names of persons voted for at the election for Member of the City
2 Council are as follows: Daniel Lee, Albert P. Vera, Marcus G. Tiggs, and Harden Alexander
3 "Alex" Fisch.

4 3. The Measure voted upon at the election is as follows:

5 **Measure A:** "Shall Culver City adopt a measure funding
6 fire/paramedic/police protection, road repairs, youth programs, parks/recreation and other
7 general municipal services by taxing commercial marijuana cultivation at \$12.00/square foot
8 and gross receipts of marijuana businesses not exceeding: 6% manufacturing/distribution;
9 8% medical retail; 10% adult use retail; and 1.5% testing; raising approximately \$1,200,000
10 annually, until ended by voters, requiring audits and compliance with laws protecting public
11 health, safety and community standards?"

12 4. The number of votes given at each precinct and the number of votes
13 given in the City to each of the persons above named for the respective office for which the
14 persons were candidates, and to Measure A, are as listed in Exhibit "A," attached hereto and
15 made a part hereof.

16 5. Pursuant to Section 15360 of the Elections Code, the Elections Official,
17 under her direct supervision, caused to be completed a manual tally of two precincts, the
18 results of which are listed in Exhibit "B" attached hereto and made a part hereof.

19 6. The City Council declares and determines that Harden Alexander "Alex"
20 Fisch and Daniel Lee are each elected as a Member of the City Council for a full term of four
21 years.

22 7. As a result of the election, a majority of the voters voting on Measure A
23 voted in favor of it, and the Measure was carried and shall be deemed adopted and ratified.

24 8. The Elections Official shall enter on the records of the City Council of
25 the City of Culver City a statement of the result of the election, showing: (1) the whole
26 number of ballots cast in the City; (2) the names of the persons voted for and Measure voted

1 upon; (3) the office into which each person was voted; (4) the number of votes given at each
2 precinct to each person and for and against the Measure; and (5) the total number of votes
3 given to each person and for and against the Measure.

4 9. The City Clerk shall immediately make and deliver to each of the
5 persons so elected a Certificate of Election signed by the City Clerk and authenticated. The
6 City Clerk shall also administer to each person elected the Oath of Office prescribed in the
7 Constitution of the State of California and shall have them subscribe to it and file it in the
8 Office of the City Clerk. Each and all of the persons so elected shall then be inducted into
9 the respective office to which they have been elected.
10

11 10. The City Clerk shall immediately codify the complete text of Measure A,
12 adopted by the voters, into the Culver City Municipal Code; and shall immediately file the
13 complete text of Measure A, adopted by the voters, with the California Secretary of State.
14

15 11. The City Clerk shall certify to the passage and adoption of this resolution
16 and enter it into the book of original resolutions.


