PRCSC - Receive and File an Informational Item Regarding Aquatics from the Senior and Social Services and Facilities Division of the Parks, Recreation and Community Services Department

Jeanine Houchen, Recreation Coordinator, provided a presentation on programming at The Plunge.

Discussion ensued between staff and Commissioners regarding the number of groups using the rental facility; Culver City vs. non-Culver City users; tracking proof of residency; the amount of time available for recreational swim for community members; balancing programming; pricing; a suggestion not to increase youth fees, but instead to increase fees for non-resident adults; providing access to youth so they can learn how to swim; balancing community demand; scanning and user compliance; data; the high demand for pool space; and the importance of working to accommodate adults as well.

Chair Rickards invited public comment.

The following member of the audience addressed the Commission:

Clay Evans, SCAQ Swim Club, provided background on his club; discussed their partnership with the City; he asserted that the club is an asset to the City; and he

expressed concern about their deteriorating relationship with the City.

Marci Baun, SCAQ, provided photographs to Commissioners; discussed raising money to help the pool; triathletes that swim with SCAQ; she felt that the adults should not be forgotten; discussed resident use vs. non-resident use; availability of the pool; the inability to expand with limited resources; and she wanted to see the pool at the High School used.

Loulou Rees provided materials to Commissioners and background on herself; discussed her positive experiences with SCAQ including rehabilitation from an injury through swimming; the need for adult coached swimming; inefficient lane allocation; and she expressed concern with nepotism.

Jaqueline Lettieri, SCAQ, discussed the elimination of midday swim and concern that the pool is now empty during the day; reduced lane allocation; loss of revenue for area businesses; payment of fees; and she felt that SCAQ is a big reason why The Plunge is successful.

Robyn Beresh expressed concern with the proposed closure of the pool to SCAQ during midday hours; discussed the impact on pool users; she questioned the reasoning behind the proposed change; discussed addressing concerns; pool uses; lane efficiency; the need for continued access and use of the pool during midday hours; physical health; the importance of continuing to be active as one gets older; and she wanted to see equal use for adults and children.

Don Van Cleve provided background on himself; discussed his experiences as a swimmer in Culver City; thinking about SCAQ as a resource; outside users; use of the pool by swimmers of varying levels; and he encouraged engagement and utilization of SCAQ as well as cooperation regarding swimming hours.

Steven Contarsy, SCAQ Coach, provided background on himself; discussed filling the 50 meter facility; hours; and he felt that more lanes dedicated to SCAQ would be a benefit to the entire City.

Masaru Heriuch discussed how important swimming with SCAQ is to him and he expressed concern with the potential elimination of midday access to the pool.

Discussion ensued between staff and Commissioners regarding public concern with the potential removal of access to the pool during midday in order to accommodate lessons; summer programs; diversity in Culver City; low income students; the importance of teaching everyone to learn how to swim; safety issues; overcoming fear; the importance of striking a balance; low cost swim lessons to save lives vs. providing a healthy venue for residents and non-residents to exercise; concern with long-time groups that are now having issues engaging with the City; City efforts to dialog with partner groups; demand for City facilities; recreational swimming vs. lap swimming; consistency with times; offering opportunities during recreational hours vs. lesson hours; flexibility; the opportunity to rent lanes from the City; the commitment of staff to evaluate and adapt as needed; fees; demand; equity; becoming a larger resource; and the importance of communication and finding a way forward.
