John Nachbar, City Manager, led the invocation and the Pledge of Allegiance was led by Hector Marin.

Community Announcements by City Council Members/Information Items from Staff

Council Member Fisch thanked those who provided input regarding the mayoral succession and encouraged others with strong feelings to reach out, noting that the item would be on a future agenda.

Council Member Lee reported attending the AVPA showcase at the Mayme Clayton Library and Museum as well as the Why Drive Art Show put on by Walk 'n Rollers; he discussed his personal mobility history; and he felt that many more things could be done in the City to improve mobility.

Council Member Eriksson discussed a health event that took place at the pool on May 11, praising the work of the responding lifeguards and paramedics; he received clarification that the investigation into a shooting between

cars at Barman and Elenda is ongoing; discussed the Vector Control Board meeting; and he received clarification that a brochure with helpful information to stop mosquito breeding is up on the City website.

Vice Mayor Sahli-Wells reported that May 17 is Bike to Work Day with refreshments available at 7:00 a.m. on the Ballona Creek Bike Path at Duquesne, and free rides on Culver City Bus for those with a helmet or a bicycle.

Jeremy Green, City Clerk, reminded everyone that May 23 is the deadline to apply to serve on Committees, Boards and Commissions and she indicated that additional information is available on the City website.

Joint Public Comment - Items Not on the Agenda

Mayor Small invited public comment and discussed procedures for public speaking.

The following members of the audience addressed the City Council:

Keith Jeffreys, United States Veterans' Artists Alliance (USVAA), introduced fellow veterans and artists; encouraged everyone to visit usvaa.org; discussed the mission of the organization; distributed information to Council Members; and wanted to discuss the possibility of transforming Veterans Auditorium into a performing arts complex in the future.

Dr. Tom Williams, Citizens Coalition for a Safe Community, provided background on himself; asked about the status of the final Environmental Impact Report (EIR) for the Inglewood Oil Field; discussed the public records request procedure; water desalinization; water resources; the best path forward; and he expressed interest in developing a working relationship with Culver City.

Dr. Janet Hoult announced that the Culver City Centennial Poetry Collection had been published; she reminded everyone that May is Pet Month and displayed her book, *Going to the Dogs and Other Critters*, noting that there would be a book signing at Centinela Feed on May 20; and she discussed Culver City as a City of Kindness, and ethical, not political guidelines for all citizens.

Daryl Cherness requested that the City Council agendaize a discussion regarding installation of a memorial sign in honor of Judge Harold I. Cherness; he reported taking preliminary steps regarding the installation of the sign; discussed previous work with staff to identify a location and design for the sign; the need for City Council approval; he stated that he had been working to get the sign installed since March 2016, before the current rules regarding naming of public facilities had been established; and he requested that the City Council grant exemption from the current rules since they were established after he began his request.

Discussion ensued between Council Members regarding consensus to consider the request, and clarification that his application had triggered questions resulting in examination of the naming process and eventual changes being made.

Matthew Hetz, Culver City Symphony Orchestra, expressed support for transforming Veterans Auditorium into a performing arts center; announced their next concert scheduled for June 9 at the Kirk Douglas Theatre; expressed appreciation for the Culver City Performing Arts grant and support from Sony Pictures; and he indicated that information was available at culvercitysymphony.org

John Cohn, Exchange Club, thanked everyone for help with the 15th Annual Car Show on May 12; discussed logistics; scholarships and donations; home challenged students at West Los Angeles College; and he indicated that the next event would be the Fourth of July celebration at West Los Angeles College.

Pete Rockwell expressed appreciation to City Council Members for their hard work and service to the City.

Cynthia Hart noted substantive and significant challenges ahead for the City; expressed hope that everyone would be able to work together in a spirit of unity and kindness; and she wanted Culver City to get green rideshare bikes like Santa Monica has.

Thomas wanted to see square dancing in downtown Culver City and he discussed options available to move forward.

Discussion ensued between the speaker and Council Members regarding the Downtown Business Association; the Actors'

Gang; dancing for beginners; and encouragement to the speaker to leave his contact information.

Michael Doyle asked for information regarding the recent break with the mayoral rotation tradition.

Michael Hamel expressed concern with changes to the selection process for mayor, and concern with the creation of a divide in the City and loss of credibility.

Vice Mayor Sahli-Wells noted that the item was deferred but she suggested that a subcommittee be formed to try to set some standards for the City; she discussed justification for this type of infrastructure over another kind of infrastructure; an observation that the issue would not go away; the need for additional guidance; and consideration of establishing a subcommittee to examine the issues during subcommittee assignments at the May 29, 2018 City Council meeting.

Discussion ensued between staff and Council Members regarding City Council consensus that a request to consider adding an ad hoc subcommittee on guidelines for cell phone tower infrastructure be added to a future agenda; telecommunications providers that want to use the fiber network; the future of the fiber network; residential use or increased business use; fiber infrastructure; a suggestion that the item be expanded to include telecommunications and a discussion of fiber; whether to create a standing technology committee vs. a specific ad hoc committee; overlap between the equipment and the fiber network; and starting as an ad hoc technology infrastructure subcommittee, called the Smart City Subcommittee.

CC - (1) Presentations and Discussion Regarding the West Basin Ocean Water Desalination Project; and (2) Direction to the City Manager as Deemed Appropriate

Helen Chin, Management Analyst, provided a summary of the material of record

Shivaji Deshmukh, West Basin Water District, provided an overview of the project; discussed project objectives; preferred options; intake and discharge facilities; the intake conveyance system; the draft Environmental Impact Report (EIR); the environmental analysis; report availability; and public comment

Conner Everts, Desal Response Group, provided background on himself and an overview of their concerns including unacceptable environmental impacts; costs; water capture by West Basin; conservation and rain water programs; the issue

of demand and need; the potential for ground water expansion; exploration of all options; state water initiatives; increased efficiencies; issues with desalination efforts in Australia; and concern with financing for the project.

Mayor Small invited public participation.

The following members of the audience addressed the City Council:

Dr. Tom Williams discussed his experience with desalination; asserted that the EIR was incomplete and inadequate; suggested that the City Manager stop dealing with West Basin as the EIR would be fought in court; discussed using ground water with desal to control ground water intrusion; he felt that there would likely be direct potable reuse within the next 5 years; suggested alternatives; he questioned who would pay and who would benefit; discussed project objectives; conflicts within the EIR; studies on microplankton not considered in the EIR; more to be done in conservation; increasing the number of rain barrels; and he requested a better EIR due to concerns with adequacy and completeness.

Bruce Reznik, LA Water Keeper, asked Culver City to join other area cities in opposing the project; asserted that desalination was the most expensive, energy intensive and environmentally harmful way to generate local water; expressed support for local water as well as efforts to reduce, reuse, recycle, and restore; discussed the decline of impact; electricity requirements for desalination; money already invested in the project; better options available; and he wanted the City to stop investments in carbon intensive projects.

Annelisa Moe, Heal the Bay, voiced concerns about the proposed desal plant; discussed negative impacts on the environment; energy use; CO₂ emissions; disruptions of ecosystems; discharge into the ocean; maintenance; costs; desalination as a last resort; capture and treatment of storm water; better use of resources; community projects; and she asked the City to oppose the proposed ocean desalination plant.

Craig Cadwallader, Surfrider Foundation, discussed partnerships with West Basin; expansion of recycled water usage; desalination used as a last resort; discharge from the Hyperion treatment plant; cooperation with the City of Los

Angeles; the timeframe involved; direct potable reuse legislation in Sacramento; encouraging West Basin to expand their use of recycled Hyperion water; and changes to technology.

Discussion ensued between staff and Council Members regarding extension of the due date; clarification that staff did not have a position on the matter; input from the Sustainability Subcommittee; the EIR for the Oil Field; what constitutes a valid comment; commenting with facts; political decisions vs. comments on the EIR; the process; clarification that there is no need to comment; the need to cite facts; and expressing views about the wisdom of the project vs. providing a technical response.

Discussion ensued between Council Members and Mr. Reznik regarding the response of other area cities.

Discussion ensued between Council Members and Mr. Deshmukh regarding formulating an informed opinion based on the facts; financial implications of city partnerships; utilizing less resource and energy intensive options; financial viability; strong experience of West Basin in recycled water and conservation; opportunity to expand; providing another supply of potable water; indirect potable reuse; the path to direct potable reuse; protecting public health; work with the environmental community; energy use; environmental impact; financial impacts; competitive supply; the focus on conservation; rain barrel programs; project objectives; the Water Replenishment District of Southern California; logical connections; the focus on desalination vs. other options; price per acre-foot; costs; greenhouse gas issues; the Greenhouse Gas Cap and Trade Program; appreciation for previous West Basin sustainability programs; goals established; Legislative and Policy Platform Water Conservation Water Quality and Air Quality Guidelines; multi-benefit thinking vs. siloed thinking; making informed comments without getting into technicalities; examining responses of other cities; the drought in Australia and reports from the Tree People; effectiveness of conservation; the ability to meet targets; addressing climate change; long term projections from West Basin; reductions to the amount of imported water purchased; the possibility of creating dams; storm water projects; creating local supply; promoting a conservation ethic; flood control dams; challenges in highly developed areas; West Basin support of research; uncertainty with other options; the data driven approach of West Basin;

application of a qualitative determination; stakeholder input; the EIR process; sources and what can be recycled; and imported water and ground water.

Further discussion ensued between staff and Council Members regarding greenhouse gases generated by moving water; placing the emphasis on conservation; prioritizing options; remaining open to desalination; analyzing the response of other cities; whether appropriate comments can be made on the EIR; the public agencies perspective; technical comments based on data and facts; the ability of the City Council to submit any comment deemed appropriate; the need for a consultant to assist in document interpretation; formulation of questions to submit as comments; the difficulty of challenging the EIR technically; a suggestion to submit a letter based on Sustainability Subcommittee stated policies; knowledge of the financial impacts before formulating an opinion; having the established policies in the City reflected in working relationships; responding to the EIR with questions; formulation of a letter; water security; water resiliency; City Council policy guidelines and sustainability goals; sea level rise; and coastal facilities.
