2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
3 CULVER CITY, CALIFORNIA, AMENDING RESOLUTION
4 2018-R015 TO MODIFY THE ALLOCATION OF
5 COMMERCIAL CANNABIS BUSINESS PERMITS, BY
6 REDUCING THE MAXIMUM NUMBER OF COMMERCIAL
7 CANNABIS CULTIVATION PERMITS BY TWO,
8 INCREASING THE MAXIMUM NUMBER OF PERMITS FOR
9 COMMERCIAL CANNABIS MANUFACTURING BY ONE,
10 AND INCREASING THE MAXIMUM NUMBER OF PERMITS
11 FOR COMMERCIAL CANNABIS DISTRIBUTION BY ONE.

12 WHEREAS, pursuant to the provisions of the 2017 California Medicinal and
13 Adult Use Cannabis Regulation and Safety Act ("MAUCRSA"), the City of Culver
14 City ("City") is authorized to adopt ordinances that establish standards, requirements
15 and regulations for the licensing and permitting of commercial medicinal and adult-
16 use cannabis activity; and

17 WHEREAS, on November 27, 2017 the City introduced an ordinance
18 amending Title 11, "Business Regulations", of the Culver City Municipal Code to add
19 a new Chapter 11.17 "Commercial Cannabis Businesses", also referred to as the
20 Culver City Commercial Cannabis Regulation and Safety Ordinance ("Commercial
21 Cannabis Ordinance"), which was adopted on December 11, 2017 with an effective
22 date of January 10, 2018; and

23 WHEREAS, Section 11.17.105 of the Commercial Cannabis Ordinance
24 provides that the maximum number of each type of commercial cannabis business
25 that will be permitted to operate in the City shall be established by Resolution of the
26 City Council; and

27 WHEREAS, on February 12, 2018, the City Council adopted Resolution
28 2018-R015, establishing the maximum number of non-storefront retail cannabis
business locations by business type; and

1 WHEREAS, the City Council desires to modify the allocation of
2 commercial cannabis business permits, to reduce the maximum number of available
3 permits for commercial cannabis cultivation, and increase the maximum number of
4 commercial cannabis permits for manufacturing and distribution.

5 NOW, THEREFORE, the City Council of the City of Culver City, California,
6 DOES HEREBY RESOLVE:

7 SECTION 1. Any terms used in this Resolution shall have the same
8 meaning as defined in the Commercial Cannabis Ordinance.

9 SECTION 2. The maximum number of commercial cannabis
10 manufacturing, cultivation, distribution, testing and delivery-only retail businesses
11 operating in the City at any one given time is set forth in Exhibit A, which shall
12 supersede Exhibit A to Resolution 2018-R015.

13 This Resolution shall take effect as of the date of its adoption. Approved
14 and adopted this __ day of July, 2018.



Exhibit A:
Maximum Number of Cannabis Business Locations by Business Type in Culver City
(Non-storefront retail)

The City of Culver City will issue up to the maximum number of permits by permit type as follows:

Permit Type	Maximum Number of Permits
Delivery-only Retail	5 ^{A,B}
Manufacturing	7
Distribution	7 ^B
Cultivation (Indoors)	1
Testing Laboratory	4

^ADelivery permits issued to a storefront retail cannabis business will not count towards this maximum number of delivery-only permits.

^BDistribution and/or delivery permits issued to a manufacturing permit holder (pertaining to its manufacturing business and on the same property) will not count towards the maximum number of distribution or delivery-only permits allowed.
