Corey Lakin, Parks, Recreation and Community Services Director, provided a summary of the material of record; discussed the process to engage a turf consultant; feedback from the community; changes to the municipal code; park prohibitions; potential recommendations; formation of an ad hoc subcommittee to examine all park prohibitions and codes; taking a wholistic view; signage; and funding.

Chair Zeidman invited public comment.

No cards were received and no speakers came forward.

Discussion ensued between staff and Commissioners regarding clarification that the code does not ban one specific sport; prohibitions on comparatively dangerous activities; park signage that points out that only soccer is not allowed; clarification that not every single regulation is posted; support for more comprehensive signage; funding for changes to signage; the comprehensive review; the fact that the signage was translated into Spanish; highlighting a sport not mentioned in the code; speculation on why certain actions were taken; background on the issue; specific issues at Culver West Park; determining how the ban was translated from one park to all parks; other adult sports prohibited at the parks; prohibition of activities unless played in specific areas; the difficulty of knowing the genesis of the policy; the right of the City to enact policy; direction from the City Council; the importance of information from the turf consultant; liability concerns; concern that Spanish speaking soccer players are being targeted; clarification that allegations do not make something true; concern with the use of cleats and players who refused to stop wearing them; other materials in the City that are translated into Spanish; the process to update the code; outdated provisions; a summary of written comments received from the public; differing perspectives; turf concerns; people who feel that their property is being disrespected; economic issues vs. social issues; waiting for the turf consultant before moving forward; people who expressed concern with the balls hitting their houses; waiting to address signage so that changes are not made twice; small parks in the community; the importance of updates to the prohibitions section; accommodating adult play; working with a partnership organization to manage play;

enforcement of rules; finding a way forward; finding affordable ways to engage young men; acknowledgement of the need to protect turf; and closing the parks to allow time for the turf to grow.

Commissioner Amezola read several Facebook posts about City signage prohibiting soccer in the parks and signage posted in Spanish.

Additional discussion ensued between staff and Commissioners regarding code review; getting the ball rolling regarding the prohibition section before the turf consultant is engaged; and a suggestion to consider creation of an ad hoc subcommittee together with item A-5.

Commissioner Amezola proposed a motion to recommend to the City Council that outdated signage in the parks banning soccer play be removed. Commissioner Rickards seconded the motion for the purpose of discussion.

Additional discussion ensued between staff and Commissioners regarding staff attempts to remedy park signage; removal of the offending part of the signage; the inadequacy of the signs; signage as the only leverage to enforce the ordinance; the difficulty of listing every prohibition; listing the most frequented issue on the signage; the feeling that any signage is better than none at all; support for Recreation Leaders; concern with allowing people to play adult soccer while signage is down and then later posting new signage disallowing it again; demonstrating responsiveness to resident concerns; and offensiveness of signage to a segment of the population.

Commissioner Amezola modified her motion to indicate that the Commission reserve making changes to signage pending recommendations from the turf consultant.

Additional discussion between staff and Commissioners included clarification that once the municipal code is updated, all park signage would be modified; consideration of which parks might be able to allocate space for adults to play soccer; concern with asking for a modification of signage based upon something that may happen in the future; the time frame for the turf consultant; the Request for Proposal (RFP) for the turf consultant; the need for City Council approval; providing an explanation

as to why a turf consultant is needed; inclusion in the City budget; and City Council awareness of issues.
