Reverend Carolyn Wilkins, Culver City Area Interfaith Alliance, discussed programming to support youth in the community; thanked Jim Clarke for bringing forth the idea for the Community Conversation; noted a potential grant from the Department of Mental Health; she proposed three subprograms under the idea of The Power of Community including: the Interfaith Peace Breakfast, a Youth Dialogue at the Teen Center in October and the Community Conversation; she distributed handouts; provided background on the Alliance; discussed challenges faced by youth; community engagement; reported increases to incivility, intolerance and polarization of young people; different types of bullying; education; goals of each planned event; engaging youth and their parents; and the intent to create a world of compassion, acceptance and friendship so that children feel connected, appreciated and safe in their own neighborhood.

Discussion ensued between Reverend Wilkins, staff and Commissioners regarding supporting materials for the upcoming events; clarification on how the Commission can support the Community Conversation; concern with securing sufficient youth participation; work with the school system; previous events; conversations with other faithbased organizations; format and location; potential funding for refreshments and outreach; dates; venue availability; awareness of any issues with bullying in Culver City facilities; training programs to prepare workers for various challenges at different City sites; mandated reporters; increased violence; mental health issues; access to guns; and scheduling.

Jim Clarke indicated the intent to have two Community Conversations, with one being at the Senior Center.

Discussion ensued between staff and Commissioners regarding Commissioner availability and availability of the Senior Center.
