Closed Session Report

Chair Daly Redholtz reported out the following statement: "After careful review of the evidence and thoughtful deliberation, the Culver City Civil Service Commission is deadlocked and unable to reach a decision on the appeal filed by the Appellant. As a result thereof, the Commission has decided, by unanimous vote, to grant the Appellant a new hearing to be conducted by a hearing officer. The hearing officer will deliberate and make a final decision in the case, consistent with Civil Service Rule 11.15.b. All evidentiary issues relating to the hearing before this Commission shall be determined by the hearing officer.

Counsel for the parties have advised the Commission, through its counsel, that they both stipulate to a new hearing before a hearing officer, and that the hearing officer's decision will be a final decision.

City staff is directed to work with the parties to select a hearing officer in accordance with City practices and take all actions necessary to expedite a new hearing."

Chair Daly Redholtz expressed thanks to fellow Commissioners, City staff, legal counsel, and both parties for their professionalism during the proceedings.
