#### Action Items

Item A-1

CAC - (1) Discussion Pertaining to Updating Culver City's Historic Preservation Program, Beginning with Updates to Chapter 15.05 of the Culver City Municipal Code Relating to the Historic Preservation Program; and, (2) Make a Recommendation to the City Council

Christine Byers, Cultural Affairs Coordinator, provided a summary of the material of record noting that additional information is available for anyone interested in learning more.

Discussion ensued between staff and Commissioners regarding Certified Local Government status; involvement of commercial property owners; specific concerns and challenges with regard to historic preservation; including a cross-section of property owners in the process; public outreach and education; whether architects and real estate professionals are to be invited to join the advisory committee; the vetting process; City Council discretion with regard to appointments; knowledge of the consultant hired; the need to update the Municipal Code; the California Environmental Quality Act (CEQA) process;

Secretary of the Interior's guidelines as pertain to historic preservation; ensuring that the City is in compliance; the amount of money involved; the importance of the outreach component; establishing a community advisory committee; public workshops; regular inquiries received about the existence of a Mills Act program in Culver City; neighborhood association representatives; the function of the subcommittee; diversifying voices that are part of the process; clarification that the consultant would draft the ordinance; input from the advisory committee; ensuring that the ordinance is specific to Culver City; approximate timeframe for completion; preservation consultants in the region; inviting members of large neighborhoods in the City without neighborhood associations to participate in the process; the General Plan Update; a Historic Preservation Officer; the Culver City Historical Society; volume of work generated pertaining to historic structures; whether the ordinance would cover objects, landscaping, or the site itself; preserving the integrity of the site; and clarification that an updated survey is not being proposed at this time, but rather, the task is to update the ordinance and the municipal code first thereby providing a framework and foundation for the program.

Hope Parrish, Culver City Historical Society, expressed appreciation to staff for their efforts; she expressed hope that the many people moving into the city would become active members of the community; and she wanted to see everyone included in the process.

Christine Byers, Cultural Affairs Coordinator, reported an upcoming meeting with staff and Culver City Historical Society representatives to discuss the project, with their comments to be added to the report going to the City Council.

MOVED BY VICE CHAIR PALI, SECONDED BY CHAIR WISNOSKY STEHLIN AND UNANIMOUSLY CARRIED, THAT THE CULTURAL AFFAIRS COMMISSION:

1. RECOMMEND THAT THE CITY COUNCIL AUTHORIZE STAFF TO ISSUE A REQUEST FOR PROPOSALS FOR CONSULTANT SERVICES IN CONJUNCTION WITH UPDATING THE CCMC AS PERTAINS TO THE HISTORIC PRESERVATION PROGRAM; AND

- 2. RECOMMEND THAT THE CONSULTANT'S SCOPE OF WORK INCLUDE DEVELOPMENT OF A MILLS ACT PROGRAM AND ADDRESS CRITERIA FOR CULVER CITY OUALIFYING AS A CERTIFIED LOCAL GOVERNMENT; AND
- 3. RECOMMEND THAT THE CITY COUNCIL DIRECT STAFF ON INCLUDING A COMMUNITY ADVISORY COMMITTEE INTO THE PROCESS AND DIRECT STAFF ON HOW THE MEMBERS ARE TO BE SELECTED.

Commissioner Williams reported attending an event at the Wende Museum and a salon at the Von Lintel Gallery; discussed the Culver City Art Walk; an upcoming exhibit at the Honor Fraser Gallery on October 19; and she announced the artist meet and greet on December 10 at the Walter Maciel Gallery on La Cienega for *Pretty Big Things*, a show that she is curating, running from November 3 - December 22.

Vice Chair Pali reported visiting the art collection for the largest pasta factory, Barilla, in Parma, Italy; he noted that his gallery at SPF:a had been open for the Art Walk; and he discussed the mobility conference.
