**Helms Avenue and Washington Boulevard Traffic Signal Timing and Update on Adaptive Traffic Control Project**

John Fisher, Consultant, provided a presentation on the Adaptive Traffic Control Project.

Discussion ensued between staff and Subcommittee Members regarding allowing more time for left turns; implementation; phasing; algorithms, timing adjustments; intersection performance; scheduling; integration; and costs.

Mayor Small invited public participation.

The following member of the audience addressed the Subcommittee.

Ken Mand discussed the light at Helms and Washington; he asked that the timing of the light be focused on the needs of the neighborhood between the 8:00 - 8:30 a.m. period; and he discussed affects to the Arts District.

Discussion ensued between Mr. Mand and Subcommittee Members regarding current conditions; the light at Cattaraugus; traffic movements; and congestion in the area.

Discussion ensued between staff and Subcommittee Members regarding restrictions on names that can be chosen; the process; the presence of a signal as a trigger; Westfield; creating a logic behind naming; and staff agreement to return with recommendations.

### **Culver City Rapid Aerial Transit Concept Overview**

Sydney Starrett, Ariel Rapid Transit Technologies, LLC, discussed their recent proposal for a gondola from Union Station to Dodger Stadium; clean air challenges in the Los Angeles basin; projects around the world; tourism; other potential sites; and she introduced the team involved in the project.

Project representatives discussed planning issues; technology involved; coordination with Metro; connecting Dodger Stadium to the regional transit system; reducing emissions; usage in other cities; safety; first/last mile; connections to activity centers; choosing the appropriate technology; ridership; costs; siting; public right of way; connectivity; handouts were distributed on other places where the system has been used effectively; capacity; different types of systems; stations; ancillary uses; tower height; adjacent areas; impacts; preliminary engineering profile; ridership goals; system capacity and ride times.

Discussion ensued between Subcommittee Members, project representatives and staff regarding public/private partnerships; keeping straight lines between stations; alignments; funding; state and federal monies; length of time to conduct the feasibility study; challenges; detachable cars; changing capacity; flexibility; comparative efficiency; cost per passenger; operating costs; carrying capacity; connectivity; and appreciation to Council Member Eriksson for pursuing the topic.

**Scooter Share Update**

Diana Chang, Senior Management Analyst, provided a presentation on Scooter Share; discussed the trial period; participation by Bird and Lime in Fiesta La Ballona, Art Walk and the GoHuman event; traffic citations issued; traffic collisions requiring a police response; photo enforced citations; scooter specific calls to the Fire Department; operator responsiveness; data received from Bird and Lime; utilization rates; correct parking; safety and access issues; consideration of other operators; disruption of service; options moving forward; and feedback.

Discussion ensued between staff and Subcommittee members regarding insufficient data received; average number of times per day that scooters parked on the sidewalk are used; the need for adequate dispersal throughout the City; length of usage; feedback; staff agreement to provide a copy of the presentation to Subcommittee Members and return with the agreement for the next meeting; the state bill; the option to extend scooter riding to streets with speed limits up to 35 miles per hour; defining which streets are allowed; flexibility; patterns; commentary on recommendations and the options available; the need to show significant improvement in communication and data sharing by the next meeting; other companies that have approached the City; a suggestion to interview other companies that could potentially take the place of Bird and Lime; efforts of Bird vs. Lime to share data; ensuring that Lime pays what Bird has paid; estimated costs; other potential operators; and different technologies.

**Experience Elenda Project Feedback**

Sanjana Mada, Bicycle and Pedestrian Coordinator, discussed the Experience Elenda project; La Ballona Elementary; the Culver Bicycle Path; cut through traffic; shared mobility; wide streets that invite more cars; navigation apps that direct people off regular routes; the need to change driving patterns; funding; outreach and engagement; community support for bike lanes on the east side of the street; parking reductions necessary with bike lanes on the west side; the Southern California Association of Governments (SCAG) Go Human demo; comments received at the September 8 SRTS Open House; the consultants; photo simulations; the temporary installation; the September 15-22 demonstration; the online survey; A-frames; the hotline; staff response to comments; the large volume of feedback received in the first two weeks; aggregation of the online survey with support of bikeways calculated to be 6; revision of plans to address issues including intersection sight lines; the inability to go fast on Elenda Street; increased traffic on Elenda Street and Culver Boulevard turning onto Elenda; incorporating feedback; and continued work with the community on the designs.

Discussion ensued between staff and Subcommittee Members regarding the 6 out of 10 rating; the bulb outs; Safe Routes to School; perception; curb extensions; school drop off; testing; and pending final results.
