# Discussion and Appointment of a New Ad Hoc Subcommittee Member to Review Certain Civil Service Rules

Serena Wright-Black, Assistant City Manager, provided a summary of the material of record; discussed rules that staff anticipated reviewing; additional research that needed to be done; Rule 11; the June 30 deadline; and Commission input on the approach to the remainder of the project.

Chair Daly Redholtz clarified that she had not asked to step down, but rather had suggested that stepping down might be the best option if there are meetings before July 1; she discussed the new Committee; whether any action is necessary; Brown Act concerns; and she noted that there was no need to make a change if there are no meetings held before July 1.

Discussion ensued between staff and Commissioners regarding scheduling; holding a meeting to advise subcommittee members on research and go over proposed language; efficiency; appointing a new person who would continue after July 1; a suggestion that Vice Chair Vera serve; and the process.

MOVED BY CHAIR DALY REDHOLTZ, SECONDED BY COMMISSIONER KUECHLE AND UNANIMOUSLY CARRIED, THAT THE CIVIL SERVICE COMMISSION APPOINT VICE CHAIR VERA TO REPLACE CHAIR DALY REDHOLTZ ON THE CIVIL SERVICE RULES REVIEW AD HOC SUBCOMMITTEE.

Additional discussion ensued between staff and Commissioners regarding review of the extension of eligible lists; including a set of criteria for which the Commission would say no; the ability of the department to negate the decision of the Commission to extend the list; consistency; and agreement to discuss the issue as part of the subcommittee.

Receive a Report from the Ad Hoc Subcommittee's Meeting with the City Council Equity Subcommittee Related to Creating a Human Relations Committee, and Provide Feedback to Staff If Desired

Chair Daly Redholtz indicated that she had asked that the item be placed on the agenda so that the Commission would be able to ask questions and provide feedback on the report.

Vice Chair Vera provided a report on the ad hoc subcommittee's meeting with the City Council Equity Subcommittee related to creating a Human Relations Committee; he discussed whether the body would be a Commission or Committee; scope of duties; overlapping responsibilities; indirect and direct conflict; transparency; opening up dialogue; providing a venue for people to air their differences; and concerns with adding to the staff workload.

Discussion ensued between staff and Commissioners regarding potential conflict or overlap; the Human Relations Workgroup proposal; employee privacy; community interest; support for providing a safe place for community members to share concerns; confidentiality; clarification that the proposal of the Workgroup does not affect how the new committee would work; communication with the Workgroup regarding constraints; length

of the process; clarification on the end goal of the group; whether a need exists to start a new body for this purpose; a suggestion that issues be considered as part of the Parks, Recreation and Community Services (PRCS) Commission rather than the Civil Service Commission; keeping issues separate; the proposal of the workgroup provided to the Commission and City Council; promotion of diversity and inclusion; community dialogues; alternative reporting options for complaints; expanding duties of the PRCS to include diversity; and staff noted that there were no additional meetings planned but agreed to relay comments to the subcommittee.
