PC: Consideration of Zoning Code Amendment P2019-0058-ZCA, Establishing "Corporate Housing" as a New Permitted Land Use with New Definition, Use and Development Standards, Amending Culver City Municipal Code (CCMC) Title 17: Zoning Code: Section 17.220.015 - Commercial District Land Uses and Permit Requirements, 17.320.020 - Number of Parking Spaces Required, 17.400 - Standards for Specific Land Uses, and 17.700.010 -Definitions

## Items from Planning Commissioners/Staff

Commissioner Voncannon reported on his experiences at Planning Academy; discussed legislative and budget updates; ambitious housing production goals set by the government; affordable housing tax credits; multi-family moderate income loan programs; emergency homeless funding; assistance for homeless individuals to access federal disability funds; streamlining California Environmental Quality Act (CEQA) requirements for homeless shelters; leasing space under Caltrans Rights-of-Way for homeless shelters; increased oversight of housing development for cities; reassessing and redistributing Regional Housing Needs Assessment (RHNA) needs and requirements for cities; the number of cities in California meeting their RHNA goals; additional funds

distributed to local agencies that meet unspecified milestones associated with advanced planning and housing to increase housing production; SB 35; local approval; Accessory Dwelling Units (ADUs); administrative approvals; single family homes and higher density homes close to transit; SB 50, up-zoning around transit; limits to single family zoning around transit; limited parking requirements; bonus incentives for low to moderate income housing next to transit; concern with taking away local control; SB 330 which prohibits down zoning; impact fees; reduced fees for affordable housing; the inability of a City to impose a moratorium; prohibiting design standards that are more costly than those currently in effect; a proposal to bring back redevelopment agencies; requirements to establish a redevelopment agency; he indicated that he would forward the presentation to Michael Allen, Planning Manager, for distribution; he discussed other sessions that he attended; and available resources.

Michael Allen, Planning Manager, discussed upcoming items to be considered by the Planning Commission and scheduling; the upcoming joint Commission/City Council meeting; and places to visit on the Planning Commission tour scheduled for May 17.

Sol Blumenfeld, Community Development Director, discussed new developments and how best to address them; examining existing developments on what has succeeded and what has not; and commercial abutting residential.

Commissioners discussed dates and availability.
