Item PH-1

PC: Conditional Use Permit Modification, P2018-0249-CUP/MOD to Allow Installation of a Multi-Purpose Playfield and Reuse of Storage Building to a Classroom Building at The Willows Community School Located at 8509 Higuera Street

Jose Mendivil, Associate Planner, provided a summary of the material of record.

Discussion ensued between staff and Commissioners regarding exterior work being done; clarification that the project is less intensive than originally proposed; the traffic study to take changes to the area into account since the school was originally approved; circulation look-back conditions;

changes to the area since 2012; the modification to the entitlement request; changes between Phase 2 and Phase 3; consistency; building geometrics; parking; compliance with the new ordinance; calculation methods; auto stackers; alternative parking provisions; adding flexibility in how temporary parking is accommodated; previously completed conditions; providing context; ensuring that lookback conditions are truly brought back for review; the traffic fee for improvements at Higuera; conformance for Phase 3 vs. Phase 2; and Fire Department access.

MOVED BY COMMISSIONER VONCANNON, SECONDED BY VICE CHAIR REILMAN AND UNANIMOUSLY CARRIED, THAT THE PLANNING COMMISSION OPEN THE PUBLIC HEARING.

Chair Ogosta invited public comment.

The following members of the audience addressed the Planning Commission:

Mark Armbruster, Armbruster, Goldsmith and Delvac, representing the Willows School, discussed the phased project; the multi-purpose play field; repurposing of the building; he pointed out that no increase in school footprint or enrollment over what had been previously approved was being requested; noted that Phase 3 had not been determined yet; discussed the need for a Conditional Use Permit Modification in the future for phase 3; necessary fundraising; staying within the parameters of the 2012 master plan; and letters of support submitted by neighbors.

Craig Jameson, Parallax Architects, provided an overview of the architectural plans and landscaping for the project.

Lisa Rosenstein, Head of School, discussed outreach efforts; community involvement; reduced reliance on Syd Kronenthal Park; and she saw the project as enhancing the overall neighborhood.

Responding to inquiry, Mark Armbruster discussed fire apparatus access.

Eric Lifshitz, parent of a Willows student and resident, expressed strong support for the project.

Zoenda MacIntosh, Willows parent and resident, expressed support for the project.

Susannah Funnell, resident and Willows employee, expressed support for the project and for the crossover between The Willows School and Culver City Unified School District (CCUSD).

Greg Seares, Willows parent and resident, expressed support for the project.

Mark Armbruster asked for flexibility with parking.

MOVED BY COMMISSIONER SAYLES, SECONDED BY COMMISSIONER LACHOFF AND UNANIMOUSLY CARRIED, THAT THE PLANNING COMMISSION CLOSE THE PUBLIC HEARING.

Discussion ensued between staff and Commissioners regarding appreciation for the public support of the project; whole child support; and timeframes within the conditions of approval.

Mark Armbruster discussed timeframes; dependency on fundraising; and allowing more time to accomplish Phase 3.

Discussion ensued between staff and Commissioners regarding the California Environmental Quality Act (CEQA) evaluation; ability to change timeframes; making amendments to phasing; and determining a realistic timeframe.

Mark Armbruster noted that adding three additional years to the timeframe for Phase 3 would be a realistic expectation; and he discussed ambiguity with Phase 2.

Discussion ensued between staff and Commissioners regarding the need to commence work within the timeframe; pulling permits for both Willows 6 and 7; adding flexibility with the word "or"; past experience; length of time between the phases; fiscal impacts; traffic studies; parking shortfall; and support for the projects.

Additional discussion ensued between staff and Commissioners regarding support of the project with the following modifications to conditions: item 4b, change "and" to "or" to read "Willows 6 or Willows 7" to provide more flexibility in completing Phase 2, modify item 4c, the applicant timeline,

to allow 8 years from the date of the phase 2 modification approval to commence demolition and/or construction work required to complete Phase 3, and for condition 73, indicate that automated parking or modified stacked parking or other means of offsite parking or onsite valet parking shall be required should offsite parking at 8511 Warner Drive become unavailable, instead of the originally worded automated parking only requirement.
