




1- How often do you use the Ballona Creek path currently?





2- Select each way you use the Ballona Creek path currently:







Summary of Survey Comments

The table below summarizes the number of respondents in favor of opening the Jackson's Avenue gate, against the gate opening, or neutral.

In Favor	Against	Neutral
Convenient/safer access: 76	Environmental threats: 13	20
Reduce crime: 6	Traffic/traffic safety: 27	
Conditional requests: 10	Increase crime/disturbance: 28	
Community enrichment: 19		

Description of Stated Reasons under “In Favor”:

- Convenient/safer access: To facilitate students' commute to/from school, community's access to the Jackson Market and other businesses, speed emergency response, and help avoid busier and less safe streets such as Overland Avenue and Duquesne Avenue
- Reduce crime: More people with access will lessen the potential for crime (safety in numbers)
- Conditional requests: To improve pedestrian and bicycle access, but the gate has to be closed at night and early morning
- Community enrichment: Opening the gate will encourage healthy lifestyle, access to nature, and promote community interactions

Description of Stated Reasons under “Against”:

- Environmental threats: Facilitate coyotes access and disposal of trash
- Traffic/traffic safety: Will cause congestion and increase potential of cyclists getting hit
- Increase crime/disturbances: The community will be negatively impacted by the increase in drugs, homeless access, crime, and noise

Description of Stated Reasons under “Neutral”:

- Unaffected or don't care
