Mayor Sahli-Wells acknowledged the impact of Dr. Sarah Carpenter on Culver City and reported attending her memorial; she discussed the County Board of Supervisors agenda item on the fate of the old Courthouse; the eviction of the Mayme Clayton Museum; the lack of public process; public land; ways to comment and/or participate; the rent freeze; she reported receipt of a petition for a ballot measure to require that renter protections would have to go to a public vote before being voted on by the City Council and she received City Council consensus to agendize a discussion of the proposed ballot measure; she discussed rental protections passed by the state of California and the governor; and she announced the passing of Community Library Manager, Laura Frakes.

Mayor Sahli-Wells invited public comment.

The following members of the audience addressed the City Council:

Kathryn Guerra, Culver City Youth First Tobacco Coalition, shared her concerns about flavored tobacco; discussed her efforts with the Coalition; the harms of hookah; normalization of usage; ease of underage access; and she asked that access of flavored tobacco products be restricted.

Marcos Rodriguez, Culver City Youth First Tobacco Coalition, expressed concern with the teen vaping epidemic; discussed Centers for Disease Control (CDC) findings; increased hookah and e-cigarette usage; the lack of age requirements for hookah lounges; enforcement; negative affects to health; misperception; and he cited the importance of stopping youth access.

Sarah Lee discussed e-cigarettes and tobacco use; the epidemic of e-cigarette use; smoking indoors; the fact that use of ecigarettes is less noticeable than regular cigarettes; new forms of electronic hookah smoking; and she asked for a sales restriction to protect the health of the community and specifically youth.

Rica Blanks, Culver City Youth First Tobacco Coalition, voiced concern with flavored tobacco and hookah; discussed the growing number of addicted youth; the high prevalence of hookah use among youth; the perception that hookah is less dangerous; and she asked that the community be protected.

Isaac Hong, Culver City Youth First Tobacco Coalition, discussed the importance of prohibiting hookah usage in Culver City; health risks; cancer causing chemicals; passing infection to shared users; socializing; and he thanked the City Council for their consideration. Evelyn Balderas, Culver City Youth First Coalition, discussed her work with students at schools; students who want to know why drugs that are harmful are legal; accessibility; increased hookah use; and she asked that the flavored tobacco ban ordinance be passed.

Monty Messex, Los Angeles Department of Public Health, Tobacco Control and Prevention Program, provided a handout on Hookah Myths and Realities; presented information regarding flavored tobacco products and tobacco retail licensing; he discussed warnings from the Federal Drug Administration and US Surgeon General warnings about the way flavored tobacco products help new users get started and lead to long term addiction; the youth vaping epidemic; menthol cigarettes; youth initiation; prohibition of cessation; relapse; hookah smoking; actions of other area cities to regulate the sale of flavored tobacco; and actions of the county of Board of Supervisors.

Discussion ensued between Mr. Messex staff and Council Members regarding other ordinances; the carve out for hookah in the City of Redondo Beach; phase out provisions; whether all hookah tobacco is flavored; clarification that onsite consumption of flavored tobacco would be prohibited as it would be sold; compliance with the California Smoke-Free Workplace Law; requirements to be a tobacco shop; the definition of a sale; age restrictions; enforcement; licensing; inspections; the annual survey; statistics indicating the amount of tobacco products sold to underage users; internet sales; jurisdiction; state authority; retail presence; carve outs in Beverly Hills; and the California Department of Fee and Tax Administration.

Hilicia Guerra, Culver City Youth First Tobacco Coalition, discussed the number of deaths annually attributed to smoking

and tobacco use; current trends; underestimation of risks; addiction; popularity of hookah bars and cafes and increased usage; availability of friendly flavors; hookah as a gateway; misinformation about the risks; and increased nicotine and carbon monoxide exposure with hookah use over tobacco use.

Lydia Lising, Culver City Youth First Tobacco Coalition, discussed recent tobacco prevention efforts in Culver City and she provided highlights of the resolution passed by the Culver City School Board in support of protecting young adults from flavored tobacco products.

Charles J. Smith, American Cancer Society Cancer Action Network Volunteer, provided background on himself; introduced the president of the Culver City Kiwanis Club; applauded the City for their efforts; discussed increased use of flavored tobacco; the teen epidemic; efforts designed to target youth and addict them; and he asked the City Council to support a ban.

JJ Jenkins provided background on himself; discussed a campaign of misinformation; vaping hysteria; closure of his stores; the feeling that actions to ban flavored tobacco are hypocritical if cigarettes are not targeted as well; funding of the nonprofits by cigarette taxes; decreases to rates of smoking; promotion of smoke-free living; and the normal actions of kids to experiment with risky behaviors.

Mayor Sahli-Wells received clarification the that proposed ban is on flavored tobacco whether it is smoked traditionally or vaped including menthol cigarettes, but that vaping itself is not targeted therefore non-flavored vaping and non-flavored tobacco are not affected.

Spencer Lyons, American Cancer Society Cancer Action Network, discussed their commitment to eliminate cancer as a major health issue; expressed support for efforts to end the sale of flavored tobacco, including menthol in Culver City; provided statistics regarding youth tobacco use; encouraging a generation of tobacco-free kids; and he expressed support for a ban on the sale of flavored tobacco without restrictions.

Jane Steinberg, USC Public Health, expressed support for the commitment of the City to protect public health; discussed growing health concerns related to the rapid increase of multiple types of tobacco products among youth; the perception that hookah use is mainly by those over 21 years old; recent data indicating that hookah and water pipe tobacco use had the highest prevalence; the perception that hookah is a harmless water vapor; measurement of air pollution from hookah bars and lounges; clarification that hookah smoking has many of the same health risks as cigarette smoking; and she expressed concern with allowing the continued sale of flavored tobacco products for 21 and over establishments as that loophole could undermine the whole purpose of the flavor restriction.

Dr. Tomas Torices, American Academy of Pediatrics in Southern California, provided background on the organization; expressed support for a ban on flavored tobacco products including menthol; discussed nicotine addiction in youth; statistics indicating increased usage; the generational impact; the campaign for Tobacco Free Kids Coalition; he distributed a letter of support for the ban; and he provided suggested language to address loopholes caused by a carve out that resulted in the creation of new establishments in Oakland.

Jaime Rojas, National Association of Tobacco Outlets, provided statistics; discussed jurisdictions; the existing prohibition of the sale of tobacco to those under 21 years of age; levels of code enforcement and education; retailer sting operations; internet sales; purchase of products by adults for their children; and he asserted that those areas that have prohibited sales have seen an increase in usage.

Amer Algazairy, Blow Hookah Lounge; asserted that the flavored tobacco ban would negatively affect the business and community; provided background on the business; indicated that he would be out of a job if the ban is enacted; he asserted that he had never allowed anyone under 21 years old to enter the facility; discussed the average age of patrons; he did not think underage hookah smoking was an issue in Culver City; and he discussed benefits of hookah smoking.

Linda Becker, Nirvana Smoke and Gift, provided background on herself and her business; discussed policies for admission to her business; asserted that she had never sold to minors or had any issues; felt that her business provided a service; she expressed support for small businesses; and she indicated that she would adhere to any new verification systems required.

Courtney Hamilton, California Association of Responsible Retailers, expressed support for stopping those under 21 from smoking tobacco products; discussed ways to stop youth from using tobacco products; the need for public education and a rise in excise taxes; expressed support for restrictions on TRLs and for a tobacco ban on places of sale that are not 21 and over; the last line of defense between youth smoking and access; online providers; and forums dedicated to vaping.

Andrew Mikthaniel, Blow Hookah Lounge, discussed his business; underage vaping concerns; age requirements for admission; allowing adults to engage in risky activities at their discretion; he asserted that his business had never violated any laws or ordinances; reported that he was not selling or promoting tobacco to users outside of his business; he asserted that the ban would amount to discrimination; he asked to the grandfathered in; expressed concern with statistics being cited against hookah; and he asked the City not to shut down his business.

Ihab Alshekh provided background on himself; asked for an exemption for age restricted businesses; noted the threat to his livelihood; discussed potential losses beyond lease and inventory; internet sales; dispensaries; diligence with refusal to sell to anyone under 21 years of age; and he asked to meet with staff.

Shonte Powers spoke representing the hookah community; asked for an exemption; discussed tradition; and she urged the City Council to stay focused on the current crisis and exempt hookah.

George Jonson clarified that unflavored hookah tobacco does not exist; discussed the exemption granted in SB 38; the exemption in Burbank, El Cajon and Redondo Beach; and he stated that traditional hookah smokers are not habitual.

Morris Pouldar asserted that his service station would be negatively impacted by the ban; felt that revenue would be pushed out of town and that products would be purchased somewhere else; discussed internet purchases; he questioned what would be achieved by banning retailers from selling flavored tobacco; he did not want to lose existing customers; discussed products harmful to children that are getting into schools; the need to consider the whole picture; taking responsibility; and he asserted that his business did not sell to under age users.

Josefina Diaz read part of the City's mission statement; thanked the City Council for their dedication and service to the community; questioned what changes could be made in the community and beyond; discussed grandfathering in establishments; and standing behind quality of life for the people in the City and for the future. Jeremy Green, City Clerk, read written comments submitted by:

Discussion ensued between staff and Council Members regarding variables to consider including the effective date, hookahs, and the amortization period for adult only use; exemptions; existing vs. new businesses; making a difference in the City; education; limiting rather than expanding; posting required notices about dire health affects; the concentration of nicotine, metals and chemicals in flavored vaping products; becoming part of a response to growing nicotine use; stopping addiction before it starts; the explosion of youth smoking; overall public health concerns; reducing access and normalization; including menthol in the ban; clarification that e-cigarettes would not be not banned, just flavored tobacco; whether to grandfather in the one hookah lounge in the City; cultural aspects to consider; adult cigar shops; monthly revenue from flavored tobacco at tobacco stores; the timeline; inventories; length of lease; being clear on the goal of the ban; FDA regulation of flavored vaping products; changes at a national level; the internet; making a real change vs. sending a message; existing operators; lung issues related to people who vape THC; allowing cannabis in Culver City; consistency; logic; allowing adults to make choices with legal products; effective restrictions for those under 21; negligence of the FDA; deaths related to vaping; the pull out of big tobacco from the San Francisco ballot measure; paid advocates from big tobacco; the importance of addressing the crisis; the need to act; grass roots, community driven public health; concern that statements indicating that there are health benefits to vaping are not science; unregulated additives in vaping; ensuring that ownership does not keep turning over if an exemption is granted lounge; providing a lookback provision; to the hookah enforcement; concern with driving more use to hookah; making sure the hookah exemption is really a cultural exemption and not just a loophole; allowing a longer period of time to phase out tobacco only age restricted shops; the ability for parents to control internet purchases; concern with increased usage by youth; the Youth Reinvestment grant; the need for additional education; addressing the real issue of using flavors to addict

children; poisonings; cities that are going farther than what is being proposed; acknowledgement that smoking is not healthy; the need for a more robust program to get the message to youth; assurances from the stores that they do not sell to underage users; concern with financial obligations for the businesses; accommodating the smoke shops; the period of time that the county allowed businesses to sell existing inventory; signage for hookah lounges; having a separate amortization for adults only establishments; the recent addition of flavored vaping products and inherent risk with investment; banning vapor products with THC; concern with making things worse; vaping as the second most common way of ingesting cannabis; information from the public health sector; nicotine based vapes leading to cigarette use; and people with chronic pain conditions.

Additional discussion ensued between staff and Council Members regarding the exemption for the hookah lounge for onsite consumption only, with follow up to ensure that there is no presence of any minors on the premises and that an uptick in use is not being seen overall; moving forward with the ban on flavored tobacco; establishing a standard of identification control and access in and out; concern with allowing a period of more than a year; effects of a flavor ban on the smoke shops; stores that existed before vaping; business tax certificates; allowing time to introduce new products and build revenue; revenue percentages to qualify as a tobacco store; concern that people do not realize that hookah is dangerous; ensuring that people do not believe hookah is somehow healthier; perception issues; and additional information and data points.

Heather Baker, Assistant City Attorney, read back the proposed components for the ordinance: including an exemption for the existing hookah lounge with the existing owner and language to ensure that it does not transfer ownership; existing tobacco stores will be given a 12-month amortization period; tobacco retail stores will be given 180 days before the flavor ban takes affect; and a 12 month look back on the operation of the hookah lounge.

MOVED BY COUNCIL MEMBER LEE, SECONDED BY COUNCIL MEMBER SMALL AND UNANIMOUSLY CARRIED, THAT THE CITY COUNCIL INTRODUCE AN ORDINANCE AMENDING CERTAIN PROVISIONS OF CHAPTER 11.15, TOBACCO RETAILER LICENSING, OF THE CULVER CITY MUNICIPAL CODE TO PROHIBIT THE SALE OF FLAVORED TOBACCO PRODUCTS, INCLUDING MENTHOL WITH OPTIONS AS STATED.
