Revised Classification Specification: Training and Safety Instructor

Serena Wright-Black, Assistant City Manager, provided a summary of the material of record and she welcomed the new Chief Transportation Officer, Rolando Cruz.

Discussion ensued between staff and Commissioners regarding consistency; agreement to change "and/or" to simply "or" under Essential Job Duties; clarification that classification specifications are not intended to be detailed job descriptions or outline every job duty, task or function; supervisor discretion; clarifying the statement that "...incumbents may not be called upon to provide all the tasks or may be required to perform similar tasks..." to make it clear that the City has the option, not the employee; Commission agreement to incorporate the change; concern with consistency of tense throughout the document; the bargaining unit representation section; reassignment of the classification; concern with additional

liability for the City; clarification regarding the assignment of positions to bargaining groups; level of responsibility; policy development; consistency of benefits; deferred compensation; clarification regarding the impetus for change; factors considered on the EER; Commission purview; Safety Management Standards and requirements; changing technology; salary; and clarification that the position is currently vacant.
