Public Comment - Items Not On the Agenda

Chair Guzzetta invited public comment.

The following member of the audience addressed the Fiesta La Ballona Committee.

John Cohn, The Exchange Club, thanked the Committee for helping facilitate the event; discussed the new location for the Beer and Wine Garden; positive feedback; tree roots; the increased variety of beer offered; and lighting.

Discussion ensued between Mr. Cohn, staff and Committee Members regarding the Kiwanis Fundraising Breakfast; costs; profit; 2018 vs. 2019; the donation of beer from Firestone Walker; the issue of shortages on two nights; under estimation of demands; the promised delivery that did not arrive; concern with overbuying and waste; a request for a revenue breakdown by night; wine margaritas; the amount of money given to Fiesta La Ballona; profit sharing; other Exchange Club events; revenue from year to year; the unsuccessful Beer Garden at The Car Show; use of money raised by The Exchange Club; previous discussions about having a percentage of revenue shared; the increase in the rental fee; figuring out the correct amount to charge for the space rental; partnering with the City; sharing risk; the kids and family part of Fiesta La Ballona, vs. the music and the Beer Garden part of Fiesta La Ballona; the feeling that the Beer Garden is member driven; enthusiasm and donations; the partnership with Public School; creating community; hosting vs. serving; money and effort put in by the City to upgrade the Beer Garden; concern with the loss incurred by the City; concern with the low numbers reported back from the Exchange Club; assistance from the City in bringing costs down; freebies; loss leaders; reliance on the donated beer; the fact that adequate supply had been promised by the Exchange Club but not delivered; lighting; benefits provided; the need for a more fair remuneration; the historical basis for the charge; costs for supplies; increased costs to meet the City requirement for sustainable supplies; additional décor; the Beer and Wine Garden subcommittee; and the common goal for a successful community event.

Discussion Regarding WIFI at Fiesta La Ballona 2020

Discussion ensued between staff and Committee Members regarding temporary WiFi at events; the difficulty of covering the entire area; the app; the need for internet connection; Spectrum; working out a trade for bandwidth handoff; difficulties with internet at Vets; the City-wide fiber network; providing a backup system; costs; sponsorship; the timeline; verification from the Information Technology (IT) Department; bandwidth; connectivity; equipment; T-Mobile sponsorship; and staff agreement to move forward once additional information is provided.

Consideration of a "Taste of Culver City" Event for Fiesta La Ballona 2020

Discussion ensued between staff and Committee Members regarding branding; restaurants with trucks in Culver City; food trucks vs. food booths; size of the event; Health Code requirements; highlighting Culver City restaurants in an enclosed event on Friday evening or Sunday; finding restaurant vendors; time, expense, energy and logistics; having an event inside an event; taking things one step at a time; highlighting local vendors in a special area; moving away from tents; enhancing the Beer Garden area; licensing requirements; access; adding food into the Beer Garden; wrist bands; expanded access; trucks that can serve both on the Beer Garden side and the regular side; extra space taken by food trucks; food carts; having a separate event on Sunday morning; willingness of restaurants to do an offsite event; type of compensation; drop off catering; music; licensing; layout; supplies; re-stocking; the number of people who could be accommodated; price to get in; a suggestion to start with one vendor in the Beer Garden for a Champagne Brunch;
