Item A-1

**CAC – Consideration of a New Permanent Mural Concept by Andrew Antonaccio (2Alas) Toward Fulfillment of the City's Art in Public Places Program Requirement for a Development Project at 11924 Washington Blvd. (Haven)**

Christine Byers, Cultural Affairs Coordinator, introduced the item; provided a summary of the material of record; discussed outreach; communication with a neighbor regarding the item; and she read comments submitted by Vice Chair Pali and Commissioner Fleischer.

Chair Wisnosky Stehlin invited public participation.

The following member of the audience addressed the City Council:

Beau Basse, LeBasse Projects, provided a presentation on the Haven Project.

Discussion ensued between Mr. Basse, staff and Commissioners regarding using public art monies to make a statement; materials; structural design; the subcommittee recommendations; broader concerns about the ordinance; safety; siting of the canopy; design; accessibility; clearance; meeting the public art requirement for the site; making an impact with the mural without being distracting to drivers; concerns noted by Vice Chair Pali; the combination of the canopy and the mural; the desire to challenge the status quo through art; approval of the mural on the condition that the developer brings back the concept for the canopy; the process; the proposed timeframe for completion; concern with the ability of the applicant to write a check rather than fulfill the art requirement; clarification that if the art concept for the canopy is not approved and completed, approval of the mural is rescinded; and applicant agreement to revised wording of the staff motion.

Discussion ensued between Mr. Basse, staff and Commissioners regarding concern with piecemeal consideration; frustration with instruction from the subcommittee to bring the mural forward; consideration of the two pieces separately; allowing work to begin on the mural while the canopy is designed; voting without all Commissioners present; meeting requirements of the ordinance; guaranteed votes; faith that the applicants will complete the project; context; other developments in the City; required infrastructure; delays on both sides; the developer's desire to begin activating the site; revisiting the Art in Public Places Program ordinance; the Ivy Station project; and future delineation that projects are not to be considered piecemeal.

Toward Fulfillment of the City's Art in Public Places  
Program Requirement for Ivy Station**

Christine Byers, Cultural Affairs Coordinator, provided a summary of the material of record; noted comments previously read from Vice Chair Pali and Commissioner Fleischer; and she read correspondence received about the item.

Chair Wisnosky Stehlin invited public participation.

The following member of the audience addressed the Commission:

Beau Basse, LeBasse Projects, provided a presentation on the project.

Discussion ensued between Mr. Basse, staff and Commissioners regarding location; visibility; accessibility; coordination with other art concepts on the property; diversity; the glass and steel perimeter; lighting; public art in private spaces; concern that the art will just seem to be part of the hotel's design; marketing; finding hidden opportunities; meeting requirements; approval of the concept conditioned on appropriate lighting and ensuring that City visibility requirements are met; artificial light vs. daylight; activating the space; requirements of the City of Los Angeles; planned educational programming; and the Los Angeles Department of Cultural Affairs component of the project.
