A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CULVER CITY, CALIFORNIA REAFFIRMING AUTHORITY DELEGATED TO ITS CITY MANAGER AND ASSISTANT CITY MANAGER TO DETERMINE WHETHER A LOCAL SAFETY MEMBER IS DISABLED FOR RETIREMENT **APPLICATIONS PURPOSES** AND TO MAKE RETIREMENT BEHALF OF ALL DISABILITY ON EMPLOYEES, AND RESCINDING RESOLUTION NO. 2015-R072.

WHEREAS, the City of Culver City ("Agency") is a contracting agency of California Public Employees' Retirement System ("CalPERS");

WHEREAS, the Public Employees' Retirement Law ("PERL") requires that a contracting agency determine whether an employee of such agency in employment in which he/she is classified as a local safety member is disabled for purposes of PERL, and whether such disability is "industrial" within the meaning of PERL; and

WHEREAS, Agency's City Council has determined upon legal advice that it may delegate authority under Government Code Section 21173 to make such determinations to the incumbents in the positions of Agency's City Manager and Assistant City Manager.

NOW, THEREFORE, the City Council of the City of Culver City, DOES HEREBY RESOLVE as follows:

1. The City Council of the City of Culver City hereby reaffirms the authority delegated to the incumbents in the positions of Agency's City Manager and Assistant City Manager authority to make applications on behalf of Agency, pursuant to Government Code Section 21152 (c), for disability retirement of all employees, and to Initiate requests for reinstatement of such employees who are retired for disability.

1	2. The City Council of the City of Culver City hereby reaffirms the
2	authority delegated to the incumbents in the positions of Agency's City Manager and
3	Assistant City Manager authority to make determinations of disability on behalf of the
4	Agency under Government Code Section 21156 and whether such disability is
5	industrial, and certify such determinations and all other necessary information to
6	CalPERS.
7	3. The City Council hereby rescinds Resolution No. 2015-R072.
