To Whom It May Concern:

Thank you for informing and updating us about the Corona Virus and for changing some rules to our benefit, such as making parking restrictions more flexible.

In this time of crisis, illness, death and uncertain future, it is even more unfathomable that the purchase of the Ballistic Engineered Armored Response Counter-Attack Truck is being considered.

Since the community meetings I have learned that since 1994, the LA County Sheriff's department has provided SWAT services to CCPD eight times and that for free! The Sheriff's SWAT teams are on standby 24/7/365.

I also learned that CCPD has not complained about the Sheriff's SWAT services, and that the CCPD is unable to show that there would have been less harm if the SWAT team had arrived earlier at the scene.

You want to spend so much money to militarize the police for a "service" that was needed eight times in 16 years. We got it for free and we did not complain – the Sheriff's department did a good job helping us.

Additionally, I really don't think a Ballistic Engineered Armored Response Counter -Attack Truck will be of that much help in a shooting. First, they won't be on the scene when the shooting starts and won't be most likely not be there until it ends. Secondly, the person inside the Ballistic Engineered Armored Response Counter-Attack Truck still has to go outside to save the people. And – in case the shooting is still going on – the people trying to get into the Ballistic Engineered Armored Response Counter-Attack Truck can still be shot.

In order to convince us to spend that money for the Ballistic Engineered Armored Response Counter -Attack Truck, the CCPC used the same cases for needing the Ballistic Engineered Armored Response Counter-Attack Truck as they used for the drones. This undermines my trust tremendously; they told us about their need for drones while they already knew they want more military objects. Which military tool do they request next or have already done so?

The poorly written policy draft written by CCPD is not professional. They want to use the Ballistic Engineered Armored Response Counter-Attack Truck during "illegal" demonstrations – while they are the ones who can declare the demonstration illegal. They can use the water cannon against us, or – maybe even worse – could it be that they already asked you for weapons to use in their Ballistic Engineered Armored Response Counter-Attack Truck since they are on a shopping spree for buying military objects?

I attended the budget meeting between CCPD and the council, and I did not hear the exact monetary requests of the police. Additionally, I wish my job evaluation meetings were that easy! I can present to my boss how great I am, and the boss agrees, gives me compliments, and is willing to give me everything I want. Is there not a third party who actually evaluates the job performance of the CCPD? (I recall that we asked for an oversight

committee and we did not get any response). And when will the exact dollar amounts be allocated to the CCPD? Was that budget meeting purposely done in a way, so we don't hear how much money they want for what? I learnt that CCPD consumes 35% of our budget, compared to 16% in Los Angeles and 29% for police AND fire department combined in Santa Monica. Why is that? Is it because we could not shake off our history of white supremacy and being a sundown town?

There are still many open questions and I am convinced that we need to change the culture and structure of our police. The answer of CCPC was evasive when asked about their involvement in the Culver City general plan. I hope that this dangerous and deadly crisis we are in right now will help us to refocus and show to us what is important in life.

Dear Elected Officials,

I am writing in response to the Emergency Hospitality Ordinance which was presented to and heard by Culver City Council last week. Having listened to the live stream I would like to take this opportunity to provide comment to some misinformation and inaccuracies.

I would like to lead by posing a few questions

- 1. What grounds and or evidence is there for the sudden concern in reference to Hotel cleanliness standards?
- 2. Was any field research completed? For example an outreach to Hoteliers to better understand standard operating procedures.
- 3. Why are Hotels being singled out? Why are these proposals not being applied to all commerce?
- 4. Should these mandates not be expected to be implemented by Cal-OSHA rather than City Council?
- 5. Are these proposals permanent or time restricted?

Suggestions that there are going concerns in reference to cleanliness could not be further from the truth. Both before and during the pandemic the PaliHotel Culver City has prided itself on maintaining a 5 star cleanliness rating on Trip Advisor. A feat which has been achieved through our not having mandated workloads but having a holistic approach to maintaining the highest standards of cleanliness. In response to the onset of Covid-19 we acted quickly at the start of March with measures that included but were not limited to the provision of disinfecting wipes to support our Housekeeping Associates in ensuring that they are able to disinfect 'high hand-use traffic' areas such as doorknobs, faucets, TV remotes and telephone handset to name a few. Standard operating procedure has always been for the Room Attendant to wash their hands as a final step to completing the guest room bathroom clean, the disinfecting wipes are also available for them to use on their hands as an added measure.

I would also like to comment on a specific statement made by Councilmember Lee suggesting that there is no "economic impact" by these proposed measures. There are in fact a number of significant costs which we at the Palihotel would have to absorb if the stated proposals are put into place as is, this number could be in the region of \$4,000 per month, a major additional expense for a boutique hotel with only 49 keys. More concerningly, in addition to these tangible expenses is the undeniable added exposure to frivolous EPLI claims in relation to adding the proposed handwash breaks which can be in the tens of thousands of dollars or more, not to mention the payroll man hours that goes into defending them. Time which I am sure you would agree could be better spent in pursuing ways to drive more business through our city.

In closing, we at Palisociety, in partnership with Hotel Ownership; remain committed to further discussion and refining of these proposals to best position the City of Culver to recover quickly from both a labor and fiscal standpoint.

EMERGENCY ACTION PROPOSALS FROM HOSPITALITY WORKERS RESPONDING TO THE CORONAVIRIS OUTBREAK

1. PREVENTION: HAND WASHING AND SICK DAYS

- Mandate that all Event Center and Hotel employers give employee an extra 15 minutes of break time every 4 hours for washing hands and sanitizing.
- In hotels, housekeepers should have an affirmative reduction in workload equivalent to 30 minutes of work (typically one "room credit"), and must not be penalized if they do not complete daily room cleaning quotas, so that they are able to perform thorough cleaning and have time to frequently wash their hands. Together, this means three legislative actions: A. Suspend room quotas for hotel housekeepers until further notice, B. mandate that all housekeepers be given a break after each room to wash their hands and disinfect, C. permanently reduce room quotas by 1 credit if the room quota is normally 16 or less, and by two credits if the room quota is more than 16.
- Event Center and Hotel employers should provide a minimum of 10 sick days per year to employees, which the Cities of Los Angeles and Santa Monica already have (LA has 12 and Santa Monica has 9).

2. CONTROL LAYOFFS

- Protect workers with fair layoff and recall by seniority rights, so laid off workers are ensured a job when the crisis subsides. See Santa Monica Municipal Code Section 4.66.10 et seq.
- Adopt a "just cause" provision to prevent unscrupulous managers from trumping up reasons to fire workers. *See* Philadelphia Municipal Code Section 9-4700 et seq.
- Adopt worker retention to protect workers through bankruptcy and subcontracting. See Santa Monica Municipal Code Chapter 4.67.050; Los Angeles Municipal Code Section 183.00 et seq.

3. TRAINING: CENTRALIZE PUBLIC HEALTH TRAINING FOR HOSPITALITY WORKERS

• All housekeepers and cooks in Event Centers and Hotels should be trained on public health by a single non-profit authority not controlled by employers. A model is the "public housekeeping" training law adopted last year by the City of Santa Monica. *See* Santa Monica Municipal Code Section 4.67.060

4. ENFORCE AND STRENGTHEN SHORT TERM RENTAL LAW, WHICH WILL OUTLAW ILLEGAL HOTELS MULTI-UNIT BUILDINGS

• Public safety measures in the hospitality industry are not meaningful if a significant part of our hotel units are being run through illegal, unregulated operators. This is especially true when short-term rental businesses occupy entire buildings or multiple units in a building and take over rent controlled units, which are often in larger, denser buildings.

Dear Hon. Mayor Sahli-Wells and Members of the Culver City Council:

At tonight's Special City Council meeting, the Council will consider adoption of a resolution confirming the Second Supplement to the Public Order. As you consider adoption of the resolution, we urge the City Council to implement a more balanced approach. The residential eviction moratorium should be narrowly tailored to specifically address the financial impacts associated with the COVID-19 pandemic resulting in renter's loss of income and inability to pay rent in line with the Governor's Executive Order. The Council should not adopt broad-based, expansive limitations on other "just cause" evictions where there is no correlation to COVID-19. Further, the provision allowing the City to "order suspension of the eviction process" is unconstitutional and improper. It is over-reaching the City's authority by empowering the City to usurp the Judiciary and the Court's authority over evictions and related disputes.

The global Coronavirus (COVID-19) pandemic has in an instant fundamentally changed all our lives and the future remains unknown and uncertain. As the Apartment Association of Greater Los Angeles (AAGLA) has repeatedly stated, the multifamily rental housing business, much like a multitude of industries, small businesses and the individuals whose livelihood are dependent upon those industries have, through no fault of their own, been detrimentally impacted by the COVID-19 pandemic. AAGLA continues to urge the City Council to take a holistic and balanced approach in recognition of the detrimental impacts of COVID-19 on **both** the City's residents and businesses, all of whom need financial support during this most challenging time.

I sent an email earlier today requesting specific language to be added to the proposed revised Eviction Moratorium public order. Language proposed in this email is in addition to my earlier request.

I request adding additional language that is consistent with the Los Angeles County March 31st Executive Order:

Renter Notice Requirement:

The Order requires the renter to provide notice to the owner of their inability to pay rent, within seven (7) days after the date that rent is due, unless extenuating circumstances exist.

Repayment Period:

The Order provides renters with six (6) months following the termination of the Executive Order to pay the owner any amounts due. Renters and owners are encouraged to agree to a payment plan during the six (6) month period following the expiration of the Order.

Taken together, this request along with my prior request, addresses all of my concerns with the proposed revised Eviction Moratorium order.

My name is Meg Sullivan and I'm an ethical housing provider in the Arts District.

Like other housing providers, I, of course, would work with tenants whose experiences as a result of the pandemic prevent them from paying rent. In an emergency like this, we all know that we have to make sacrifices for situations that stem from the emergency itself.

However, it makes no sense at all to pause the need to pay rent without some sort of nexis to the pandemic, as the latest supplement to the city's eviction moratorium would do. The newest guidelines are far too broad. They basically give carte blanche to any tenant who can claim any inability to pay for whatever reason -- even apparently reasons that predate the pandemic.

The room for abuse is just too great. And the potential detriment to my operations and the livelihoods of local vendors and service providers that I support is too high.

Throughout the crisis, I will still have the need to meet all kinds of financial obligations, especially the building's mortgage but also taxes and utilities. Additionally, I employ local service providers who now more than ever rely on income from me.

If rent payments are deferred, I will have trouble meeting those obligations, and that will leave me with no choice but to cut back essential services, which will have a ripple effect not just for my tenants but also for these vendors and service providers.

It's one thing if those sacrifices are tje tragic and unavoidable consequences of the pandemic but quite another if they have to be made because the city has unwittingly given a free pass to anyone.

The city needs to take a more balanced approach. Instead of enacting this overly broad ordinance, provide help to affected residents and business alike through the establishment of emergency financial assistance with clearly defined standards.


Apart from that, during this time of heightened anxiety, job loss and financial strain, and when all children are home from school this is just purely a bad idea from a health and safety standard.

The National Shooting Sports Foundation (NSSF) is America's trade association for the firearm, ammunition, hunting and recreational shooting sports industry. Our over 9,000 member companies include federally licensed manufacturers, distributors and retailers of firearms and ammunition products. On behalf of our members nationwide, I am writing to thank you for your leadership and the ongoing efforts of your agency to combat the COVID-19 (Coronavirus) pandemic.

I am respectfully requesting that your city adopt the Resolution Confirming Third Supplement to Public Order Issued on April 1, 2020 by the Director of Emergency Services, Allowing Firearms Retailers to Conduct Business, Including New Sales and Transfers, During the COVID-19 Local Emergency, Consistent With U.S. Department of Homeland Security Cybersecurity & Infrastructure Security Agency (CISA) Advisory Guidance and the Los Angeles County Positions Regarding Firearms Retailers.

The firearm and ammunition industry is proud to provide the U.S. military and federal, state and local law enforcement agencies with the tools they need to carry out their vital national security and public safety missions. While we are facing a different kind of war in combatting an unprecedented public health crisis, it is imperative that we maintain a strong national defense and maintain public order.

As you are aware, the Department of Homeland Security (DHS) oversees the country's National Infrastructure Protection Plan (the "Plan")¹. This Plan outlines how government and private sector participants in the critical infrastructure community work together to manage risks and achieve security and resilience outcomes. The Plan identifies 16 different critical infrastructure sectors, including Defense Industrial Base (DIB)² and Emergency Services Sector (ESS)³. Firearm retailers, manufacturers and ranges have been classified as essential by DHS.

Defense Industrial Base

The United States military acquires virtually all its small arms from domestic commercial firearm manufacturers. All handgun ammunition used by the U.S. military is sourced from commercial ammunition manufacturers. The U.S. military also purchases rifle ammunition directly from domestic commercial ammunition manufacturers. The federal government recognizes the importance of ammunition and firearm manufacturing in times of crisis.

We believe federally licensed firearm and ammunition manufacturers, and their employees, are clearly part of the Defense Industrial Base.

Manufacturers cannot remain operational if they are unable to secure necessary raw material and component parts in order to produce finished products for the military, law enforcement and commercial market. Therefore, it is vital that the supply chain upon which our industry relies, including the ability to transport materials, parts and finished products, must also be designated as critical infrastructure industry.

Emergency Services Sector - Public Safety

According to DHS Cybersecurity and Infrastructure Security Agency (CISA), "The mission of the Emergency Services Sector (ESS) is to save lives, protect property and the environment, assist communities impacted by disasters, and aid recovery during emergencies." Law enforcement is one of the five distinct disciplines composing the ESS sector that encompasses a wide range of emergency response functions and roles.

Members of our industry provide federal, state, local and tribal law enforcement agencies with the firearms and ammunition products they use to protect our communities and keep the peace. While large law enforcement agencies typically obtain the firearms, ammunition and related products directly from the manufacturer, most law enforcement agencies and their officers obtain firearms and ammunition from their local federally licensed firearms retailer. Our industry primarily functions on a traditional two-step distribution system whereby retailers generally acquire firearms from federally licensed wholesale distributors. In addition, many law enforcement officers supplement their income by working at firearm retailers.

We have seen in the past that law enforcement has turned to firearm retailers in times of civil unrest, such as when during the Los Angeles riots in 1992 local law enforcement went to retailers to obtain more effective firearms in order to restore the peace and protect residents and local businesses.

We cannot expect law enforcement to do its job of serving, protecting, and defending our communities without making sure they have access to the tools they need and which our industry provides. Our industry's manufacturers, distributors and retailers are a vital part of the Emergency Services Sector.

Second Amendment - The Right to Keep and Bear Arms

Food, water, shelter and adequate medical care are paramount for survival, but so too is the ability for an individual to defend his or herself, their family, as well as their home, business and property.

The firearm and ammunition industry is essential for law-abiding Americans to exercise their Second Amendment right to acquire a firearm and ammunition for personal protection and home defense. Right now, across America, tens of thousands of our fellow citizens are lining up at their local federally licensed firearm retailer to purchase firearms (after an industry-supported background check) and ammunition to protect themselves and family during this uncertain time. Law enforcement resources will be taxed and stressed thin if this pandemic continues to spread. Americans increasingly understand that they cannot always rely on law enforcement to be there in a time of need. They have a duty to be responsible for their own safety. The Second Amendment protects each law-abiding American's God-given right to self-defense. And, the lawful commerce in firearms and ammunition products is constitutionally protected. Without our industry, the right to keep and bear arms would be a mere illusion.

Unfortunately, as with past major disasters like Hurricanc Katrina, a growing number of jurisdictions are ordering federally licensed firearm retailers to close their stores as "non-essential" businesses. For example, the Santa Clara and Contra Costa counties and the City of San Jose in California have all ordered firearm retailers to close. Just last night, Athens-Clarke County in Georgia passed an ordinance that requires firearm retailers to close as "non-essential" businesses.

The line of customers outside of firearm retailers across America is testament to the fact that Americans believe the ability to exercise their constitutional rights protected by the Second Amendment is essential. Law abiding citizens owning firearms for their own protection assists law enforcement and aids in keeping the peace.

Further, the psychological impact of having firearm retailers and manufacturers shuttered should not be underestimated. Americans are concerned that in this time of crisis, they will not be able to protect themselves, their families or their property. Ordering the shuttering of retailers will only serve to fuel this fear unnecessarily. The firearm and ammunition industry is present in every community. We know first-hand the importance of ensuring that families are able to focus on what's important right now: following government guidance to help stop the spread of this deadly virus. The last thing an American should be worrying about is how to make sure they are physically safe. Even for those who are not purchasing firearms or ammunition right now, allowing these essential businesses to remain open, while abiding by the important social-distancing guidelines, demonstrates that Americans are not going to be deprived of their right to bear arms.

In addition, shooting ranges, both public and private, are also essential to public safety and the exercise of the Second Amendment. Shooting ranges are where firearm safety education is taught especially to new and inexperience gun owners. It is also where law enforcement officers typically train to be proficient with their duty weapon. And, members of the military also frequent shooting ranges to train before they deploy to defend our nation.

Economic Impact

Our industry contributes to our nation's economic well-being. In 2019, the firearm and ammunition industry was responsible for \$60 billion in total economic activity, employing as many as 150,707 people in the U.S. and generating an additional 181,501 jobs in supplier and ancillary industries.

Whether it is providing firearms or ammunition to military, law enforcement, and law-abiding citizens or ensuring that they have access to shooting ranges for training, the firearm industry is a critical component of our nation's security, public safety, and economic well-being. We must remain open for business. By including our industry among our nation's critical infrastructure industries, you can help ensure that we are able to do so.

We appreciate your support for the men and women who proudly wear our nation's uniform, our nation's law enforcement and first responders, as well as protecting our constitutional right to keep and bear arms and supporting the very industry that helps make that right a reality for tens of millions of Americans. Thank you for your consideration of this important request.

Dear Culver City Council,

Martin B. Retting, Inc. (MBR, Inc.) has been conducting business in Culver City since 1953. We are a licensed Firearms retailer. We have always structured our business practices in such a way as to maintain strict compliance with the law and we have always maintained an excellent relationship with the City of Culver City. The safety of our customers, staff and the community is something we take very seriously.

In response to the current COVID-19 crisis, we voluntarily implemented significant steps to mitigate exposure and create a safe environment by limiting our occupancy and volume. Most of these steps were later included in the original Culver City COVID-19 order issued to us on March 20th, 2020. In summary, we have instituted a strict appointment only policy, limited the number of patrons to no more than three (3) at any time, enforced social distancing standards and have taken steps to minimize community spread by sanitizing hard surfaces and issuing a fresh pen to any customer that needs one. There is no doubt that while creating some operational challenges, these procedures have been successful in their goal of creating a safer environment.

The City order stated that we were to remain open for 30-days in order to complete pending transactions. We were told not to accept any new business. With little official guidance on what constituted "critical infrastructure", it's understandable that the City could take the position that it did. However, since the original order, there have been several important developments.

- On March 28th, 2020, the Department of Homeland Security added firearms retailers to the current CISA guidelines of critical infrastructure under the general heading of "Public Safety".
 The new CISA guidelines state that "Workers supporting the operation of firearm or ammunition product manufacturers, retailers, importers, distributors, and shooting ranges." are part of critical infrastructure and thus deemed essential.
- On March 30th, in response to the new CISA guidelines, Los Angeles County Sheriff Alex Villanueva reversed his initial position by allowing Firearms Retailers within the County to remain open "Based on this further input from the federal government, the Los Angeles County Sheriff's Department will not order or recommend closure of businesses that sell or repair firearms or sell ammunition,".

After these developments, MBR, Inc. respectfully requested that the existing City order be modified to allow us to remain open, and accept new transactions. On April 1st, 2020, Culver City Manager John M. Nachbar issued a Third Supplement to the City's Public Order regarding COVID-19, which clarified the position of firearms retailers as part of essential critical infrastructure and specified that they would be allowed to conduct business, including new sales, during the COVID-19 local emergency.

We are grateful that the City has reached this determination and would like to reassure the members of the City Council, as well as City administrators, that we take our responsibility to operate within accepted COVID-19 safety protocols seriously. We are confident that with the precautions that we have implemented, we will continue to operate safely. As always, we welcome any advice that the City may offer on how to safely operate and meet our obligations during this crisis.

In closing, we wish to our reaffirm our commitment to the community. In the interest of addressing concerns regarding new firearm owners and in a general effort to raise awareness and encourage safe firearm handling practices, we are currently collaborating on a public service announcement (PSA) in partnership with world renowned firearms instructor, retired LAPD SWAT Officer and court recognized "use of force" expert Scott Reitz of International Tactical Training Seminars (ITTS). Mr. Reitz will address firearms safety for new gun-owners and we will make this available freely through social media. Mr. Reitz has decades of experience instructing shooters of all levels and his insight will be invaluable to all gun-owners. We expect it to be available by April 3rd. We encourage the City to join our efforts and offer something similar to the community now, and on an ongoing basis, in order to constructively address the issue of firearms safety.



Dear Culver City Council,

I am a proud CC resident and homeowner. I have several points I would like to make:

- 1) I make my living in executive protection, and I hold the required CA Guard Card and Exposed Firearms permit (and have for 20 years now). I fall under the 'Essential Personnel' criteria, allowing me to continue to work, in these trying times. I would ask a very simple question: what sense does it make to prevent a trained professional who is authorized as 'essential', and carries a deadly weapon daily as part of the job, from acquiring the tools needed to do that job, and limit access to the goods needed to maintain proficiency and safety on the job? It would be negligent to deny me access to the requirements of the job, be it parts, holsters, cleaning supplies, or ammunition (for practice or otherwise). You might think 'a professional should have adequate supply, or be prepared'; however, this creates a situation which requires hoarding, and the effects of that are amply clear right now.
- 2) At a time when CA is releasing criminals from jails, and crime has increased over the last few years due to prop's 47 and 57, preventing law-abiding citizens from taking the necessary steps to protect themselves and their families is wrong.
- 3) The 2a is enshrined in the constitution, and hindering it is illegal, as the Supreme Court has made clear. It's also immoral, endangering innocent lives. To lend this a personal note, I was shot at outside my home in Mar Vista in 2014, for no reason, as I entered my car to go to work a night shift. A round hit the car 4in from my head. I've done the training, and used the training drill to evade, shelter, and gain access to my weapon, which was locked in a safe in my trunk as per the law. I ran a short distance home, with my weapon in my hand, and made sure my wife and two daughters were safe until law enforcement arrived. The salient point is that law enforcement arrived.....over 5 minutes after shots were fired, and I had responded and resolved the incident myself. Unless CC law enforcement can guarantee the safety of myself, my family, and every other family in Culver City, unless they can promise me they will be there to prevent a violent incident from the start, you have no right to reduce anyone's ability to defend themselves.







Re: Comments re Discussion of the Classification of Firearms Retailers as Essential Businesses

To Whom it May Concern:

We write on behalf of our clients FFLGuard, Inc. and the California Rifle & Pistol Association, Inc. and their respective members and customers, regarding the City Council's upcoming discussion regarding the classification of firearm businesses as "essential or non-essential businesses during the COVID-19 local emergency in light of the U.S. Department of Homeland Security Cybersecurity && Infrastructure Security Agency (CISA) advisory guidance and the Los Angeles County positions," which is currently scheduled for April 2, 2020, at 8:00 P.M.¹

As an initial matter, the Second Amendment forbids the government from completely shutting down firearm and ammunition sales, even in times of grave public emergency. *See Bateman v. Perdue*, 881 F.Supp.2d 709 (E.D.N.C. 2012) (applying *District of Columbia v. Heller*, 554 U.S. 570 (2008) to hold unconstitutional a statute authorizing government officials to prohibit the sale of firearms during state of emergency); *id.* at 714 (noting that statute "effectively prohibit[s] law abiding citizens from purchasing and transporting to their homes firearms and ammunition needed for self-defense" thus "burden[ing] conduct protected by the Second Amendment").

Members of the Pennsylvania Supreme Court just reiterated that principle specifically in response to its Governor shutting down gun stores.² Pennsylvania's Governor amended his order to allow firearm stores to remain open even before hearing from his Supreme Court, reasoning that gun stores are "essential" because Pennsylvania law, like California, requires firearm purchases to take place in person.³ Also noteworthy is the Executive Order of Governor of Illinois, Executive Order in Response to COVID-19 (COVID-19 Executive Order No. 8), at 12(n), defining "Essential Businesses and Operations" to include "firearm and ammunition suppliers and retailers for purposes of safety and security").⁴

The federal government has also recently expressly stated its position that firearm retailers are "essential businesses." Coupled with the Governor Newsom issuing Executive Order N.33-20. Contained in the Governor's Executive Order is an order from the State Public Health Officer and Director ordering "all individuals living in the State of California to stay home or at their place of residence except as needed to maintain continuity of operations of the federal critical infrastructure sectors." That same Health Department order clarified that Californians working in the "16 critical infrastructure sectors" identified by the federal government "may continue their work because of the importance of these sectors to California's health and well-being."

Initially, some the federal government's descriptions of "essential" workforce operations in the 16 critical infrastructure sectors implicitly included gun stores. But on March 28, 2020, Christopher C. Kreps, Director of the federal Cybersecurity and Infrastructure Security Agency ("CISA"), issued a memorandum clarifying the list of job descriptions that CISA considers part of the nation's "essential Critical Infrastructure Workforce" and "16 critical infrastructure sectors" to expressly include "workers supporting the operation of *firearm or ammunition product manufacturers, retailers, importers, distributors, and shooting ranges.*"

Under federal law CISA's "list is advisory in nature" and "is not, nor should it be considered, a *federal* directive." Nonetheless, under California law it has the effect of a

mandatory directive because, through Executive Order N-33-20 the State Public Health Officer and Director has ordered that Californians working in the "16 critical infrastructure sectors" identified by the federal government be allowed to continue working. In other words, California has incorporated the federal guidelines, including the recent clarifications to those guidelines by CISA that expressly include gun stores as critical infrastructure, into its order by referencing them and mandating that they all be complied with. The operation of firearm retailers and ranges seeking to perform their jobs and duties within one of the 16 federally identified sectors is thereby protected by the Governor's Order.⁸

Any emergency declaration and related local Order mandating the closure of essential firearm-related businesses is also preempted by Government Code section 53071. That section expresses the intent of California's legislature to occupy the whole field of regulations regarding the registration and licensing of commercially manufactured firearms to the exclusion "of all local regulations." *See Fiscal v. City & Cty of San Francisco* (2013) 158 Cal. App. 4th 895, 912 (holding a San Francisco ordinance banning sale of firearms within city limits preempted by both the Penal Code and Section 53071). That does not change because of an emergency declaration. Local government remains limited by state law. *See* 75 Ops.Cal.Atty.Gen. 256, 258 (1992) (broad powers based on a declaration of local emergency cannot be construed literally to encompass "any" orders, regulations, or preventative measures in violation of state law or policy). Tellingly, the California Department of Justice, Bureau of Firearms continues to operate its Dealer Record of Sale Entry System ("DES"), which is dedicated to processing lawful firearm and ammunition transactions, while maintaining essential staff to facilitate background checks in connection with those transactions.

Ordering the closure of firearm-related businesses also raises substantial public safety concerns. Chief among those is the ability of such businesses to communicate with state and federal law enforcement in response to crime gun trace requests. What's more, these businesses provide first responders (police, private security, and even the military) with the equipment necessary to perform their duties effectively and safely. As additional law enforcement, private security, and other first responders are called to broader and extended service these businesses will be critical in supplying necessary equipment.

In addition, licensed firearm dealers and licensed ammunition vendors generally provide the only lawful means of transferring firearms and ammunition between private individuals. If firearm-related businesses are forced to close, people will have no means of conducting lawful transfers which ensure a background check is conducted on the purchaser. Not only is this a violation of their Second Amendment rights, it encourages otherwise law-abiding but currently desperate people to violate the law and conduct off the record firearm transfers. Ordering the closure of firearm-related businesses during this time of emergency, therefore, is not only unlawful but also contrary to public safety.

In other jurisdictions that initially considered forcing the closure of firearms and ammunition retail stores we have been able to provide more information about the many laws

Whenever we called Inglewood Police Department, they said call Lennox Sheriff. Lennox Sheriff said to call Inglewood PD. It felt like we were helpless, trapped in the middle of this political and urban battle. Why not move, you ask? My parents didn't have much money. They spent their extra money to send me to private school so I could have a better life.

My father was an expert marksman in the Army. He grew up on a farm in West Virginia, were firearms are the norm. Dad sat on our porch in Inglewood, cleaning his rifles and pistols, for everyone to see. He taught me gun safety. He taught me not to fear. The people in our neighborhood thought he was insane, but he didn't care. If the two different police entities couldn't help us in a timely manner, at least he could protect his family should the need arise.

So here I am, a 53 year old, single AND disabled woman. Living alone. Do I feel safe with all that's going on? No. I don't. What happens if the food runs out? No toilet paper? With all of the panic purchasing that is going on, who's to say that someone won't want my stock of supplies. Or worse. My money. My car. Me?

Is my Glock essential to me??? YES IT IS. I have had to pull it out when a man entered my back yard. I stayed inside. Should I have waited for the police to arrive? Didn't have to. I showed him my gun. He left. No violence. No crime other than trespassing.

People are scared. There isn't enough emergency response personnel to cover every problem.

Yes, Martin B. Retting and other stores like this one are essential. I urge you to follow Homeland Security and LA County Sheriff in their decision to keep this as an essential business.

Good Morning,

Thank you for reading my concerns and comments regarding the status of firearms retailers.

I'm simply confused at the double standard being imposed on firearm retailers during these times. Within the past week I've visited the following retail store fronts: dedicated paint store, dedicated liquor store (no bread, eggs or milk are sold, simply soft drinks and alcohol) and a car dealership. Due to legal precedent, driving in California is considered a privilege, yet dealerships are permitted to stay open with modified procedures.

To add, my wife and I are remodeling our bathrooms and the boutique storefront that sold us our luxury whirlpool bath tub is still open and operating with appointment only visits to the store front. Indoor plumbing, if legally considered an essential business, can easily be satisfied with warehouse store fronts that cater to professional contractors and plumbers that common citizens can call for repairs during these times. Yet a boutique store front selling luxury end items is not facing the same scrutiny as firearms retailers selling the most common models of firearms owned by millions of Americans and registered permanent residents. And we're talking pump action shotguns and revolvers.

I see the need for public health and safety but I see it as a double standard. Procuring an automobile is non essential, due to the California courts ruling driving as a privilege and the fact that public transit is fully operational across our county. In fact, every DMV drivers handbook opens with the presiding governor reminding us of the legal privilege it is to hold a California drivers license. Now why are firearms retailers are villianized?

I've been a customer of a firearms retailer in Culver city and can attest to their lawful means of conducting business in compliance with California DOJ regulations and ATF federal statutes. Why during this time of high demand does the city council of Culber Coty continue to shut down a retailer engaging in a business deemed a constitutional right, twice by the Supreme Court, and explicitly stated in the Bill of Rights. Firearm ownership is not an implied right that was decided by the Supreme Court, it is identified within the original Bill of Rights. To add, the demand is high. It is irresponsible to continue the closure of firearms retailers due to constitutional and pragmatic reasons.

Constitutionally, I listed the reasons. Pragmatically, people will procure firearms illegally from out of state or criminals, if they cannot procure them from a California DOJ certified and registered Federal Firearms Licensed dealer.
