Pam Freidan, Culver Palms Meals on Wheels: thanked Culver City for the recognition; discussed increased efforts due to the Coronavirus; and she shared a note they received from one of their clients on their anniversary in appreciation of their services.

Closed Session Report

Carol Schwab, City Attorney, reported that the City Council had met in Closed Session regarding Item CS-2 concerning an April 6th letter from Protect Culver City submitted to the City pursuant to Government Code Section 54960.1, demanding that the City Council cure or correct alleged violations of the Brown Act concerning comments made during Community Announcements by Members at the February 24, 2020 City Council meeting regarding the ballot initiative process. The City Council determined that no Brown Act violations had occurred, therefore there is no need to cure or correct the action and directed that a written response be prepared in response to Protect Culver City in accordance with such determination.

Community Announcements by City Council Members/Information Items from Staff

Council Member Lee expressed gratitude to the City Manager and staff for their continued efforts to keep things going and he thanked Vice Mayor Eriksson and Council Mayor Small, The Whole

9 Gallery, and churches around the City for their work to feed those in need.

Vice Mayor Eriksson reported that feedculvercity.org had collected over \$32,000 to support restaurants and feed individuals in the City; Grace Diner at Grace Lutheran Church provides free meals; he indicated that additional donations were needed; and he thanked everyone for their contributions.

Council Member Fisch thanked Kids Group Media for their work noting that interviews were available on youtube.com, and he thanked the community for practicing physical distancing and wearing masks noting that is why California is doing well.

Council Member Small thanked teamculver.org, Backpacks for Kids, The Whole 9 Gallery, and City staff for their work.

Mayor Sahli-Wells expressed gratitude to everyone stepping up to help; she announced that the mayoral rotation would take place at the April 27, 2020 City Council meeting; she discussed adopted City Council policy; expressed support for Vice Mayor Eriksson; discussed the pinning ceremony and celebration; the ability to increase bicycle and pedestrian access as other cities have been doing; staff resources and costs; the timeline for a report back; and she requested pedestrian access at the Washington/National construction site.

Charles Herbertson, Public Works Director, discussed work on Active Transportation Grants and examination of the Washington/National construction site.

Heba El-Guindy, Mobility and Traffic Engineer, discussed changes made to signals; lower traffic volumes; the pedestrian push button; and items included in the memo to the City Manager.

Jeremy Green, City Clerk, reported that the City Clerk's office was accepting applications to fill vacancies on Committees, Boards and Commissions through May 18, available on the City website for consideration of appointment at the regular meeting of June 8, 2020, and she discussed revised policies and eligibility requirements.

Joint Public Comment - Items Not on the Agenda

Mayor Sahli-Wells invited public comment.

Jeremy Green, City Clerk, read public comment submitted by:

Lesley Roberts: thanked Council Members for their service; expressed hope that the closure of all non-essential businesses included gun stores; and discussed panicked gun sales.

David Metzler: discussed the actions of Oakland to shut down residential streets to through traffic; suggested streamlining the existing permit process for street parties with longer closure duration and multiple streets at a time; discussed using volunteers; connecting adjoining streets; use of signage and cones; and he wanted to see each neighborhood in the City have a group of residential streets that were closed.

Dr. Janet Hoult: thanked the City for their efforts; encouraged everyone to keep smiling; discussed the commendation and proclamation presented; and she shared poems about Meals on Wheels and Arbor Day.

Ron Bassilian: expressed concern about the state of small businesses during COVID-19; permanently altering the character of the City; deferring to state and county authorities; the need for clarity for struggling constituents; he requested information on available aid and when businesses would be allowed to reopen; and he encouraged affected businesses to reach out to Protect Culver City at info@protectculvercity.org or by calling (310) 879-1579.

Colin Diaz, Culver City Chamber of Commerce: questioned why there was nothing on the agenda to address the crippling effect of COVID-19 on the business economy, and he expressed concern that many small businesses would not be able to return after COVID-19.

Sean Moran: questioned whether residential construction hours could be reduced noting the number of people now required to work at home.

Karol Mora: proposed a significant reduction of work hours for residential construction and possible cessation of projects that are not truly essential; felt that residents should be taken into consideration; observed that most of the projects were not affordable housing projects; discussed a project adjacent to where she lives; the difficulty of working from home with nonstop noise and dust; and the struggle of teachers in her building to conduct remote classes.

Frank Clark: reported on his experiences with homeless individuals on Globe Avenue; expressed concern with City protection of individuals who put his neighborhood and family in danger; and he requested permanent action to address the problem.

Mayor Sahli-Wells indicated that the City Council would be discussing commercial tenant protections, and she noted that the Vice Mayor and Council Member Small were having weekly calls with businesses and the Chamber of Commerce.

Council Member Small discussed weekly calls in collaboration with the Vice Mayor, the Chamber of Commerce and the Economic Development Department; time and effort spent bringing resources to address issues; appreciation for the collaboration; and he acknowledged the importance of small businesses to Culver City.

Vice Mayor Eriksson discussed the weekly meetings being held and the lack of participation by property owners.

Council Member Fisch questioned whether the contract reflected the probability that revenue would be significantly lower due to current situation.

Todd Tipton, Economic Development Manager, indicated that staff had adjusted revenue projections based on anticipated levels of occupancy and believed that sufficient revenue would be available to address the costs.

Mayor Sahli-Wells received clarification regarding measures being taken to ease parking time limits in response to changes due to the pandemic and other assistance for those in the business community, and she suggested promotion of efforts being taken by the City to respond to the economic impacts of the crisis.

Jeremy Green, City Clerk, read written comment submitted by:

Kelli Estes: wrote regarding Items A-1 and A-4 asking that pet grooming and pet salons be added to the list of essential services.

Tamal Dodge, Yoga Salt, discussed effects of the pandemic on their small business, and questioned when they would be allowed to re-open and what kind of restrictions would be imposed.

Discussion ensued between staff and Council Members regarding options for pet owners; the eviction moratorium; a request for staff to respond via email to the two people who sent in written comments; limits to City authority; the requirement that businesses show financial issues as a result of the COVID-19 pandemic; clarification that the provision provides extra time to pay rent, not a vacation from rent; actions of the Judicial Council of California; the importance of communication; and the actions of neighboring cities.

Kathe Head, Keyser Marston, reported performing the analysis last year; discussed the mixed-use ordinance; the benefit for additional density; City-owned property; density bonuses; benefits to developers; adding affordable housing; ad hoc projects on City-owned properties; market analysis; financial prototypes; combining community benefits and the state density bonus; and affordable housing requirements.

Sol Blumenfeld, Community Development Director, provided an overview of the proposed changes to the mixed-use ordinance.

Mayor Sahli-Wells invited public comment.

Jeremy Green, City Clerk, read written comments submitted by:

Disa Lindgren: urged the City Council to adopt a strong inclusionary ordinance amending the Culver City Zoning Code to require mandatory affordable housing as part of a new market rate housing development; she recommended 50% minimums given the exorbitant cost of housing in Culver City; noted displacement of low and middle income families; the pressing need; lower and middle income families forced to commute long distances; 50% minimums adopted in San Antonio, Texas; the need for bold action; the threshold for workforce rental units; the need to prioritize affordable housing and help the severely

rent-burdened; and she provided an article on the San Antonio approach at: salud-america.org/san-antonios-daring-new-policies-for-affordable-housing.

Yasmine-Imani McMorrin: expressed support for the proposed zoning code amendment; discussed notice she and her neighbors received about the sale of their apartment building; support for an eviction moratorium preventing displacement during the pandemic; the importance of commitment by the City to create affordable housing; loss of long-term renters; housing as a human right; and ensuring that Culver City is accessible to all.

Discussion ensued between staff and Council Members regarding work put into the proposed ordinance; inclusionary housing as a tool to create affordable housing; the need for additional vetting; government operated housing; striking a balance between creating an ordinance to encourage the building of affordable housing and making it impossible to build housing; working with the development community; outreach; next steps; testing levels of affordability; the market study; financial projections taking changes in the economy into account; the feeling that the change in the market is temporary; projects that are still moving forward; advantages to refinancing at this time; the difficulty of financing in the short-term; advantages to developer buy-in; other area cities with inclusionary housing; nexus fees; the experiences of other cities; impact fees; additional density bonuses; choosing very low income units so fewer units are required to be provided; adding incentive for the Transit Oriented District (TOD); mandatory replacement of existing rental units; fear of displacement; concern with exclusively market rate development; micro-units; including residents in the discussion; holding a webinar to discuss the provisions; success of the Transit Oriented Communities (TOC) program; creating value; expanding what is considered appropriate for those zones; the nighttime population in Culver City; concern with double counting; calculations; rethinking base density; concern with time and expense for projects underway; vested rights; timing of in lieu fees; economic integration benefits of inclusionary zoning; broadening the definition of mixed-use; the General Plan Update; examining where density should occur residential districts; commercial corridors; Regional Housing Need Assessment (RHNA) numbers; the definition of ground floor retail; activating the public realm; prioritizing daycare; avoiding the "Condo Canyon" affect by creating pedestrian and bike friendly environments; achieving long-standing goals; acknowledgement that sometimes in lieu fees serve a purpose; only allowing in lieu fees when a developer shows infeasibility

and development of criteria for determinations; ensuring that fees are charged for fractional units; clarification regarding receipt of RHNA credit; RHNA cycles; number of permits issued vs. completion of the process; limiting inclusionary to mixeduse development; the outcome of inclusionary to increased density; focusing density on areas where it makes the most sense; addressing mandatory affordability in the multi-family residential zone; true inclusionary ordinances; state density bonus law; determining levels of affordability; higher density levels permitted in Los Angeles; allowing flexibility; current density levels in Culver City; identifying objectives; support for a mix of levels in every project; length of time for the affordable covenant; displaced renters in affordable units; priority for current renters for units in the new building; the mobile home park; redevelopment loan policies; workforce units as part of the community benefit; addressing the missing middle population; Habitat for Humanity housing; ensuring maximization of public benefit; finalizing concepts; implementation; the selection process; oversight; income compliance; appreciation to staff for their efforts; and staff agreement to formulate outreach ideas and return with next steps.

ability to terminate the contract if it is not financially feasible; concern with having to finance the project out of other funds; the timeline for the project; excess funds; the difficulty of cancelling a project mid-stream; reliability of state agencies funding grants; federal funding of infrastructure projects; concern with jumping into something the City will pay dearly for; confidence about available funding and moving forward with the project; ensuring readiness for stimulus opportunities; seeking a better bid; the lack of an impact on Public Works construction as it is seen as an essential activity; clarification that the project is running out of time; the current request for an extension; other cities that have increased projects due to decreased traffic; concern with losing the grant money if the project is delayed; the potential for increased competition for the contract; and appreciation for the work of Public Works staff on the project which will result in increased safety for students and families.

Peggy Sue Fisher: requested a moratorium on small cells and other wireless infrastructure permits until the COVID-19 emergency is over; expressed concern that wireless providers were using the emergency as cover to expand and cement their rapidly and virtually unsupervised deployment of harmful wireless infrastructure; asserted that time and resources should not have to be used policing whether wireless companies are following local and state law; noted that the FCC allowed for moratoria to be enacted; discussed Homeland security guidelines; stated that new construction is not essential and now is the time to maintain, not expand networks; discussed Homeland Security guidance documents; and the ability of the City to impose a moratorium.

Discussion ensued between staff and Council Members regarding staff resources; the importance of providing essential infrastructure; exemptions; permitting; enhanced need for online communications; and clarification that there has been no observed rush to build infrastructure during this time.

MOVED BY COUNCIL MEMBER LEE, SECONDED BY COUNCIL MEMBER SMALL AND UNANIMOUSLY CARRIED, THAT THE CITY COUNCIL: ADOPT A RESOLUTION CONFIRMING THE APRIL 2, 2020 FOURTH SUPPLEMENT TO PUBLIC ORDER AND THE APRIL 8, 2020 SIXTH SUPPLEMENT TO PUBLIC ORDER ISSUED BY THE CITY MANAGER, AS DIRECTOR OF EMERGENCY SERVICES, UNDER CITY OF CULVER CITY EMERGENCY AUTHORITY, ORDERING ADDITIONAL PRECAUTIONARY MEASURES DURING THE CORONAVIRUS RESPIRATORY DISEASE ("COVID-19") PANDEMIC.

Jeremy Green, City Clerk, read a written comment from:

Amanda Roberts: provided background on herself; discussed the difficulty of trying to work from home with excessive noise; complaints filed with the City regarding construction hours; extreme noise and music from construction workers; and she described a confrontation between herself and workers.

Mayor Sahli-Wells acknowledged multiple complaints received regarding construction noise and the difficulty of working from home.

Discussion ensued between staff and Council Members regarding the process for handling complaints; ensuring that all requirements are being met; use of the Coronavirus hotline to make complaints (310) 253-6890; and whether other jurisdictions have altered construction hours in response to shelter-in-place orders.
