Public Comment - Items Not on the Agenda

Mayor Sahli-Wells invited public comment.

Jeremy Green, City Clerk, read public comments from the following members of the public:

Rich: mentioned seeing Culver City citizens without masks, to which Mayor Sahli-Wells received confirmation from City Manager Nachbar that face coverings are required only to enter a place of business and that the public order requiring face coverings does not apply to walking outside.

April 16, 2020

Mark Lipman: stated that he had not received notifications about meetings; expressed appreciation for the discussion of affordable housing at the April 13, 2020 City Council meeting; discussed developers building in Culver City; clarification that tech workers are not essential workers and can work from home; his desire for all new housing to be 100% affordable; and he requested information about care for unsheltered residents and the state of Vets Memorial emergency center.

Mayor Sahli-Wells affirmed that notifications were being provided for all meetings and requested that staff follow up to determine any issues Mr. Lipman might be having.

Vice Mayor Eriksson provided an update on support for unsheltered residents noting that Grace Lutheran is now serving up to 90 hot meals every weekday for the homeless population and residents who have run out of cash; he noted that Feed Culver City had raised over \$52,000 in eleven days; and he expressed appreciation for the amazing support of the community.

Peter: requested that the effective date for the ordinance banning the sale of flavored tobacco be extended from May 25, 2020 to December 2020 to allow tobacco retailers to sell remaining inventory noting the large decrease in business due to the pandemic.

Vice Mayor Eriksson asked if other Council Members would be interested in extending the deadline of the flavor ban as requested, to which Mayor Sahli-Wells stated that, from a public health perspective, she would not be inclined to extend the deadline and to which no other comments were received.
