A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CULVER CITY, CALIFORNIA, CONFIRMING THE MAY 7, 2020 TENTH SUPPLEMENT TO PUBLIC ORDER (ALLOWING CERTAIN BUSINESSES TO RE-OPEN ON A LIMITED BASIS, FOR CURBSIDE PICK-UP ONLY, AND AUTO DEALERSHIPS TO CONDUCT SHOWROOM SALES, WITH STRICT PHYSICAL DISTANCING AND INFECTION CONTROL PROTOCOLS IN PLACE), AND THE MARCH 14, 2020 ELEVENTH SUPPLEMENT TO PUBLIC ORDER (EXTENDING PREVIOUS PUBLIC ORDERS, AND ALLOWING ADDITIONAL LIMITED RE-OPENINGS), ISSUED BY THE CITY MANAGER, AS DIRECTOR OF EMERGENCY SERVICES, UNDER CITY OF CULVER CITY EMERGENCY AUTHORITY, DUE TO THE CORONAVIRUS RESPIRATORY DISEASE (COVID-19) PANDEMIC.

WHEREAS, since February 2020, the City of Culver City has been part of a coordinated response involving the federal Centers for Disease Control and Prevention, the California Department of Public Health, and the Los Angeles County Department of Public Health as a result of the rapidly evolving multinational outbreak of the coronavirus respiratory disease (COVID-19); and

WHEREAS, pursuant to the authority granted by Culver City Municipal Code (CCMC) Section 3.09.020, on March 14, 2020, the City Manager, as the Director of Emergency Services, issued a Proclamation of Local Emergency due to the outbreak and spread of Coronavirus (COVID-19), which was ratified by the City Council on March 18, 2020 by Resolution No. 2020-R015. Such action followed the Los Angeles County Department of Public Health's and the Chair of the Board of Supervisor's declarations of a local health emergency and the State of California's declaration of a State of Emergency on March 4, 2020, and the President's declaration of a National Emergency on March 13, 2020; and

1 WHEREAS, as of May 14, 2020, Johns Hopkins University reported 4,408,618  
2 confirmed COVID-19 cases globally and 300,798 deaths; 1,405,961 cases nationally, with  
3 85,066 deaths; and 71,141 cases in California, with 2,934 deaths. Further, as of May 14,  
4 2020, the Los Angeles County Department of Public Health reported 34,428 cases in Los  
5 Angeles County with 1,659 deaths, which includes 121 cases and three deaths in Culver City.  
6 As there is a rapid increase in cases and ongoing significant risk of infection throughout the  
7 United States and the State of California, the federal Centers for Disease Control and  
8 Prevention and the California Department of Public Health are recommending that counties  
9 and cities throughout the U.S. continue to actively address the COVID-19 pandemic and  
10 implement aggressive measures to prevent the spread of COVID-19; and  
11

12 WHEREAS, during this unprecedented time, various orders have been issued by  
13 the State of California and the Los Angeles County Department of Public Health, as well as a  
14 number of our neighboring communities, designed to protect both residential and commercial  
15 tenants from eviction during the COVID-19 pandemic; and  
16

17 WHEREAS, on March 16, 2020, under the authority of CCMC Section 3.09.020,  
18 the City Manager issued a Public Order enacting new City measures to protect members of  
19 the public and City workers from undue risk of COVID-19 ("March 16 Order"). The March 16  
20 Order included, among other things, temporary restrictions on certain establishments  
21 throughout Culver City, in which large numbers of people tend to gather and remain in close  
22 proximity. Since the issuance of the March 16 Order, various supplemental orders have been  
23 issued by the State of California and the Los Angeles County Department of Public Health, as  
24 well as a number of our neighboring communities, including the City of Los Angeles; and

1 WHEREAS, on March 20, 2020, the City Manager issued a First Supplement to  
2 Public Order enacting further City measures to protect members of the public and City workers  
3 from undue risk of COVID-19 ("March 20 Order"). The March 20 Order was enacted after the  
4 City of Los Angeles and Los Angeles County Department of Public Health issued a similar  
5 public order. The March 20 Order issued, and incorporated by reference, any and all orders  
6 set forth in *Public Order Under City of Los Angeles Emergency Authority, Subject: SAFER AT*  
7 *HOME*, issued by Los Angeles Mayor Eric Garcetti on March 19, 2020; and

9 WHEREAS, since the March 19 *SAFER AT HOME* Order, Los Angeles Mayor  
10 Garcetti issued revised *SAFER AT HOME* Orders on April 1, April 10, and April 27, 2020. In  
11 step with the City of Los Angeles, on April 7, 2020, April 11, 2020, and May 1, 2020  
12 respectively, the City Manager issued a Fifth Supplement to Public Order (incorporating the  
13 April 1 *SAFER AT HOME* Order), a Seventh Supplement to Public Order (incorporating the  
14 April 10 *SAFER AT HOME* Order), and a Ninth Supplement to Public Order (incorporating the  
15 April 27 *SAFER AT HOME* Order); and

18 WHEREAS, on May 6, 2020, the County of Los Angeles announced its  
19 Roadmap to Recover—a Phased Approach to Reopening Safely, which included allowing  
20 certain non-essential businesses to open on a limited conditional basis May 8, 2020 for  
21 curbside pick-up only, with physical distancing and infection control protocols. In addition,  
22 auto dealership showrooms were permitted to open in Los Angeles County, while adhering to  
23 physical distancing and infection control protocols; and

24  
25 WHEREAS, consistent with the County of Los Angeles directives on the  
26 permitted limited re-openings, on May 7, 2020, the City Manager issued a Tenth Supplement  
27

1 to Public Order (May 7 Order), effective May 8, 2020, permitting florists, toy stores,  
2 bookstores, clothing stores, music stores and sporting goods stores to open for curbside pick-  
3 up only, with strict adherence to physical distancing and infection control protocols at all  
4 times, including but not limited to the use of face coverings for employees and customers, and  
5 additionally permitting auto dealership showrooms to open for sales, with strict adherence to  
6 physical distancing and infection control protocols at all times, including but not limited to the  
7 use of face coverings for employees and customers; and

9 *Eleventh Supplement to Public Order*

10 WHEREAS, On May 13, 2020, the County of Los Angeles' Health Officer issued  
11 a new *Safer at Home Order for Control of COVID-19*, which extended all previous County  
12 Health Officer orders issued, and announced that, in addition to the business already  
13 permitted to operate in some fashion, certain low-risk businesses and select recreational  
14 facilities and beaches are now permitted to reopen subject to certain restrictions. Before  
15 eligible businesses are permitted to reopen, they are required to prepare, implement and post  
16 their plan for adhering to County directives, including distancing and infection control  
17 practices that protect both employees and customers. The County's March 13 order further  
18 requires all persons to practice physical distancing of at least six feet apart and wear a clean  
19 cloth face covering that securely covers both nose and mouth when around people outside of  
20 their household. Public and private gatherings of any number of people occurring outside of a  
21 single household or living unit continue to be prohibited; and  
22

24 WHEREAS, On May 14, 2020, the City Manager issued an Eleventh Supplement  
25 to Public Order (May 14 Order), extending all previous Orders, except where noted, permitting  
26  
27  
28



1 certain additional limited re-openings, and additionally extending certain fee waivers, parking  
2 restrictions and signage restrictions.

3 NOW, THEREFORE, the City Council of the City of Culver City, California,  
4 DOES HEREBY RESOLVE as follows:

5 1. Pursuant to CCMC Section 3.09.020.B.1.h(2), the City Council hereby  
6 confirms the Tenth Supplement to Public Order issued by the Director of Emergency Services  
7 on May 7, 2020, attached hereto as Exhibit A and incorporated herein as though fully set  
8 forth.  
9

10 2. Pursuant to CCMC Section 3.09.020.B.1.h(2), the City Council hereby  
11 confirms the Eleventh Supplement to Public Order issued by the Director of Emergency  
12 Services on May 14, 2020, attached hereto as Exhibit B and incorporated herein as though  
13 fully set forth.  
14

15 3. The City Council finds that this Resolution is not subject to the California  
16 Environmental Quality Act ("CEQA") pursuant to CEQA guidelines, California Code of  
17 Regulations, Title 14, Chapter 3, §15060(c)(2) [the activity will not result in a direct or  
18 reasonably foreseeable indirect physical change in the environment] and §15060(c)(3) [the  
19 activity is not a project as defined in §15378] because it has no potential for resulting in  
20 physical change to the environment, directly or indirectly.

### **Tenth Supplement to Public Order Under City of Culver City Emergency Authority**

**Issue Date: May 7, 2020**

**Subject: COVID-19 Roadmap to Recovery Order: Effective May 8, 2020**

On March 14, 2020, I issued a Proclamation of Local Emergency, as a result of a positive coronavirus respiratory disease (COVID-19) case in our City as well as a rapid increase in cases throughout Los Angeles County. Since that time, I have ordered a number of additional measures to be taken across the City to protect the public and City workers from an undue risk of contracting COVID-19, and to further slow its spread.

On March 16, 2020, under the authority of Culver City Municipal Code (CCMC) Section 3.09.020.B.1.h(2), I, as the Director of Emergency Services, issued a Public Order enacting City measures to protect members of the public and City workers from undue risk of COVID-19 ("March 16 Order"). The March 16 Order included, among other things, temporary restrictions on certain establishments throughout Culver City, in which large numbers of people tend to gather and remain in close proximity.

Since the issuance of the March 16 Order, various supplemental orders have been issued by the State of California and the Los Angeles County Department of Public Health, as well as a number of our neighboring communities, including the City of Los Angeles.

On March 20, 2020, I issued a First Supplement to Public Order enacting further City measures to protect members of the public and City workers from undue risk of COVID-19 ("March 20 Order"). The March 20 Order issued, and incorporated by reference, any and all orders set forth in *Public Order Under City of Los Angeles Emergency Authority, Subject: SAFER AT HOME*, issued by Los Angeles Mayor Eric Garcetti on March 19, 2020 ("March 19 SAFER AT HOME Order").

Since the March 19 SAFER AT HOME Order, Los Angeles Mayor Garcetti issued revised SAFER AT HOME Orders on April 1 and April 10, 2020. In step with the City of Los Angeles, on April 7, 2020 and April 11, 2020, respectively, I issued a Fifth Supplement to Public Order (incorporating the April 1 SAFER AT HOME Order) and a Seventh Supplement to Public Order (incorporating the April 10 SAFER AT HOME Order).

On May 1, 2020 I issued a Ninth Supplement to Public Order, incorporating the April 27, 2020 City of Los Angeles revised SAFER AT HOME Order, effective through May 15, 2020, which primarily addresses clarifications regarding funeral attendance and real estate showings, and advised that non-essential businesses doing the basic minimum

tasks to maintain operations must have their doors closed and locked and signage stating they are not open.

On May 6, 2020, the County of Los Angeles announced its Roadmap to Recover—a Phased Approach to Reopening Safely, which includes allowing certain non-essential businesses to open on May 8, 2020 for curbside pick-up only; these businesses must adhere to physical distancing and infection control protocols. In addition, auto dealership showrooms will be permitted to open in Los Angeles County, while adhering to physical distancing and infection control protocols.

Consistent with the County of Los Angeles directives on the permitted limited re-openings, and by virtue of authority vested in me under the CCMC as the Director of Emergency Services, I hereby order:

1. Effective May 8, 2020, all florists, toy stores, bookstores, clothing stores, music stores and sporting goods stores may open for curbside pick-up only, with strict adherence to physical distancing and infection control protocols at all times, including but not limited to the use of face coverings for employees and customers.
2. Effective May 8, 2020 auto dealership showrooms may open for sales with strict adherence to physical distancing and infection control protocols at all times, including but not limited to the use of face coverings for employees and customers.
3. Attached hereto as Exhibit “A” are Culver City’s Guidelines for Curbside Pick-up and Auto Dealership Showrooms (“Guidelines”). To the extent these Guidelines conflict with any provision of the CCMC, such provision will not be enforced during the pendency of the Local Emergency, or as long as the Guidelines are in place, whichever is later. These Guidelines may be modified administratively without the issuance of a new Public Order.
4. Except as otherwise provided herein, in allowing a limited number of businesses to open with appropriate safeguards in place, this Tenth Supplement to Public Order is in addition to, and does not supersede nor replace, any previously issued orders, which shall remain in full force and effect.
5. Additional social distancing, infection control, and health and safety measures may be imposed at any time, in my sole discretion, in order to ensure the protection of the public’s health and safety, and the intent of each and every Public Order is carried out.

Any violation of this supplemental order may be enforced under the CCMC, which provides for fines not to exceed \$1,000 or imprisonment not to exceed six months. Each individual officer should use their discretion in enforcing this order and always keep the intent of the order in mind.

## EXHIBIT A

### Effective May 8, 2020: City of Culver City Guidelines for Curbside Pickup and Auto Dealerships

#### **Curbside Pick-up in the Public Right of Way (e.g. street or alley)**

On-street pick-up may be permitted with the following guidelines:

- Avoid direct hand-off of merchandise, when possible;
- Schedule pick-ups, if feasible, and create protocols to alert staff to a customer's arrival (such as by text, call, or email);
- Require customers to remain in their cars and not congregate on the sidewalk;
- Display a door or sideway (A-frame) sign immediately in front of business frontage and/or parking spaces with the services available (e.g., takeout, curbside pick-up), instructions for pick-up, and hours of operation. Signs must not obstruct pedestrians' passing;
- Require employees to wear cloth face coverings over their nose and mouth to prevent the spread of COVID-19. Customers are also required to wear cloth face coverings when vehicle windows or doors are open.
- Businesses must follow all industry specific health and safety guidelines from the Los Angeles County Department of Public Health posted at <http://publichealth.lacounty.gov/media/coronavirus>.

#### **Curbside Pick-up from Interior Parking Lots (e.g. shopping center or private parking lot)**

Parking stalls on private property abutting commercial frontages may be used with the owner's permission for pick-up services with the following guidelines:

- Pick-up parking stalls/locations may not impede driveways, parking aisles, alleys, or streets;
- Drive-through pick-up may be permitted if does not impede driveways, parking aisles, alleys, streets, fire lanes, and does not create queuing into vehicular cross traffic or other business establishment frontages;
- Schedule pick-ups, if feasible, and create protocols to alert staff to a customer's arrival (such as by text, call, email);
- Dedicated pick-up parking stalls shall be located closest in proximity (as reasonably possible) to the structure's/business's entrance and may not include stalls in front of another business's frontage;
- Dedicated pick-up parking stalls (permanent or temporary) shall be signed/labeled as "curbside pick-up stalls";
- Display a door or sideway (A-frame) sign immediately in front of the business's frontage with the services available (e.g., takeout, curbside pick-up), instructions for pick-up, and hours of operation. Signs must not obstruct pedestrians' passing;
- Require employees to wear cloth face coverings over their nose and mouth to prevent the spread of COVID-19. Customers are also required to wear cloth face coverings when vehicle windows or doors are open;

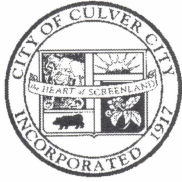
- Avoid direct hand-off of merchandise when possible.
- Follow all industry specific health and safety guidelines from the Los Angeles County Department of Public Health posted at <http://publichealth.lacounty.gov/media/coronavirus>.

### **Auto Dealerships—Showroom Sales**

Auto Dealerships may conduct sales in the showroom and shall adhere to the following:

- Train workers in proper hygiene practices and the use of workplace disease controls;
- Require workers to wear cloth face coverings over their nose and mouth to prevent spread of COVID-19. Customers are also required to wear cloth face coverings when in the showroom or when interacting with dealership employees;
- Provide a place for employees and customers to wash hands with soap and water or alcohol-based hand sanitizer containing at least 60% alcohol;
- Routinely clean and disinfect surfaces and equipment with Environmental Protection Agency approved cleaning chemicals from List N or that have label claims against the coronavirus;
- Practice sensible physical distancing by maintaining at least six-feet between employees, between customers, and between employees and customers;
- Temporarily move workstations to provide at least six-feet in-between workstations;
- Install plexiglass partitions at workstations, if feasible.
- Follow all industry specific health and safety guidelines from the Los Angeles County Department of Public Health posted at <http://publichealth.lacounty.gov/media/coronavirus>.

### Eleventh Supplement to Public Order Under City of Culver City Emergency Authority

Issue Date: May 14, 2020

**Subject: City Measures to Address COVID-19: Extension of Public Orders;  
Additional Limited Conditional Re-openings**

On March 14, 2020, I issued a Proclamation of Local Emergency, as a result of a positive coronavirus respiratory disease (COVID-19) case in our City as well as a rapidly growing number of cases throughout Los Angeles County. Since that time, I have ordered a number of precautionary measures to be taken across the City to protect the public and City workers from an undue risk of contracting COVID-19. Our precautions over these past several weeks and what we continue to do in the coming weeks will affect how well we weather this emergency.

On March 16, 2020, under the authority of Culver City Municipal Code (CCMC) Section 3.09.020, I, as the Director of Emergency Services, issued a Public Order enacting new City measures to protect members of the public and City workers from undue risk of COVID-19 (March 16 Order). The March 16 Order included, among other things, temporary restrictions on certain establishments throughout Culver City, in which large numbers of people tend to gather and remain in close proximity, and a moratorium on evictions of residential tenants ("Residential Tenant Eviction Moratorium").

Since the issuance of the March 16 Order, the number of COVID-19 cases have increased exponentially throughout the City, Los Angeles County, the State, the Nation and the world; and various supplemental orders have been issued by the State of California and the Los Angeles County Department of Public Health, as well as a number of our neighboring communities, including our largest surrounding neighbor, the City of Los Angeles. In step with these agencies, I issued the following supplements to the March 16 Order:

- March 20, 2020 First Supplement to Public Order (March 20 Order): Incorporated by reference, any and all orders set forth in *Public Order Under City of Los Angeles Emergency Authority, Subject: SAFER AT HOME*, issued by Los Angeles Mayor Eric Garcetti on March 19, 2020; established a moratorium on evictions of commercial tenants who have an inability to pay their rent due to circumstances related to COVID-19 ("Commercial Tenant Eviction Moratorium"); relaxed signage and parking restrictions and parking meter fees to facilitate food delivery and pickup; waived outdoor dining and valet parking license fees; and extended the business tax due date to June 1, 2020. Apart from the June 1, 2020 business tax



payment extension, the March 20 Order was effective through April 19, 2020, and subsequently extended to May 15, 2020 by the Seventh Supplement to Public Order.

- March 27 Second Supplement to Public Order (March 27 Order): Expanded the scope of the Residential Tenant Eviction Moratorium to prohibit all evictions during the moratorium period, subject to certain limited exceptions (mostly related to public health and safety) and extended the duration of the Residential Tenant Eviction Moratorium through May 31, 2020.
- April 1, 2020 Third Supplement to Public Order (April 1 Order): Consistent with the U.S. Department of Homeland Security Cybersecurity & Infrastructure Security Agency (CISA) and the County of Los Angeles' positions regarding the inclusion of firearms retailers as part of the essential critical infrastructure, the April 1 Order clarified the March 20 Order to allow firearms retailers in Culver City to conduct business during the COVID-19 local emergency (April 1 Order). The April 1 Order was effective through April 19, 2020, and subsequently extended to May 15, 2020 by the Seventh Supplement to Public Order.
- April 2, 2020 Fourth Supplement to Public Order (April 2 Order): Incorporated by reference all orders set forth in *Public Order Under City of Los Angeles Emergency Authority, Subject: SAFER AT HOME*, as revised and issued by Los Angeles Mayor Eric Garcetti on April 1, 2020, excepting those provisions of the City of Los Angeles *SAFER AT HOME* order that are specific to City of Los Angeles locations and services, and was effective through April 19, 2020, and subsequently extended to May 15, 2020 by the Seventh Supplement to Public Order.
- April 7, 2020 Fifth Supplement to Public Order (April 7 Order): Extended the Commercial Tenant Eviction Moratorium through May 31, 2020.
- April 8, 2020 Sixth Supplement to Public Order (April 8 Order): Incorporated by reference all orders set forth in *Public Order Under City of Los Angeles Emergency Authority, Subject: Worker Protection Order*, issued by Los Angeles Mayor Eric Garcetti on April 7, 2020, and was effective through April 19, 2020, and subsequently extended to May 15, 2020 by the Seventh Supplement to Public Order.
- April 11, 2020 Seventh Supplement to Public Order (April 11 Order): Incorporated by reference all orders set forth in (a) *Public Order Under City of Los Angeles Emergency Authority, Subject SAFER AT HOME*, as revised and issued by Los Angeles Mayor Eric Garcetti on April 10, 2020; and (b) *Public Order Under City of Los Angeles Emergency Authority, Subject: Worker Protection Order*, as revised and issued by Los Angeles Mayor Eric Garcetti on April 10, 2020, effective through May 15, 2020.

- April 28, 2020 Eighth Supplement to Public Order (April 28 Order): Extended the Eviction Moratoria Payment Period for unpaid back rent to 12 Months.
- May 1, 2020 Ninth Supplement to Public Order (May 1 Order): Incorporated by reference all orders set forth in the *Public Order Under City of Los Angeles Emergency Authority, Subject: SAFER AT HOME*, as revised and issued by Los Angeles Mayor Eric Garcetti on April 27, 2020 and effective through May 15, 2020.
- May 7, 2020 Tenth Supplement to Public Order (May 7 Order): Consistent with the County of Los Angeles May 6, 2020 directives on limited conditional re-openings of certain businesses, effective May 8, 2020, florists, toy stores, clothing stores, music stores, and sporting goods stores were permitted to open for curbside pick-up, and auto dealer showrooms were permitted to open, with strict physical distancing and infection control protocols in place.

On May 13, 2020, the County of Los Angeles' Health Officer issued a new *Safer at Home Order for Control of COVID-19*, which extended all previous County Health Officer orders issued, and announced that, in addition to the business already permitted to operate in some fashion, certain low-risk businesses and select recreational facilities and beaches are now permitted to reopen subject to certain restrictions. Before eligible businesses are permitted to reopen, they are required to prepare, implement and post their plan for adhering to County directives, including distancing and infection control practices that protect both employees and customers. The County's March 13 order further requires all persons to practice physical distancing of at least six feet apart and wear a clean cloth face covering that securely covers both nose and mouth when around people outside of their household. Public and private gatherings of any number of people occurring outside of a single household or living unit continue to be prohibited.

It remains clear that these significant efforts taken throughout the region over the past several weeks for maintaining hand hygiene, respiratory etiquette, and physical distancing must continue in order to further slow the spread of COVID-19 and protect the public health and safety.

By virtue of authority vested in me as the Director of Emergency Services, pursuant to the provisions of CCMC Section 3.09.020.B.1.h(2), to make and issue rules and regulations on matters reasonably related to the protection of persons, property and the environment as affected by such emergency, I hereby declare the following orders to be necessary for the protection of life and property and I hereby order:

1. Each of the following public orders, except as expressly provided herein, shall be extended until superseded or rescinded: March 16 Order, March 20 Order, April 1 Order, April 2 Order, April 8 Order, April 11 Order, and May 1 Order.

2. The Residential Tenant Eviction Moratorium, as set forth in the March 27 Order, shall remain in effect through May 31, 2020, unless extended by separate public order.
3. The Commercial Tenant Eviction Moratorium, as set forth in the March 20 Order and April 7 Order, shall remain in effect through May 31, 2020, unless extended by separate order.
4. Effective as of the issuance of this May 14 Order, all lower risk retail businesses, as defined by Los Angeles County in its May 13, 2020 Order, are permitted to open for curbside pick-up or walk-up service only, including those that are located in a mall or shopping center with an exterior entrance. No customers may enter the retail business. Those businesses with access only from the interior (inside) of a mall or shopping center must remain closed. Before a retail business may open, they are required to adhere to all City Guidelines, and prepare, implement and post their compliance with all County directives and reopening protocols, including physical distancing and infection control practices to protect employees and customers.
5. Effective as of the issuance of this May 14 Order, manufacturers and logistic (warehouse) businesses that supply the lower risk retail businesses listed in Section 4 above may open. Before a manufacturer or logistic business may open, they are required to adhere to all City Guidelines, and prepare, implement and post their compliance with all County directives and reopening protocols, including physical distancing and infection control practices to protect employees and customers.
6. Beginning at 7:00 a.m. on May 15, 2020, tennis courts, paddle tennis courts, and hand ball courts may open, with strict compliance with all County directives. The community garden may remain open, with strict compliance with all County protocols.
7. Individuals leaving their residences for the limited purposes allowed by the Orders listed herein and by this Order, must strictly comply with all Social (Physical) Distancing requirements, including those specified in guidance or protocols established by the County of Los Angeles Dept of Public Health; this includes wearing a cloth face covering whenever there is contact or can be contact with others who are non-household members in both public and private places. Young children age 2 and under, and people with certain disabilities, are not required to wear a face covering, per the County of Los Angeles.
8. As set forth in the March 20 Order and April 11 Order, outdoor dining license fees and valet parking license fees will continue to be waived, through June 30, 2020.
9. As set forth in the March 20 Order and April 11 Order, in order to allow businesses to communicate they are open for curbside pick-up and/or delivery of food,

applicable CCMC restrictions related to outdoor business signage (including “sandwich board” signs and temporary banners) are hereby suspended for the duration of this Eleventh Supplement to Public Order and any extension thereto; provided, all signs must be placed in such a manner to allow for pedestrian access along the public right-of-way.

10. In order to facilitate retail curbside pick-up, food delivery and food pickup, the following shall apply for the duration of this Eleventh Supplement to Public Order and any extension thereto:
  - A. Temporary parking shall be permitted in loading zones and special rideshare pickup zones solely for this purpose.
  - B. Parking fees for all meters and pay machines for on-street parking spaces shall be waived for the first 15 minutes.
11. The June 1, 2020 extension for the payment of Culver City business taxes, as set forth in the March 20 Order and April 11 Order, shall remain in effect.
12. Except as specifically modified or amended by the Tenth Supplement to Public Order and this Eleventh Supplement to Public Order, which allow for a limited number of businesses to reopen with appropriate safeguards in place, this Eleventh Supplement to Public Order is in addition to, and does not supersede nor replace, any previously issued orders, which shall remain in full force and effect. All Stay at Home orders remain in place. Public and private gatherings of any number of people occurring outside of a single household or living unit continue to be prohibited.
13. Additional social distancing, infection control, and health and safety measures and guidelines may be imposed at any time, in my sole discretion, in order to ensure the protection of the public’s health and safety, and the intent of each and every Public Order is carried out.

Any violation of this Eleventh Supplement to Public Order may be enforced under the CCMC, which provides for fines not to exceed \$1,000 or imprisonment not to exceed six months. Each individual officer should use their discretion in enforcing this order and always keep the intent of the order in mind.

This Eleventh Supplement to Public Order shall be effective immediately and shall remain in effect until superseded, amended, modified or rescinded.
