Beau Basse, LeBasse Projects, discussed concerns previously voiced by the subcommittee about the structural design for the canopy and about the mural design on the Inglewood Blvd. façade of the building; design changes to address concerns; and budget adjustments.

Discussion ensued between Beau Basse, Adam Perry, staff and Vice Chair Pali regarding foundation for the canopy; the property line; the image of the woman's face; the canopy roof; materials used; the structural poles; approval of the concept vs. approval of the installation; ensuring that what is presented is what is constructed; production of a model; the need for material samples, finalized colors, and a model before presentation to the Commission; the permits referenced for the project; the Temporary Certificate of Occupancy (TCO); items necessary for the Commission presentation; timing; providing a statement to the Commission; and agreement to reconvene on November 18, 2019 with samples.

Marla Koosed received clarification regarding the proposed location of the canopy.

Further discussion ensued between project representatives, staff and Vice Chair Pali regarding requirements from the City of Los Angeles; a request that page numbers be added on the documents; scheduling; the mural; the artist's commission; design fees; mural costs; a request for additional specificity in the costs; clarification that the canopy will be painted; documenting the process with videos and photographs; 3-D printers vs. laser cutting; and coordination and communication with the Planning Division.

# 1) Consideration of Revisions to Concept for Permanent Artwork by Jason Woodside for One Culver at 10000 Washington Boulevard

Discussion ensued between Mr. Basse, staff and Vice Chair Pali regarding structural/seismic issues with using the larger panels; materials; clarification that art will be painted on the metal panels currently in place at One Culver; the panel seams; the finish on the panels; concerns with longevity of the paint finish; tests; bonding with different coatings; and timing.
