Receive an Update on the Culver City Economic Recovery Task Force

Chair Lachman introduced the item.

Member Jones reported on the recent meeting of the Economic Recovery Task Force; discussed the focus on the most vulnerable; he indicated that he serves on the Health and Fitness Group; and he announced an upcoming meeting.

Discussion ensued between staff and Committee Members regarding recent closures; efforts of salons to use outside areas in order to continue operations;

street closures; outdoor dining; parklets; involvement of restaurant owners in the process to have outdoor space; the Downtown Business Association (DBA); the Business Improvement District (BID); Temporary Use Permits (TUPs); and ensuring everyone gets as much space as possible.

Item A-4

Receive and Discuss the Interim Financial Report Through May 31, 2020

Onyx Jones, Chief Finance Officer, provided an overview of the Interim Financial Report through May 31, 2020; discussed a commitment made to the City Council to provide regular updates; the dynamic nature of the current economy; the difficulty of forecasting; fund balance to help the transition; and the potential need to make additional cuts.

Discussion ensued between staff and Committee Members regarding revenue estimates; falling short of the City budget; sales tax; the long-term forecast; longterm sustainability; the need to generate additional revenue or make additional cuts; the potential for a real estate transfer tax; outreach; the time frame for moving forward to place a tax on the ballot; proposed reductions; length of time for the economy to rebound; examining a broad set of options to generate income; revisions to business license fees; the process to get a tax on the ballot; timing; holding a special election; decreased Utility Users Tax (UUT) year over year; shifting of costs from business users to residential users; debate to find out whether rebates should be included with UUT calculations; savings realized by the Police Department by not filling vacant positions; participation by the FAC in consideration of the Police Department budget; property taxes; Prop 13; the need to place a measure on the ballot in order to receive more property taxes; legislative action required in order to change the percentage of allocation; creating a specific property tax to fund a specific item; pass through monies that go to the county; CalPERS; reserves; the self-insurance fund; large increases to premiums and deductibles for the same level of service; concerns with liability claims; the difficulty of obtaining competitive bids since Culver City has their own Police and Fire Departments; aid; grant funds; the CARES Act; FEMA monies; the proposed transfer tax; and information gathered from other agencies.

(1) Discuss Finance Advisory Committee Bylaws; (and, if necessary) (2) Recommend Proposed Amendments for Transmittal to City Council

Erica McAdoo, Procurement & Financial Services Manager, provided a summary of record noting that staff had not provided recommendations.

Discussion ensued between staff and Committee Members regarding clarification that the bylaws had been adjusted in 2019; length of time for the discussion of the bylaws; creation of a subcommittee; FAC recommendations to the City Council; concern with having an all-male Committee and a suggestion that the bylaws provide for one-third of the Committee to be female; triggering a conversation across the community; ensuring diverse representation; current workplan items; adding elements to the workplan including reviewing bylaws from a diversity and equity standpoint, highlighting City efforts to improve government efficiency, and language to include other financial challenges affecting the City including but not limited to the COVID-19 crisis; the narrow mandate currently in place; adding flexibility; positive interactions with the City Council; acting as a resource for the City Council; practices of other cities; revenue challenges during the COVID crisis; and next steps in the process.
